INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
SI Engineering, P.C. 401(k) and Profit-Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of SI Engineering, P.C. 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of Plan:

The following description of the SI Engineering, P.C. (the “Company” or the “Plan Sponsor”) 401(k) and Profit-Sharing Plan, (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees of the Company are eligible other than union employees governed by a collective bargaining agreement, leased employees, and nonresident aliens with no U.S. sourced income. Employees are eligible to participate in elective deferral and discretionary employer matching contributions on the first day of the month after attaining age 21 and completing 3 months of service.

Employees are eligible to participate in the discretionary Profit-Sharing portion of the Plan on the first day of the Plan Year or the first day of the seventh month of the Plan Year after attaining age 21 and completing one year of service. To receive the discretionary profit-sharing contribution, the participant must be employed by the Company on the last day of the Plan year.

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by John Hancock Life Insurance Company (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

Contributions - Each year, eligible participants may elect to contribute a dollar amount or percentage of their annual compensation on a pretax or after-tax basis, subject to the maximum amount allowable as set forth in the Internal Revenue Code (“IRC”). For 2024, the maximum allowable contribution was \$23,000 plus a catch-up contribution of \$7,500 for participants aged 50 and older. Participants may also rollover amounts representing pre-tax distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions, the Company’s discretionary match and the Company’s discretionary profit-sharing contribution into various investment options offered by the Plan. The Plan complies with ERISA Section 404(c) regarding limitation of liability for a participant’s individual election of funds.

Employer Contributions - The Company may make discretionary matching contributions to the Plan in which all eligible employees will receive a portion of the Company’s contribution, of which the percentage is determined by the Company each year. The Company’s discretionary matching contribution was 100% and was limited to 5% of the participants’ eligible compensation effective January 1, 2023. The Company may also make discretionary profit-sharing contributions to the Plan which are allocated to participant accounts based upon participants’ eligible compensation as compared to all participants’ eligible compensation. Employees must be employed on the last day of the Plan year to receive the discretionary profit-sharing contribution. For the year ended December 31, 2024, the discretionary matching contributions and discretionary profit-sharing contributions totaled \$379,465 and \$250,000, respectively.

Participant Accounts - Individual accounts are established for each plan participant. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s employer discretionary matching and discretionary profit-sharing contributions, (b) Plan earnings/losses, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS

Vesting - Participant contributions plus actual earnings thereon are vested immediately. A participant is credited with a year of service for each Plan year during which the participant is credited with at least 1,000 hours of service. A participant will vest in the employer discretionary matching and discretionary profit-sharing contributions at a rate in accordance with the following schedule:

Years of Service	Percentage of Company Contribution Vested
Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six years	100%

Payment of Benefits - Upon termination of employment with the Company, or upon death, disability, or retirement, a participant or its beneficiary may elect to receive either lump sum, installment, or rollover contributions. The Plan also allows for in-service distributions for those participants who have attained age 59½. If the value of a participant's vested account does not exceed \$5,000, the participant's entire vested account shall be distributed as of the earliest of his retirement, death or severance of employment.

Forfeitures - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce the Company's discretionary contributions to the Plan. Forfeited non-vested accounts totaled \$35,211 and \$102,816 for years ended December 31, 2024 and 2023, respectively. There were \$124,213 of forfeitures utilized to reduce Company contributions for the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Cash and Equivalents - Cash and equivalents include money market and all other highly liquid short-term investments purchased with maturities of three months or less.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES TO FINANCIAL STATEMENTS

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions, loans, recordkeeping and asset fees are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan Administrator has reviewed and evaluated all subsequent events and transactions from December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- c) Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

NOTES TO FINANCIAL STATEMENTS

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts*: Valued at their accumulated unit value ("AUV"). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. See Note 5.
- *Cash and equivalents*: Valued at the closing price in similar markets in which it's traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 - Pooled Separate Accounts with Insurance Company:

The Plan has entered into pooled separate accounts with the Trustee. The Trustee maintains the contributions in a pooled account. The pooled account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses assessed by the Trustee. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the Trustee. There are no unfunded commitments at December 31, 2024 and 2023.

Note 6 - Risks and Uncertainties and Concentration of Investment Risk:

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

NOTES TO FINANCIAL STATEMENTS

The Plan may have investments in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investments in three funds comprises approximately 37% of total investments at December 31, 2024. The Plan's investments in two funds comprised approximately 28% of total investments at December 31, 2023.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their own contributions and Company contributions, if any, become fully vested as of the Plan termination date. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 8 - Notes Receivable from Participants:

Participants may obtain loans from the Plan at a minimum of \$1,000 and maximum of 50% of the participant's vested account balance, or \$50,000 whichever is less. Loans bear interest at the prime rate plus 1% and are collateralized by the participant's account balance. Loans are generally payable through payroll deductions within a five-year period, however, if the loans are used to fund the purchase of a principal residence of the participant, the repayment period shall be a reasonable period which may exceed five years. A maximum of two loans can be outstanding at any time. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Note 9 - Tax Status:

The Plan was written on an Internal Revenue Service (IRS) non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 10 - Parties-In-Interest Transactions:

Certain Plan investments are managed by the Trustee. Services provided by the Trustee include investment management, recordkeeping, and administrative services to the Plan. The fees associated with these services qualify as party-in-interest. Fees paid for such services totaled \$49,106 for the year ended December 31, 2024.
