## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GO Wireline LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 PLAN DESCRIPTION**

The following description of the GO Wireline LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of the Company, GO Wireline, LLC, who have reached eighteen years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by management personnel appointed by the Company. Fidelity Management Trust Company serves as the trustee of the plan, maintains the records of the participant data, and holds the Plan assets.

**Contributions**

Participants may have a percentage of their compensation withheld by the employer to contribute to the Plan. These elective deferrals may not exceed 100% of their compensation or IRS limits. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company provided a 2% discretionary match for the years ended December 31, 2024 and 2023. The Plan also allows for a discretionary nonelective contribution to be made by the Company. To be eligible for the discretionary nonelective contribution, the participant must have earned at least 501 hours of service during the Plan year and is employed by the employer or a related employer on the last day of the Plan year. There were no discretionary nonelective contributions for the years ended December 31, 2024 and 2023.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company's contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting Fidelity.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates comparable to those of similar loans from commercial lending institutions, as determined by the Plan Administrator. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within fifteen years. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Hardship distributions and in-service retirement distributions are permitted for participants who have not separated from service. Hardship withdrawals are subject to account balance limits and applicable laws. Participants must have attained age 59 ½ to qualify for in-service retirement distributions.

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account, or the account balance may be rolled over to a qualified account. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Plan Administrators.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in matching employer contributions and nonelective employer contributions is based on years of service. A participant is 100 percent vested after four years of credited service for matching contributions and five years of credited service for nonelective contributions.

**Forfeitures**

At December 31, 2024 and 2023, there were unallocated assets, which consisted of forfeited non-vested accounts of \$42,997 and \$21,970, respectively. No forfeitures were used to reduce employer contributions or pay plan expenses during the years ended December 31, 2024 and 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, (“GAAP”), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Certain other administrative expenses were paid from the Plan's assets. Certain other plan expenses are paid by the Company and are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds (including money market funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 AMENDMENT AND TERMINATION**

Although it has not expressed intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 6 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan sponsored by Fidelity Management Trust Company. The pre-approved plan has received an advisory letter dated June 30, 2020, from the Internal Revenue Service as to the Plan's qualified status. The pre-approved plan advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fidelity Trust Management Company is the Trustee and Recordkeeper of the Plan as defined by the plan document. As such, transactions with the Trustee and Recordkeeper qualify as party-in-interest transactions. Total administrative fees paid to Fidelity Trust Management Company for recordkeeping services amounted to \$2,363 and \$2,025 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
