Due to the merger and transfer of Plan assets into The Standard Pooled Employer Plan, all Plan assets are deemed to be transferred from the Plan as of December 31, 2024 on the Form 5500; therefore, there are no Plan assets as of that date to report on the supplementary information required by the DOL's Rules of Regulations for Reporting and Disclosure under ERISA. Note 1 - Plan Description

The following description of the BH Inc (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Company who have completed two months of service, are 18 years of age, and are not members of a collective bargaining unit or a non-resident alien. The Plan is subject to the provisions of ERISA. The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

Merger and Transfer of Plan Assets

In 2024, the Company's Board of Directors, under its responsibilities granted by Charter, approved the merger of this Plan into The Standard Pooled Employer Plan, effective as of December 1, 2024. All Plan assets were physically transferred to The Standard Pooled Employer Plan during the blackout period which began December 6, 2024 and was complete on January 6, 2025. All Plan assets were transferred out as of December 31, 2024. See Note 8 for further details related to the merger.

Contributions

Each year, participants may contribute up to 100 percent of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a Safe Harbor match of 100 percent of the first four percent of compensation that a participant contributes to the Plan. The Safe Harbor matching Company contribution is invested directly in the fund in which the participant has elected to defer. Additional discretionary nonelective contributions may be contributed at the option of the Company's Board of Directors. During the year ended December 31, 2024, the Company did not elect to make a discretionary nonelective contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's Safe Harbor contributions, as well as allocations of the Company's discretionary nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's contribution portion of their accounts plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may only borrow one loan from their accounts. The loans are secured by the balance in the participant's account. The loan interest rate, determined at issuance of the loan, is set at prime plus one percent. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other eligible events defined by the Plan, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants who have attained age 59 1/2 may elect to receive either a partial withdrawal or lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may request a hardship withdrawal of the vested portion of their account. Any hardship withdrawal is limited to the amount needed to meet the financial need.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$5,942, respectively. These accounts will be used to pay Plan expenses or to reduce future employer contributions. During 2024, no forfeitures were used to pay Plan expenses or to reduce employer contributions.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Note 2 - Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of the Plan paid to the third-party administrator and other service providers are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Primarily valued at net asset value (NAV) per share based on quoted market prices of underlying investments. The NAV is used as a practical expedient to estimate fair value.

In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value of investments measured at NAV at December 31, 2024 and 2023 was \$0 and \$8,151,677, respectively. There were no other investments measured at fair value.

Investments Measured Using the NAV per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2023. There were no assets in the Plan as of December 31, 2024. There are no participant restrictions for these investments; the redemption notice period is applicable only to the Plan.

It is estimated that the underlying assets of the fund will be liquidated over the next seven to ten years. 20 percent of the total investment in this category is planned to be sold. However, the individual investments that will be sold have not yet been determined. Because it is not probable that any individual investment will be sold, the fair value of each individual investment has been estimated using the NAV of the Plan's ownership interest in the partners' capital. Once it has been determined which investments will be sold and whether those investments will be sold individually or in a group, the investments will be sold in an auction. The investee fund's management must approve the buyer before the sale of the investments can be completed.

Note 5 - Fully Benefit-Responsive Investment Contract

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company. American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and; therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA;
2. Premature termination of the contracts;
3. Amendments to the Plan Documents (including complete or partial Plan termination or merger with another Plan);
4. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participant.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation;
4. A material amendment to the agreements without the consent of the issuer.

Note 6 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments consist of pooled separate accounts and a fully benefit-responsive investment contract managed by American United Life Insurance Company. American United Life Insurance Company is the Custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment to the third-party administrator and other service providers considered parties-in-interest of \$38,155, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 7 - Tax Status

The Plan adopted a nonstandardized pre-approved profit sharing plan with Cash or Deferred Arrangement sponsored by DWC The 401(k) Experts. The plan has received an opinion letter from the IRS as to the plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Merger and Transfer of Plan Assets

Effective December 1, 2024, the Plan's assets were transferred into The Standard Pooled Employer Plan. The transferred net assets have been recognized in the accounts of The Standard Pooled Employer Plan as of December 31, 2024, at their balances as previously carried in the accounts of the Plan. All Plan assets were physically transferred to The Standard Pooled Employer Plan on December 16 and 18, 2024. A summary of the transferred net assets follows:

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Nonexempt Transactions

Under provisions of ERISA, contributions of employee deferrals are to be remitted to the Plan as of the earliest date on which such contributions can reasonably be segregated from general assets. During 2024 and 2023, the Company inadvertently failed to deposit certain participant deferrals within the required timeframe as stated by the DOL as reported on the attached schedule of delinquent contributions. The DOL considers late contributions to be prohibited transactions. The Plan Sponsor has fully corrected the late contributions, including lost interest and applicable excise tax, for the 2023 Plan year during the current year. The Plan Sponsor intends to reimburse the Plan for lost interest, file Form 5330, and to pay the applicable excise tax in 2025 for the 2024 Plan year late contributions noted above. The excise tax payments will be made from the Plan Sponsor's assets and not from the assets of the Plan.
