Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of One Senior Care, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Plan Description

The following description of One Senior Care, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was formed effective January 1, 2022. The Plan is a defined contribution plan sponsored by LIFE Northwestern Pennsylvania, LLC (the Plan Sponsor), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective on January 1, 2023, the Plan adopted a resolution to change the plan name to the One Senior Care, Inc. 401(k) Plan and the plan sponsor to One Senior Care, Inc. The Plan Sponsor's management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility: Employees of the Plan Sponsor, except for non-resident aliens, union employees, or leased employees, as defined by the Plan, are eligible to participate in the Plan. Eligible employees are enrolled immediately. Participants are eligible to receive discretionary employer matching contributions once they have reached the age of 21 and completed one year of service, as defined. Effective January 1, 2023, the Plan was amended to remove age and service requirements for discretionary employer matching contributions. All eligible participants will immediately be eligible to receive discretionary employer matching contributions. Employees of One Senior Care Virginia, LLC dba Cherry Blossom PACE (Cherry Blossom), and One Senior Care Kentucky, LLC, effective February 2024, related entities, are eligible to participate in the Plan. The Plan Sponsor and related entities are hereafter referred to collectively as the "Company".

Contributions: Participants may make voluntary pre-tax contributions to the Plan up to 100% of their eligible compensation, as defined. Participants who are 50 years and older may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan permits the Company to make discretionary employer matching contributions. The Plan limits matching contributions to \$5,000 in a given plan year. During the year ended December 31, 2024, the Company made matching contributions to all eligible participants equal to participant contributions limited to \$5,000 per participant for the Plan year. Effective July 1, 2024 the Plan was amended to fund matching contributions with each pay period to all eligible participants.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment election daily.

Participant accounts: Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, an allocation of Plan earnings, reduced for benefits paid, and charged directly for loan origination and benefit processing fees, if applicable. Plan earnings subject to allocation are allocated based on the investments held by the participant. The benefit to which a participant is entitled is limited to that which can be provided from the participant's vested account balance.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary employer matching contributions become 20% vested after one year of credited service, as defined, with vesting increasing at 20% increments each year thereafter, to 100% after five years of credited service. Participants are 100% vested upon reaching retirement age, regardless of service years.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Payment of benefits: Upon termination of employment with the Company, death, disability, or retirement, a participant or a participant's beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and for participants who have attained age 59½. Balances of terminated participants of less than \$5,000 are automatically distributed to participants.

Forfeitures: Forfeited non-vested accounts amounted to \$61,379 and \$7,386 at December 31, 2024 and 2023, respectively. Forfeitures of nonvested Company contributions are used to pay administrative expenses of the Plan or to reduce the Company's contributions. Forfeitures of \$13,616 were used to pay administrative expenses in 2024. Forfeitures of \$2,191 were used to fund the employer match in 2024.

Notes receivable from participants: The Plan allows participants to borrow from certain of their accounts a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loans must be repaid in at least quarterly installments over a maximum term of five years for personal loans and over a term determined by the Plan Administrator for loans related to the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024 and 2023, these rates range from 8.75% to 9.50% on loans outstanding, and the loans mature through 2028.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Contributions from participants are recorded in the year in which the underlying compensation is paid. The discretionary contribution from the Sponsor is recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding distribution.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 13, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. There were no transfers between levels during the year ended December 31, 2024 or 2023.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

Ascensus Trust Company is the trustee as defined by the Plan, Ascensus, LLC, through a subcontract agreement with the Vanguard Group Inc., is the Plan recordkeeper, HBKS Wealth Advisors is the Plan investment advisor, and Baker Tilly Vantage, LLC is the third-party administrator. Therefore, transactions with these parties qualify as party-in-interest transactions and are reported as administrative expenses. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be 100% vested in their entire account.

Note 7. Tax Status

The Plan has adopted a non-standardized form of an IRS preapproved plan sponsored by Walker Benefits LLC. Walker Benefits, LLC has received an opinion letter from the IRS as to the preapproved plan's qualified status dated June 30, 2020. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


