## INDEPENDENT AUDITOR'S REPORT

**NOTE A – DESCRIPTION OF PLAN**

The McCabe, Hamilton & Renny Company, Limited 401(k) Retirement Savings Plan (Plan) was established to provide retirement benefits for the employees of McCabe, Hamilton & Renny Company, Limited (Plan Sponsor and Company). The following is a description of the Plan which provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under the provisions of Section 401(a) of the United States Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), as well as certain provisions of the federal income tax laws. The Plan was amended and restated effective November 2021.

The Plan covers all employees (except residents of Puerto Rico and casual employees) of the Company who are at least 18 years of age for salary deferrals and 21 years of age and 12 months of service from the date of hire for employer contributions. Certain participants (L100) are subject to a collective bargaining agreement.

Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility.

Contributions

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the plan administrator, participants may be permitted to deposit or “rollover” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may make employee salary deferral contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,000 in 2024 and \$22,500 in 2023, adjusted annually for the cost of living. Participants who have attained the age of 50 may make additional annual contributions of \$7,500 in 2024 and 2023. Total contributions to each participant’s account may not exceed the lesser of \$69,000 (\$76,500 if age 50 and older) in 2024 and \$66,000 (\$73,500 if 50 and older) in 2023, or 100% of annual compensation, as defined. Excess contributions, if any, are refunded in accordance with provisions of the IRC.

Contributions (continued)

The following contribution types are allowed by the Plan:

- Elective deferrals
- Roth deferrals
- Employer discretionary profit sharing contributions
- Employer discretionary matching contributions
- Rollover contributions

The Company may elect on a year-to-year basis to make matching contributions to the Plan that are allocated to participants based on a percentage of the salary deferral contributions of each eligible participant who has completed a year of service and is still employed by the Company on the last day of the plan year. L100 participants are excluded from the matching contributions. The Company also may elect on a year-to-year basis to make profit sharing contributions to the Plan that are allocated to eligible participants based on their compensation. The Company's matching and profit sharing contributions are only available to non-bargaining employees, with the exception of negotiated bargaining unit benefits. For L100 participants, the profit sharing contribution is a fixed amount equal to 5% of compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions (if applicable), and an allocation of plan earnings or losses; and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for Company matching and profit sharing contributions is based on a three-year cliff vesting schedule. Under this vesting schedule, participants become 100% vested in employer matching and profit sharing contributions once three years of vesting service are completed. Prior to the completion of three years of vesting service, participants have no ownership interest in their employer matching or profit sharing amount. Participants are credited with a period of service for 12 months from date of hire. If participants are employed on or after their Normal Retirement Age or if they terminate employment on account of death or disability, they are 100% vested in their Company matching and profit sharing contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the plan administrator and Company in such multiples as the participant prescribes. Participants may change their investment direction with respect to future contributions or redirect the investments in their account balances.

Forfeited Accounts

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. The Plan allows forfeitures of non-vested Company contributions to be used to reduce the Plan's administrative expenses or Company contributions to the Plan.

At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$0. During the years ended December 31, 2024 and 2023, forfeited non-vested accounts of \$6,384 and \$213, respectively, were used to pay administrative expenses.

Notes Receivable from Participants

Participants, who are active employees, may borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balance in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the plan administrator. The maximum number of loans that may be outstanding at any one time is one, and spousal consent is required if the participant is married. The notes receivable and related interest must be repaid within five years unless they are used to acquire a principal residence, in which case the repayment period may be extended to 15 years. Principal and interest are paid ratably through payroll deductions.

Benefits Paid to Participants

Upon termination of service, disability, death, or normal retirement (age 65), a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

Participants who have vested account balances in excess of \$5,000 may receive their accounts in a single lump-sum payment or in periodic payments over their life expectancy. Participants who have vested account balances that do not exceed \$5,000 at the time of separation are automatically disbursed to the participant. Rollover contributions are not considered in determining if the account balance exceeds \$5,000.

Active participants may withdraw all or a portion of their vested account balances as in-service distributions after attaining age 59-1/2, or as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Services (IRS).

Plan Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonable possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

Contributions

Contributions from plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation. Contributions receivable are recognized for amounts due from the Company remitted to the qualified institution after plan year-end. The receivables are typically short-term in nature and are expected to be collected in full.

Management has evaluated the collectability of employer contributions receivable in accordance with Accounting Standards Update No. 2016-13, *Financial Instruments – Credit Losses (Topic 326)*, and determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023. The Plan considers the Company's historical payment experience, current and future financial condition, and the legally binding nature of the contribution obligation in making this assessment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded if the participant is no longer employed by the Company. For active participants who have not incurred a distributable event, such as employment termination, death or disability, but have delinquent receivables, the note receivable remains outstanding until a distributable event occurs. Once a distributable event occurs, the outstanding balance is considered a distribution or benefit payment.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Expenses are recognized when the related liability is incurred. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the related investments, as they are paid using investment earnings rather than a direct payment.

NOTE C – CERTIFICATION FROM QUALIFIED INSTITUTION

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained from information supplied to the plan administrator and certified as complete and accurate by Trust Company (Reliance), the qualified institution, as of and for the years ended December 31, 2024 and 2023.

**NOTE D – FAIR VALUE MEASUREMENTS**

U.S. GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies are valued using quoted market prices, a Level 1 input. The valuation methodology may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Transamerica Stable Value Core Account is an unallocated group annuity contract (annuity contract). Amounts invested in this contract are deposited to the general account of Transamerica Retirement Solutions, LLC (Transamerica). The contracts are backed by the general accounts of Transamerica, which supports all of Transamerica's policy and contractual obligations, including those that apply to the annuity contract. Transamerica is the owner of the underlying assets in the general account. All guarantees are based on Transamerica's financial claims-paying ability.

The unallocated group annuity contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative fees.

Transamerica assigns an interest rate to the annuity contract. Interest is credited daily to amounts the Plan has invested in the annuity contract. The effective credited interest rate is set semi-annually and effective on the first date of the semi-annual period. Contract charges may reduce this return. The annual minimum guaranteed interest rate can be equal to, but will never be less than, the lifetime minimum guaranteed interest rate. Transamerica sets current interest rates for the annuity contract. Current interest rates may be equal to or higher than the annual minimum guaranteed interest rate, but will never be lower.

The annuity option does not provide for a defined maturity date. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to certain restrictions. Further, withdrawals for participant benefits from the annuity contract are permitted as specified in the contract and are not subject to any market value adjustment.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Amendments to the plan documents (including complete or partial plan termination or merger with another plan).
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

**NOTE F – ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are held in a trust fund by First Hawaiian Bank as the directed trustee of the Plan. Reliance is the custodian of the Plan and Transamerica is the Plan's recordkeeper. The determination of the amount, timing, and type of contributions made to the Plan is made by a committee, which also determines the amount and method of benefits paid to participants from the Plan.

Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. Custodian fees and other administrative expenses are paid either by the Plan or by the Company, as provided in the plan document. Expenses that are paid by the Company are excluded from these financial statements.

**NOTE G – RELATED PARTY TRANSACTIONS AND TRANSACTIONS WITH PARTIES IN INTEREST**

A related party is any party who can control or significantly influence plan management or operating policies. Parties in interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, investment managers, investment advisors, legal counsel, and plan auditor.

During the years ended December 31, 2024 and 2023, the Plan made direct payments of \$61,740 and \$59,250, respectively, to certain parties in interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan, which are not included in the Plan's financial statements.

**NOTE H – TAX STATUS**

The Plan Sponsor adopted a plan which received a favorable determination from the IRS dated April 26, 2002, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the letter. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, and for the years then ended, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

**NOTE I – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan and Company operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effect on the financial statements of the Plan from such changes in economic conditions are not presently determinable.
