Report on the Financial Statements

NOTE 1 DESCRIPTION OF PLAN

The following description of Flatiron Construction Corp. Employee Health Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1982 to provide health and other benefits to eligible employees and their covered dependents of Flatiron Construction Corp. (the Sponsor) and its wholly owned subsidiaries: Flatiron Construction, Inc., Flatiron Constructors, Inc., Flatiron West, Inc., and E.E. Cruz & Company, Inc. (not wholly owned, but under common control). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

All non-craft employees scheduled to work at least 30 hours per week on a regular basis are eligible to participate. Craft employees are eligible to participate on the first day of the month following 60 days of service. Coverage normally terminates upon leaving full-time employment with the participating employers unless the participant elects extended coverage under the provisions of the Consolidated Omnibus Budget Reconciliation Act of 1975 (COBRA).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The premiums for health care benefits are established based on trended historical claims data and plan administrative costs. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium costs. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Benefits

The Plan provides health benefits (medical, dental, vision and prescription drug benefits), life insurance (basic, supplemental, and dependent), short-term disability benefits, long-term disability benefits, voluntary accident, and accidental death and dismemberment benefits to eligible members and to their dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures vision benefits, life insurance benefits, long-term disability benefits and accidental death and dismemberment benefits through insurance contracts. For craft employees, the Plan fully insures medical and dental benefits. The Company purchases annual insurance contracts for these insured benefits.

Self-Insured Benefits

Certain Plan benefits for administrative employees are self-insured, including medical, dental, prescription drug benefits and short-term disability benefits. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Flexible Spending Accounts

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions. The FSAs allow eligible participants to be reimbursed tax-free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The employer is not permitted to refund any part of the FSA balances to the employee; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the employer, and any unused amount is forfeited back to the Plan Sponsor. Residual FSA amounts unused at the end of the year can be carried over for two and one-half months into the next year to allow qualified expenses incurred during that period to be reimbursed from the account. Any residual FSA amounts remaining after the two and one-half month extension are immediately forfeited.

Health Savings Accounts

Active employees enrolled in the high-deductible health plan (HDHP) are eligible to enroll in a health savings account (HSA), subject to Internal Revenue Service (IRS) eligibility requirements. The Sponsor provides a contribution to the HSA and the employee may also elect to make additional contributions to their account subject to IRS limits. The contributions made to the HSA can be used on a tax-free basis to pay or reimburse for qualifying health care expenses. The participant owns the account and is responsible for substantiating distributions from the HSA account.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its demand deposits in commercial bank accounts, which at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and professional fees. These expenses are reported on the statements of changes in net assets available for benefits as Administrative Expenses.

Payment of Benefits

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Short-term disability payments are processed through the Company's payroll system and paid from the general assets of the Company. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds are netted with claims paid in the accompanying statements of changes in net assets for the years ended December 31, 2024 and 2023.

Refunds

Refunds are recorded when earned. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Medical, dental and prescription refunds of \$5,141,896 and \$1,078,520 for the years ended December 31, 2024 and 2023, respectively, have been netted against claims paid.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

Claims Incurred But Not Reported

The Plan "self-funds" medical and dental benefits provided to non-craft participants. As of each December 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable and claims incurred but not reported (IBNR) was estimated by Plan management using claims data from the third-party administrator and the actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Hour Bank Reserve

The Plan maintains an hour bank reserve for non-union craft employees who worked under prevailing wage contracts for which there are residual amounts that can be either (1) used for the employee portion of benefit costs for active employees, (2) used for the entire portion of benefit costs for terminated employees or (3) paid to the participants as cash compensation. During the years ended December 31, 2024 and 2023, there were no funds added to the reserve balance. The Plan Sponsor intends to spend down the hour bank reserve through payment of future benefit costs. During the years ended December 31, 2024 and 2023, \$46,967 and \$85,858, respectively, was used to pay insurance premiums and \$56,333 and \$9,567, respectively, was paid to participants as cash compensation.

NOTE 4 STOP LOSS COVERAGE

During the year ended December 31, 2024, the Plan maintained a stop loss insurance policy with Cigna Health and Life Insurance Company (CIGNA). The policy provides reimbursement to the Plan for claim amounts paid in excess of \$200,000 per year for each participant for the years ended December 31, 2024 and 2023. Since the Plan utilizes CIGNA for both claims processing and as the stop loss insurance carrier, the Plan is not billed for claims in excess of \$200,000 per year for each participant.

The Plan is required to maintain a premium deposit with the third-party claims administrator, CIGNA. The premium deposit is related to claims and will be used to pay claims in the event the Plan terminates the contract with CIGNA. The premium deposit amounted to \$457,000 as of December 31, 2024 and 2023.

NOTE 5 TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated November 15, 1988, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 8 RISKS AND UNCERTAINTIES

The liability for claims payable and claims incurred but not reported (IBNR) was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.


