### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Continuant, Inc and Affiliates 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (“financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 - Background Information and Description of Plan

The following description of Continuant, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Continuant, Inc. and its participating employers (collectively, the “Company”) and was originally formed and adopted on February 1, 2000. The Plan was most recently amended and restated effective July 15, 2022. The Company serves as the Plan Administrator and is responsible for the overall administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees become eligible to participate in the Plan upon reaching the age of 18 and completing three months of service for deferral contributions. For employer matching contributions, eligibility begins after six months of service.

#### Contributions

Enrollment for all eligible employees is automatic at 10% of compensation, unless the participant elects to opt out of enrollment or modify the deferral percentage. Participants may elect to defer up to 100% of their eligible compensation, as defined in the Plan Document, on a pre-tax or Roth basis, subject to the annual limits established under the Internal Revenue Code. Participants who attain age 50 before the end of the Plan year are eligible to make additional catch-up contributions as permitted under the Code. The Plan also permits participants to contribute amounts representing rollover distributions from other qualified retirement plans (“rollover contributions”).

Under the terms of the Plan, the Company makes a matching contribution equal to 100% of elective deferrals up to 3% of compensation, plus 50% of elective deferrals that are greater than 3% but less than or equal to 6% of compensation, per eligible participant each Plan year. To be eligible for matching contributions, participants must be at least 18 years of age and have completed six months of service during the Plan year. In addition, the Plan permits the Company, at its discretion, to make a profit-sharing contribution. No discretionary profit-sharing contributions were made for the years ended December 31, 2023 or 2024.

Participants direct the investment of both their contributions and the Company match contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching contribution and Plan earnings. Participant accounts shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants’ salary deferrals and rollover contributions, as well as the earnings thereon, are 100% vested at all times. Vesting in the Company matching portion of their accounts, plus actual earnings thereon, is based on years of credited service. Participants become fully vested after two years of credited service under a cliff vesting schedule. A participant who reaches normal retirement age of 65 years, becomes totally disabled, or dies, whichever comes first while under the Company’s employment, shall be 100% vested on such date.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

### Payment of Benefits

In the event of termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as defined in the Plan agreement, less any applicable taxes. If a participant's vested balance is \$1,000 or less, the Plan Administrator will distribute the entire vested account balance to the participant without their consent. Participants may also request in-service distributions upon attaining age 59 ½ or as a qualified reservist. Benefits may be received when a participant demonstrates a situation of financial hardship as defined in the Plan documents.

### Excess Contribution

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding addition to distributions. At December 31, 2024 and 2023, excess contributions payable amounted to \$0 and \$11,756, respectively.

### Forfeitures

The Plan provides that forfeitures of non-vested Company contributions may be used to pay Plan expenses or reduce Company contributions. For the year ended December 31, 2024, forfeitures in the amount of \$15,659 were received by the Plan and \$12,447 were used to pay Plan expenses. At December 31, 2024 and 2023, forfeitures in the amount of \$37,035 and \$32,813, respectively, were available for future use.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan terminates, the net assets will be allocated to the participants and beneficiaries based on the balance of each participant's account subject to adjustments for gains or losses incurred or accrued as of the termination date.

### Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.

### Note 2 - Summary of Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

#### Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (see below). Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments consists of both realized gains and losses and unrealized appreciation and depreciation of those investments.

#### Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* The collective trust fund is valued daily at the NAV. The NAV is determined by the administrator of the fund and is used as a practical expedient to estimate the fair value of the units held by the Plan. The NAV is based on the fair value of the underlying investments (primarily investment contracts and cash equivalents), less any liabilities, and then divided by the number of units outstanding. The objective of the collective trust fund is to preserve principal while maximizing current income over the short-term. The fund has no restrictions and no unfunded commitments.

The following tables present information about the Plan's assets that have been measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the classification by level of input within the fair value hierarchy described above:

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the audited financial statements were available to be issued.

### **Note 3 - Information Certified by the Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company and Newport Trust Company, LLC, qualified institutions, have certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024. The investment information as of and for the year ended December 31, 2023, was certified by a Principal Trust Company, a predecessor trustee, which was a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4 - Related Party and Party-In-Interest Transactions**

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$41,000 during the year ended December 31, 2024.

### **Note 5 - Tax Status**

The Plan has received a favorable determination letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the IRC and therefore entitled to favorable tax treatment. Although the Plan has been amended since receiving the determination letter, the Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
