Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of plan

The following description of the McKinley Companies, LLC 401(k) Retirement Plan (the Plan), provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

On December 20, 2019, the SECURE ACT became law and changes applicable to the Plan were placed in operation.

a. General

The Plan is a defined contribution plan covering all full- and part-time employees of McKinley Companies, LLC (Company), who have attained six months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation up to a maximum of \$23,000 for employees under age 50 and \$30,500 for employees age 50 and above. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan through Fidelity Investments. The Plan currently offers a selection of mutual funds as investment options for participants. The Company may make voluntary matching contributions as determined annually at the end of each year. The matching Company contribution is invested using the investment options that each participant has selected. For 2024, the Company contributed 20% of the first 6% of base compensation that a participant contributed to the Plan.

c. Participant accounts

Each participant's account is credited with the participant's contributions and withdrawals, as applicable, and allocations of the Company's contributions, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions or Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

d. Vesting

Participants are immediately vested in their contributions and any Company qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service (including prior continuous service from January 1, 1993). A participant is 100 percent vested after five years of credited service.

e. Investment options

Participants may designate that their contributions be invested in a variety of investment options offered by the trustee and approved by the Plan administrator. These options include mutual funds that invest in fixed income securities, equity securities and money market investments.

f. Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as defined by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts paid to such participants for the year ended December 31, 2024 were \$1,963,394. Excess contributions of \$-0- and deemed distributions of participant loans of \$49,090 were distributed back to participants during 2024.

g. Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Note transactions are treated as a transfer to (from) the investment fund from (to) the Participants' notes receivable fund. Notes receivable from participants at December 31, 2024 and 2023 amounted to \$532,773 and \$504,057, respectively.

h. Forfeited accounts

During 2024, there were \$31,717 of forfeitures on non-vested accounts as well as \$1,152 of unclaimed distribution checks for beneficiaries with unknown addresses. At December 31, 2024 and 2023, the balance in the forfeiture account totaled \$14,905 and \$14,722, respectively. Forfeited non-vested accounts are used to reduce employer expenses for maintaining the Plan. Distributions of \$1,000 from this account were used to pay administrative expenses and employer matching funds of the Plan for 2024.

2. Summary of accounting policies

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Benefits are recorded when paid.

b. Investment valuation and income recognition

The Plan's investments, other than those in the common/collective trust, are stated at fair value based on quoted values in an active market as summarized by the trustee. The common/collective trust is valued based on the contractual terms of the underlying guaranteed investment contracts. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Notes receivable from participants are valued at their outstanding balances, which approximate fair value. Purchases and sales of securities are recorded on a trade-date basis.

c. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

d. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

e. Administrative expenses

The Company pays for most of the administrative expenses of the Plan, unless forfeitures are available to pay the expenses.

f. Date of management's review

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

4. Fair value measurements (continued)

The valuation methodologies used for assets measured at fair value are as follows:

Registered investment companies - valued at the closing prices of shares held by the Plan at year-end.

Common/collective trusts - valued at the net asset value of shares held by the Plan at year-end. The net asset value as provided by the custodian is used as a practical expedient to estimate fair value and as a result both are included in the investments measured at net asset value.

The methods described above may produce a calculated fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with ASU 2015-07, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the table above for those investments are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of financial position.

5. Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any termination of the Plan, the accounts of each affected participant shall become fully vested.

6. Party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by a company related to the trustee and assistant to the Plan administrator and, therefore, qualify as party-in-interest transactions. Fees and commissions in the amount of \$58,248 were paid to the trustee during 2024.

7. Tax status

The Internal Revenue Service has determined and informed the Company by letters dated October 26, 1992, and February 14, 1996, and March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letters, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
