Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Lone Star Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of Lone Star Corporation 401(k) Plan ("Plan") provides only general information. Participants should refer to the legal plan document for a more complete description of the plan's provisions.

General

The Plan, originally effective July 1, 2010, has been amended and restated effective July 22, 2022, to conform the Plan to new tax laws. Lone Star Instrumentation & Electric Corporation ("Company") is the employer and administrator of the Plan. The Plan is a qualified retirement plan pursuant to section 401(k) of the Internal Revenue Code ("IRC") adopted to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

All employees of the Company are eligible to participate in the Plan after attainment of age 21 and completion of one year of service. Employees electing to participate will become a participant of the Plan for all contribution types allowed on the first day of the quarter coinciding with or next following the date they satisfy the eligibility requirements.

Contributions

A participant may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a pre-tax 401(k) deferral or Roth 401(k) deferral. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may defer additional amounts as catch-up contributions.

The Plan is a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a safe harbor matching contribution equal to 100% of a participant's salary deferrals that do not exceed 5% of their compensation. The Company has the option to make annual discretionary matching and non-elective contributions in an amount to be determined by the Company. There were no discretionary matching or non-elective contributions made for the year ended December 31, 2024.

Participants are also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Participants direct the investment of their entire interest in the Plan in any of several investment securities. Participants can change their investment allocation among the various securities either through direct transfers from one option to another or by changing the percentage allocation of future contributions.

Vesting

Participants are always 100% vested in their salary deferrals including Roth 401(k) deferrals and catch-up contributions, safe harbor contributions, and rollover contributions.

Notes Receivable from Participants

Loans are available to participants on a reasonably equivalent basis. All loans must be adequately secured and are charged a reasonable rate of interest. No loan in an amount less than \$1,000 will be made. The maximum loan amount will be limited to the lesser of \$50,000 reduced by the highest outstanding balances of loans during the prior one-year period or one half the participant's vested interest in the Plan. Generally, the term of the loan may not exceed five years unless the loan is for the purchase of a principal residence.

Benefits Paid to Participants

Participants may receive a distribution of the vested portion of some or all of their account in the Plan upon termination of employment, normal retirement, disability, or death. In addition, a participant may receive a distribution from the Plan from certain accounts prior to their termination of employment provided they have attained age 59½ or incurred a financial hardship.

If the value of the terminated participant's vested account balance is less than \$1,000, the Plan will distribute it to the terminated participant as a lump-sum distribution. If the participant's vested account balance is greater than \$1,000, the participant may elect to receive a lump sum distribution, roll the balance into another qualified retirement plan or an IRA, or leave the vested balance in the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by both Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower Retirement"), a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Variable Annuities – Unit values for variable annuities are calculated daily by Empower Retirement according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The unit value is determined in a manner similar to a mutual fund net asset value calculation: dividing the net assets by the number of units outstanding. The unit value is deemed to be published and is the basis for current participant transactions (purchases and sales).

Fixed Annuities – Values for fixed annuities are reported daily based on the valuation method disclosed in the annuity contract, as calculated by Empower Retirement. The Company evaluates the general financial condition of Empower Retirement as a component of validating whether the calculated value is an accurate value. All of these inputs are generally considered obtainable/observable through the review of existing contracts and readily available financial information.

5. TAX STATUS

The pre-approved plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Plan investments are managed by Empower Retirement. Empower Retirement is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. In addition, the Plan provides for notes receivable from participants, which are party in interest transactions that are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

There were two and three investments as of December 31, 2024 and 2023, respectively, that represent a concentration of greater than 10% of the Plan's net assets available for benefits.
