## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Central Moloney, Inc. Retirement Savings Plan for Salaried Employees (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was effective January 1, 1994, is a defined contribution plan maintained for the benefit of employees of Central Moloney, Inc. (the Employer, Plan Sponsor and Plan Administrator), who have met eligibility requirements as defined in the Plan. Generally, employees who are age 18 or older and not covered by a collective bargaining agreement are eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Employer utilizes the services of Fidelity Management Trust Company (Fidelity), a third party administrator and trustee, to process investment transactions, maintain participant account balances and act as trustee of the Plan's assets. Also, the Employer has entered into an agreement with Meridian Investment Advisors (Meridian) to provide investment advisory services related to the Plan's investment portfolio. Total fees paid by the Plan to Fidelity and Meridian were approximately \$98,000 for the year ended December 31, 2024.

The Board of Trustees for the Plan is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$11,000 for the year ended December 31, 2024.

### **Contributions**

Participants may contribute up to 90% of annual compensation, as defined in the Plan, not to exceed limitations imposed by the Internal Revenue Service (IRS). The Plan includes an automatic enrollment provision, which provides that employees who have met eligibility requirements are automatically enrolled as participants in the Plan at a salary deferral rate of 2% of eligible compensation, unless the employee completes an enrollment form and elects otherwise. On an annual basis each May 1st, the salary deferral percentage is increased by 1% until the salary deferral percentage equals 7% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Employer may make discretionary matching contributions. Employer contributions are also subject to limitations imposed by the IRS.

## **NOTE 1: DESCRIPTION OF PLAN (Continued)**

### **Contributions (Continued)**

Only those participants who are actively employed by the Plan Sponsor on the last day of the Plan year and who have completed 1,000 hours of service during the Plan year are eligible to receive matching contributions made by the Employer. A participant who dies, becomes disabled or retires after reaching normal retirement age during the Plan year is also eligible to receive Employer matching contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's matching contributions (if any) and allocations of Plan earnings, net of certain administrative expenses. Allocations are generally based on participant account balances, as specified in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in the Employer's contributions, plus actual earnings thereon, occurs according to the following schedule.

### **Investment Options**

Participants may direct the investment of their contributions in one or more mutual funds or a collective trust fund offered under the Plan. Participants may change their investment options at any time.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms may range from one to five years. The loans are secured by the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

### **Forfeitures**

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Under the terms of the Plan agreement, forfeitures are used to reduce Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, the Plan had forfeitures totaling approximately \$54,000 and \$46,000, respectively, that were available for future use. During the year ended December 31, 2024, forfeitures totaling approximately \$4,800 were used to pay plan expenses.

### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value accumulated in his or her account in either a lump-sum amount or in periodic installments over a period to be selected by the participant (or beneficiary) from several options under the Plan. For termination of service due to other reasons, a participant may receive the value accumulated in his or her account as a lump-sum distribution or, if the account balance exceeds \$5,000 on the date of termination, may leave the account under the Plan until the participant reaches normal retirement age or dies.

### **Hardship Withdrawals**

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the participant's vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments, notes receivable from participants and related activity reflected in the financial statements and supplemental schedule was certified by the Plan's trustee, Fidelity Management Trust Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
  
- Level 2      Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust

Collective trust stable value fund is valued at the NAV of units of a collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The fund invests in a diversified portfolio of stable value investment contracts issued by life insurance companies, banks and other financial institutions. The principal value is designed to remain stable regardless of stock and bond market fluctuations. The fund is designed for long-term retirement investing.

**NOTE 5: TAX STATUS**

Effective April 25, 2022, the Plan executed an adoption agreement for the Fidelity Volume Submitter Defined Contribution Basic Plan #17 (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The Prototype obtained its latest opinion letter on June 30, 2020, in which the IRS informed Fidelity Management and Research Company, that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

***NOTE 5: TAX STATUS (Continued)***

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

***NOTE 6: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain of the investment options available to Plan participants may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued.
