### Opinion

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Plan Description**

The following description of Performance Contractors Inc. (the “Sponsor”) Health Benefit Plan #503 (the “Plan”) provides only general information. Participants should refer to the Plan agreement and any related amendments for a more complete description of the Plan’s provisions.

*General:* The Plan offers medical, prescription, dental, vision, disability, life, and accidental death & dismemberment benefits to all full-time employees electing to participate in the plan after sixty days of employment. In addition, the Plan offers postretirement medical and prescription benefits to qualifying employees. To qualify for these postretirement benefits, an employee must have 20 years of service and hold a staff position, as defined in the Plan documents, on the date of their retirement. The Plan is subject to the provisions of the Affordable Care Act and Employee Retirement Income Security Act of 1974 (ERISA), as amended. The benefits under the Plan are uninsured (self-insured), fully insured, or a combination thereof.

The Plan’s financial statements include the financial activity of all benefit offerings, whether insured, uninsured, or a combination thereof. This financial activity includes that of the Plan along with certain transactions accounted for by the Sponsor.

*Medical and Prescription Benefits:* The Plan provides self-insured medical and prescription benefits to electing full-time employees and their beneficiaries and covered dependents. The benefits are offered under a Preferred Provider Organization Plan (PPO – Plan A) and High Deductible Health Plan (HDHP – Plan B). Effective July 1, 2023, an additional High Deductible Health Plan (HDHP – Plan C) option was offered to Plan participants. In Network deductibles under the PPO plan are \$1,000 per individual and \$2,000 per family per calendar year, coinsurance of twenty percent with a maximum out-of-pocket of \$3,000 per individual and \$4,000 per family. In Network deductibles under the HDHP-Plan B plan are \$5,000 per individual and \$10,000 per family per calendar year, coinsurance of twenty percent with a maximum out-of-pocket of \$6,000 per individual and \$12,000 per family. In Network deductibles under the HDHP-Plan C plan are \$2,850 per individual and \$5,200 per family per calendar year, coinsurance of twenty percent with a maximum out-of-pocket of \$4,250 per individual and \$8,500 per family. Lifetime overall maximum benefit is unlimited under all of the plans. Deductibles, coinsurance, and maximum out-of-pocket are more costly to the participants for out of network PPO and HDHP providers.

*Participant Medical and Prescription Benefit Contributions:* Required contributions under the PPO and HDHP medical and prescription plans are established annually on July 1<sup>st</sup>, which represents the beginning of the open enrollment period. The current and prior period rates were as follows:

*Sponsor Medical and Prescription Benefit Contributions:* The Sponsor pays for all medical and prescription claims in excess of participant contributions on a claims incurred basis. Claims are reported weekly by the claims administrator, and to the extent that claims exceed available plan assets, the Sponsor contributes the additional funds necessary to pay the weekly claims. The Plan is self-funded to the extent of a \$325,000 stop-loss policy per covered participant or dependent, and any excess is insured by the stop loss insurance policy paid by the Sponsor.

**1. Plan Description (continued)**

*Other Benefits:* The Plan's dental, vision, voluntary life, basic life, and disability benefits are fully insured through various insurance policies. Excluding basic life, the premiums for these benefits are fully paid with participant contributions. For basic life, which is offered to all employees participating in the health benefit plan, the Sponsor pays all of the premiums for this policy. The basic life policy offers a lump-sum payment of \$15,000 to a covered employee upon their death or significant loss, as defined in the agreement, during their employment with the Sponsor.

*Plan Termination:* Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the trust fund shall continue to be used and applied until exhausted for the payment of plan benefits, including the purchase of a contract of insurance and for the payment of fees and expenses of the plan and trust. Under no circumstances shall the trust fund or the net earnings of the trust fund, if any, be distributed to the Sponsor upon termination of the Plan.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting:* The financial statements of the Plan are prepared using the accrual method of accounting.

*Subsequent Events:* Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

*Concentration of Credit Risk:* The Plan maintains its cash in financial institutions insured by the Federal Deposit Insurance Corporation (FDIC). The accounts, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts.

*Use of Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition:* The plan has no investments or income there on for the current or prior period.

*Postemployment Benefit Obligations:* An obligation for postemployment benefits is not recognized because the amount cannot be reasonably estimated. Historically, the number of COBRA participants and the average time period they choose to continue receiving benefits has been inconsequential to the Plan as a whole.

*Plan Administration Costs:* A significant portion of the plan administration costs are absorbed by the Sponsor.

*Refunds, Rebates, and Subrogation:* Amounts due to the Plan for refunds, rebates, and subrogation are recorded as a receivable with a corresponding offset to benefit or premium payments, as applicable. If the amount cannot be reasonably estimated, then it is recorded when received. During the current and prior year, pharmacy rebates totaling \$2,196,723 and \$1,652,514, respectively, were netted with claims paid in the accompanying statements of changes in net assets available for benefits.

*Deficit in Net Assets Available for Benefits:* Deficiencies in net assets over benefit obligations, if any, relate primarily to claims IBNR and postretirement benefit obligations that have been accrued in the financial statements. Deficits in net assets available for benefits are funded by the Sponsor on a pay-as-you-go basis.

**2. Summary of Significant Accounting Policies (continued)**

*Postretirement Benefit Obligation:* The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Sponsor. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Sponsor and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. For measurement purposes, as of December 31, 2024, an 8.50% annual rate of increase in the per capita cost of covered medical and prescription benefits was assumed; then grading down to an ultimate rate of 4.00%. For 2023, a 7.50% annual rate of increase in the per capita cost of covered medical and prescription benefits was assumed and graded down to an ultimate rate of 4.00%.

The Plan lacks historical experience for certain assumptions used in the postretirement benefit obligation valuation process. Key information related to plan participation and average retirement age were estimated during the actuary evaluation since historical information wasn't available. The actuary assumed a 25% participation rate by using the Society of Actuaries' 2003 Turnover study. These figures will be adjusted as the Plan accumulates additional historical information in the future.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

*Other Benefit Obligations:* Claims incurred but not reported (IBNR) to the plan are determined based on amounts reported to the plan administrator between plan year end and the time the financial statements were available to be issued. Accounting principles generally accepted in the United States of America require IBNR claims be measured at the present value, as applicable, of the estimated ultimate cost to the plan of settling the claims and the estimated ultimate cost shall reflect the plan's obligation to pay claims to or for participants beyond the financial statement date pursuant to the provisions of the plan; however, the plan trustee believes that the difference between the two methods is not material to the financial statements. Medical and prescription claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

**3. Tax Status**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501 (c) (9) of the Internal Revenue Code and the trust has obtained a favorable tax exemption letter from the Internal Revenue Service (IRS). The Sponsor believes that the trust and the plan, as amended, continue to qualify and to operate as designed. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan's open tax years for the prior three years are subject to examination by the IRS.

**4. Parties-in-Interest**

The Plan has no reportable or nonexempt transactions for the current and prior period.

**5. Third Party Administrative Services Agreement**

Health Claims Processing

The Plan is currently contracted with Blue Cross Blue Shield of South Carolina (BCBSSC), a party-in-interest, to provide administrative claims payment services. The agreement covers claims processing payment services for the health benefits offered by the Plan. Total administrative fees charged to the Plan during the years ended December 31, 2024 and 2023 were \$1,606,442 and \$1,246,311, respectively. The balance due BCBSSC for administrative fees as of December 31, 2024 and 2023 was \$0 and \$125,506, respectively.

Prescription Claims Processing

The Plan has contracted with MaxorPlus for pharmacy benefit management services. Among other things, the agreement covers prescription claims processing, maintenance of a pharmacy network for Plan participants, provides MaxorPlus with exclusive rights for the provision of mail/specialty prescriptions to Plan participants, and a rebate program. Management has determined that all services provided under the agreement are exempted transactions. Administrative fees associated with the contract were minimal for the current and prior year.

Medication Reimbursement Management

The Plan entered into a contract with Payer Matrix on July 1, 2022 for specialty drug and medication reimbursement management services by dealing directly with alternate funding programs offered by manufacturers, charitable organizations, and grant programs. Among other things, the services include the following: (a) enhanced reimbursement for certain prescription drug products that require difficult or unusual administration, mandated risk evaluation and mitigation strategies, enhanced data collection efforts, and cost greater than \$670 per 30-day supply, (b) facilitating the initial and on-going enrollment of participants in alternative funding programs with active prescription orders for Specialty Drugs listed on the Specialty Drug List (SDL), and (c) engaging with Plan, MaxorPlus, and participants to resolve issues that may affect participants' access to specialty drugs. The initial contract term is 3 years and automatically renews for consecutive 1 year terms unless either party chooses to terminate the agreement at the end of the latest term. The Plan pays a 25% cost avoidance fee, which is based off of drugs on the SDL funded under the program, to Payer Matrix for its services. The original cost avoidance fee of 30% was amended to 25% effective July 1, 2023. The cost avoidance fees charged and accrued to the Plan are presented as part of medical and prescription benefits on the Statements of Changes in Net Assets Available for Benefits and Benefit Obligations as of and for the year ended December 31, 2024. Total cost avoidance fees charged to the Plan during the year ended December 31, 2024 and 2023 were \$306,376 and \$487,317, respectively. There was no balance due Payer Matrix for cost avoidance fees as of December 31, 2024 and 2023.

**5. Third Party Administrative Services Agreement (continued)**

Post-Employment Benefits Administration

The Plan has contracted with WageWorks for post-employment benefits administration services. Among other things, the agreement provides for the following COBRA services: (a) monthly billing and management of participant contributions due, (b) publication and mailing of initial, eligibility, general, expiration, and similar type notices to participants, and (c) remittance of net amounts to the Plan. Total administrative fees charged to the Plan during the years ended December 31, 2024 and 2023 were \$16,003 and \$9,682, respectively. The balance due WageWorks for administrative fees as of December 31, 2024 and 2023 was \$0 and \$1,094 respectively.

Management has determined that all services provided under these administrative service agreements are exempted transactions. None of the agreements require the service providers to assume any financial risk or obligation with respect to claims and claim amounts. Furthermore, none of the agreements confer upon the service providers the (a) status of fiduciary as defined by ERISA, or (b) any responsibility for or control over the terms or validity of the Plan.

**6. Concentrations**

The health and prescription benefits offered by the Plan are uninsured benefits whereby the Sponsor funds 100% of the obligations not covered by participant contributions. As a result, a significant portion of the Plan's total contributions are funded by the Sponsor. Sponsor contributions represented 44.54% and 44.00% of total Plan contributions during the current and prior year, respectively.

**7. Risks and Uncertainties**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured health and prescription benefits (individual participant claims over a specific dollar amount). Premiums for stop loss insurance are included in the accompanying statements of changes in net assets available for benefits. Stop-loss recoveries under the policy totaling \$1,830,108 and \$291,805 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits in the current and prior year, respectively.

The actuarial present value of the postretirement benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**8. Prescription Benefits and Medicare**

Single employer health benefit plans that offer prescription drug benefits are required to make certain disclosures in the notes to the financial statements. The Plan meets these requirements and is therefore required to disclose the following: (a) it has notified and disclosed to participants the existence of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003, (b) the Plan's Accumulated Postretirement Benefit Obligation (APBO) and the changes in the APBO during the current and prior period haven't been adjusted for any amounts associated with Medicare subsidy since the Plan isn't directly entitled to said subsidy, (c) the Sponsor isn't currently able to determine whether the Plan's prescription benefits are actuarially equivalent to Medicare Part D.1, and (d) the Sponsor's APBO is different than the Plan's APBO because the Sponsor has the ability to include the impact of this Medicare subsidy when determining its APBO and changes in its APBO.

**9. Postretirement Benefit Obligation**

The weighted-average health care cost-trend rate assumption (see note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$641,000 and \$675,000, respectively. If the assumed rates decreased by one percentage point in each year, it would decrease the obligation as of December 31, 2024 and 2023 by \$545,000 and \$568,000, respectively. Expected future postretirement benefit payments for medical and prescription claims are as follows:
