Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Moneta Group, LLC Employee Benefits Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a complete description on the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan was established on January 1, 2006, to provide medical and prescription drug coverage to eligible employees of Moneta Group, LLC (the "Company") and covered dependents. The medical and pharmacy coverage became self-insured effective January 1, 2016.

Plan assets are held in a voluntary employees' beneficiary association trust ("VEBA Trust"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended.

Administration

The Company, as Plan Administrator, retained the services of United HealthCare Insurance Company ("United HealthCare") to administer the review, processing, and payment of claims. All expenses incurred in the administration of the Plan are paid by the Plan.

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, accidental death and dismemberment, critical illness, and short and long-term disability benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Insured benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent); accidental death and dismemberment benefits; short and long-term disability benefits; and dental, vision, and voluntary life benefits. The Company purchases annual insurance contracts for these fully insured benefits and the premiums are paid to the insurance company from the general assets of the Company. Medical and pharmacy claims are paid from the assets of the VEBA Trust.

Stop-loss policy

The Plan is covered by a stop-loss insurance policy. Under this policy, the insurance company reimburses the Plan for medical claims incurred in a calendar year which exceed 100% of the annual aggregate claims estimated at the beginning of the year by the insurance company or claims exceeding \$100,000 for an individual. The cost of the reinsurance program is funded by Plan assets.

Employment benefit trust

Plan assets are held in a VEBA Trust at Enterprise Bank. The VEBA Trust funds health and prescription drug coverage claims paid by the Plan, and the administrative expenses of the Plan.

Self-insured benefits

The medical and pharmacy Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only ("ASO") arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA Trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Cash

The Plan's cash is held in a non-interest-bearing checking account. The Plan's cash is on deposit with a domestic financial institution. At times, bank deposits may be in excess of federally insured limits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Prepaid expenses - UHC

The Plan maintains an arrangement with United Healthcare under which the Company funds a bank account owned and controlled by the third-party claims processor to facilitate the payment of claims. Amounts deposited into this account represent prepayments for future claims and are recorded as prepaid expense in the accompanying financial statements.

Contributions and receivable

Employee contribution premiums are withheld from participants' paychecks on a pay-date basis and are remitted to the VEBA Trust periodically throughout the year. Employer contributions are also remitted to the VEBA Trust at various points during the year as determined by the Company. Contributions are recognized as additions to net assets once withheld from participants' paychecks and/or determined by the Company. Amounts withheld from employees and amounts due from the Company but not yet remitted to the VEBA Trust as of December 31, 2024 and 2023 are reported as receivable from employer.

Payment of benefits

Premiums paid by either the Company or the VEBA Trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Stop-loss premiums and reimbursements

The Plan has a stop-loss insurance arrangement with Sun Life Assurance Company of Canada. Premiums for the Plan's stop-loss insurance are included in the accompanying statements of changes in net assets available for benefits. During the Plan years ending December 31, 2024 and 2023, stop loss premiums totaling \$975,177 and \$1,164,836, respectively, and have been included with administrative expenses in the accompanying statement of changes in net assets.

Reimbursements receivable for stop-loss insurance are included in the claims paid in the accompanying statements of changes in net assets available for benefits. During the Plan years ending December 31, 2024 and 2023, stop-loss reimbursements totaled \$725,201 and \$484,643, respectively.

Rebates

Rebates due to the Plan are recorded when earned. Rebates due as of the financial statement date have been recorded as an offset being netted against claims paid. Rebates totaling \$544,984 and \$544,525 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Benefit obligations

At December 31, 2024 and 2023, health claims incurred by participants but not reported at that date are estimated by United HealthCare based on the claims received after year end through the date these financial statements are available to be issued. Such estimated amounts are reported in the accompanying statements of benefit obligations.

Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claim administrators, consulting fees, external audit fees, and stop-loss insurance provider. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

Reclassification

Certain reclassifications have been made in the accompanying 2023 financial statements to conform to the 2024 presentation.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated based upon information provided by United HealthCare. These amounts are paid by the Plan only if claims are submitted and approved for payment. While Plan management believes the amount to be fairly stated, the ultimate liabilities may be in excess of, or less than, the amounts provided.

4. TAX STATUS

The VEBA Trust funding certain benefits of the Plan received an exception letter from the IRS dated August 4, 2016, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC").

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

4. TAX STATUS (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the state and federal taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Company has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Company will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

6. PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Company and related Trust are related parties to the Plan. Certain professional and administrative costs of the Plan have been paid by the Company. Personnel and facilities of the Company have been used by the Plan for accounting and other activities at no charge to the Plan.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The amounts of \$259,362 and \$380,865 at December 31, 2024 and 2023, respectively, included in the accompanying statements of benefit obligations consists of claims filed by participants but unpaid by the Plan at year-end, plus an estimated amount for unreported participant claims based on actual payments subsequent to Plan year-end and historical claims information. In accordance with accounting principles generally accepted in the United States of America, these obligations are not a liability of the Plan at the Plan year-end; however, the Department of Labor requires these payments to be recorded as a liability on the Form 5500 – Annual Return/Report of Employee Benefit Plan.
