NOTE 1 - Description of the Plan

The following description of the EVO Transportation and Energy Services, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established April 1<sup>st</sup>, 2023 to provide health and other benefits to eligible participants. The sponsoring employer, EVO Transportation and Energy Services, Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, life and accidental death and dismemberment, short-term disability and supplemental benefits for eligible participants and their dependents. The Plan provides these benefits through contracts with third party insurance companies' contracts.

Eligibility rules under the Plan require all employees hired as active employees to receive coverage the first of the month following one month of continuous employment on a fringe contract. Benefits terminate on the last day of the month in which a participant's employment terminates.

Eligible employees will receive an allocation to a separate retirement plan with the remainder of fringe in excess of plan cost contributed. These retirement contributions are reported as contribution income and then deducted as an expense.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 22, 2025 the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$280,922 and \$22,244 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 4 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 and 2023 and, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - Plan Termination

In 2025, the plan sponsor notified the Trustee to terminate the existing Plan effective March 31, 2025. Any remaining plan assets will be transfer to EVO Transportation and Energy Services, Inc. for benefits paid under a Cash Model.
