NOTES TO THE FINANCIAL STATEMENTS

A - DESCRIPTION OF PLAN

The following description of the Star Companies 401(K) Plan ("the plan") provides only general information. The plan sponsor is Star Home Entertainment Systems, Inc. Participants should refer to the Summary Plan Description (SPD) for additional information.

General

The plan was established on and effective as of January 1, 2014. The plan is a qualified defined contribution plan covering all employees of the Company and its affiliate, STARS D, Inc., who have six consecutive months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Ascensus Trust Company acts as record keeper and custodian for the plan.

Allocations

Assets of the plan are allocated to participant accounts based on specific contributions made by each participant and respective match made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant's account and any earnings thereon.

Contributions

Each year, participants may contribute up to annual federally defined limits. Participants may make elective contributions of pretax compensation and Roth 401 (k) deferrals subject to the provisions of Internal Revenue Code Section 401 (k) and the provisions of the plan. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1 % of eligible compensation. The plan allows the Company to make matching and profit-sharing contributions in the amount determined by the Company at its discretion. In 2024, the Company made matching contributions of 50% of salary deferrals to a maximum of 6% of compensation.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of the participant's accounts plus actual earnings thereon is 20% after two years of service increasing 20% each year until fully vested after six years. A participant is 100 percent vested in employer contributions upon attainment of normal retirement age, death, total disability or after six years of service.

Disposition of forfeitures

Forfeitures, if any, are used to pay plan expenses in the year they occur. During the current year, there were forfeitures available of \$6,672 of which none were utilized to pay plan expenses. As of December 31, 2024, there were \$6,120 of unallocated forfeitures.

A - DESCRIPTION OF PLAN (Continued)

Benefit payments

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum distribution or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of their vested account in a lump-sum.

Participant accounts

The plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Investment options

Upon enrollment in the plan, participants direct the investment of their contributions and the Company contributions into various investment options offered by the plan. Participants may direct their contributions into one or more mutual funds or money market funds.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions and distributions would be made as soon as administratively practical after the plan terminates.

Notes receivable from participants

Participants may borrow from their fund accounts, for certain hardship needs, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The term of the loan may not exceed 5 years except for the purpose of purchasing a primary residence. The loans are secured by the balance in the participant's account.

The notes bear interest at 1% above WSJ prime. Principal and interest are paid ratably through payroll deductions.

Participant rollovers

Participants are allowed to transfer or rollover funds into the plan from other qualified plans.

## B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following summary of the plan's significant accounting policies is presented to assist in understanding the financial statements. The financial statements and notes are representations of the plan's management, who is responsible for their integrity and objectivity.

### Basis of presentation and use of estimates

The plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The accrual basis of accounting requires the use of estimates and assumptions that affect the assets, liabilities, revenues and expenses reported in the financial statements, as well as amounts included in the notes thereto, including discussion and disclosure of contingent liabilities. Although the plan uses its best estimates and judgments, actual results could differ from these estimates as future confirming events occur.

### Investment valuation and income recognition

Money market and mutual funds are reported at fair value based on published market prices, which represent the quoted net asset values of shares held by the plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the exdividend date. Net appreciation in fair value of investments includes the plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

### Plan expenses

Plan expenses are paid by both the Company and the plan.

### Payment of benefits

Benefits are recorded when paid.

### Contributions

Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant earnings.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal plus accrued interest income. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

## C - INCOME TAX STATUS

The plan document is based upon a volume submitter plan instrument from Ascensus Trust Company which received an IRS advisory letter dated June 30, 2020. The volume submitter plan instrument has been updated for legislative and regulatory changes. Management Committee of Star Companies 401(K) Plan and plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for state or federal income taxes has been included in the plan's financial statements.

C - INCOME TAX STATUS (Continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

F - FAIR VALUE MEASUREMENTS

The framework for measuring fair value is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1

Fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2

Fair values are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly.

Level 3

Fair values are based on at least one significant unobservable input for the asset.

G – RISK AND UNCERTAINTIES

Financial instruments subject to credit risk consist primarily of investment securities and participant notes receivable.

Investment securities

The plan's investments are not insured by agencies of the United States government. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits. The maximum amount of loss due to credit risk that the plan would incur if parties to the financial instruments failed to perform according to the terms of the contracts and the collateral, if any proved to be of no value, would approximate the balances that appear on the Statement of Net Assets Available for Benefits.

Notes receivable from participants

As previously stated, participant notes receivable are secured by the balance in the participant's account. Consequently, management considers any risk of collectability to be very unlikely. However, if such events should occur, the loss would be limited to the balance reported in the statement of net assets available for benefits at year end.

G – RISK AND UNCERTAINTIES (Continued)

General business economy

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

H - SINGLE EMPLOYER PLAN (RELATED PARTIES)

As defined in ERISA, Single Employer plans are generally established by the management of one employer (or a controlled group of corporations) either unilaterally or through collective bargaining, and the employer is the plan sponsor. By contrast, multiemployer plans are normally negotiated and established pursuant to a collective bargaining agreement between an associated group of employers, such as in the construction trades, and the union representing the employees. For financial reporting purposes, Star Companies 401(K) Plan is considered a single employer plan which includes the employees of Star Home Entertainment Systems, Inc. and STARSD, Inc. which are affiliated companies.

I - PARTY IN INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence plan management or operating policies. Parties-in-interest are defined under DOL Regulations as any employees of the plan, fiduciaries of the plan, service providers to the plan, the employer whose employees are covered by the plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third party administrator (the TPA), investment managers, investment advisors, legal counsel, and plan auditor.

The plan sponsor pays directly any other fees related to the operation of the plan. Fees incurred by the plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment. During 2024, the plan made direct payments of \$21,746 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA.

J – SUBSEQUENT EVENTS AND DATE OF MANAGEMENT'S REVIEW

The plan administrator has evaluated subsequent events through date of the independent auditor's report, which is the date the financial statements were available to be issued.
