Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

THE BELDEN HOLDING AND ACQUISITION COMPANY 401(k) PLAN

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of The Belden Holding and Acquisition Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit-sharing plan which includes an employees’ savings plan established under the provisions of Internal Revenue Code Section 401(k) and covers all employees of The Belden Brick Company, LLC, Belden Brick Sales and Service, Inc. and Arcitell LLC, (the “Companies”). The plan covers employees who have completed four months of service and are age 18 or older and is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

Contributions

Each year, participants may make salary deferral contributions in any percentage from 1% to 50% of pretax annual compensation, as defined in the Plan. For those plan participants previously covered under the Belden Brick 401(k) Plan and hired after January 1, 2007, the Companies will automatically withhold 3% of compensation as salary deferral unless an alternate deferral amount is elected, or the participant elects not to defer. For all other participants, there will be no automatic deferral. In 2024 and 2023, the Companies made discretionary matching contributions to eligible participants’ deferrals based on a percentage of the participant’s compensation. In addition, the Companies may also make discretionary profit-sharing Plan contributions. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Companies made no profit-sharing contributions in 2024 or 2023.

Participant Accounts

Each participant’s profit-sharing account is credited with an allocation of (a) the Companies’ profit-sharing contribution, (b) Plan earnings and (c) forfeitures of terminated participants’ nonvested accounts. Each participant’s 401(k) account is credited with an allocation of (a) the participant’s salary deferral contribution, (b) the employer matching contribution and (c) plan earnings. Any forfeitures derived from employer matching contributions can be used to pay plan administrative expenses or reduce employer matching contributions in the current or future plan years. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Participants' Investment Options

Participants must direct their salary deferral contributions and all matching and profit-sharing contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via direct phone access to Fidelity Management Trust Company, or by accessing Fidelity Management Trust Company on-line.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their accounts (the profit-sharing account and the employer matching account) is based on years of continuous service and also on the class of the participant as defined in the Plan agreement.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$165,121 and \$154,929, respectively. Forfeitures have historically not been used to reduce the Plan's administrative expense even though permitted by the Plan document.

Forfeitures related to the profit-sharing portion of the Plan shall be allocated to remaining participants' profit-sharing accounts based on wages.

Forfeitures related to the employer matching portion of the Plan will be used to reduce employer matching contributions. During the years ended December 31, 2024 and 2023, respectively, amounts totaling \$82,128 and \$62,182 were used to reduce employer matching contributions.

Participant Loans

Participants may borrow from their retirement accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the participant's investment funds from (to) the participant notes fund. Loan terms range from 1 – 5 years. The loans are secured by the balance in the participant's account and bear interest at current prevailing interest rates as defined in the plan agreement. Principal and interest are paid ratably through payroll deductions.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

Payments of Benefits

In the event of a mandatory distribution greater than \$1,000 that is made in accordance with the provisions of the Plan providing for an automatic distribution to a Participant without the Participant's consent, if the Participant does not elect to have such distribution paid directly to an "eligible retirement plan" specified by the Participant in a direct rollover or to receive the distribution directly, then the Administrator shall pay the distribution in a direct rollover to an individual retirement plan designated by the Administrator.

A participant whose vested account balance exceeds \$5,000 may elect to receive either (1) a lump-sum amount equal to the value of his or her account or (2) installment payments over a specified term or (3) partial withdrawal.

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025 the date which the financial statements were available to be issued.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions Receivable

Employer profit-sharing contributions, employer matching contributions and participant salary deferral contributions are recorded as additions to net assets available for benefits during the Plan year for which they are due. Rollovers are recorded as additions to net assets when received.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Plan expenses paid by the Company amounted to \$57,766 for the Plan year ended December 31, 2024.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE C - FAIR VALUE MEASUREMENTS (CONTINUED)

FASB ASC 820, Fair Value Disclosures, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices.

Level 2 Fair Value Measurements

The fair value of investments in bank and investment house common/collective investment trusts for which quoted market price are not available are reported at the value reported to the Plan by those entities. Funds are invested in financial instruments issued by highly rated companies. These include guaranteed investment contracts (GICs), security backed contracts (synthetic GICs) and cash equivalents.

Level 3 Fair Value Measurements

There were no plan investments subject to Level 3 fair value measurements. This category would include investments that are not actively traded, and significant other observable inputs are not available.

NOTE D - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments in 2024 and 2023 were shares of mutual funds managed by affiliates of Fidelity Investments, who sponsored the 401(k) Plan and provided investment services, recordkeeping, and administrative support to the Plan and the Plan A administrator for the respective years.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE F - INFORMATION CERTIFIED BY THE PLAN TRUSTEE

Fidelity Management Trust Company certified the following information included in the 2024 and 2023 financial statements and supplemental schedules:

- Investments, including fair value, investment transactions, and related information.
- Investment income, including net unrealized appreciation (depreciation) in fair value of investments, net realized gains (losses) from sale of securities, and interest and dividend income.
- Form 5500, Schedule H, 4(i) – schedule of assets held for investment purposes.

NOTE G - TAX STATUS AND INFORMATION REGARDING DETERMINATION LETTER

Effective July 1, 2015, the Plan sponsor adopted a non-standardized form of a volume submitter plan sponsored by Fidelity Management Trust Company. The prototype plan has received an opinion letter dated June 30, 2020 as to the volume submitter plan's qualified status.

The volume submitter plan opinion letters have been relied upon by this Plan. The Plan Administrator does not plan to submit an application for determination for its adoption of such volume submitter plans. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

NOTE H - RISK AND UNCERTAINTY

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statements of net assets available for benefits.
