Independent Auditor's Report

Opinion

Notes To Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following brief description of Geo-Hydro Engineers (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1983, is a defined contribution employee benefit plan covering all employees who have attained age 21 and completed three months of service. Employees may become participants in the Plan on the first day of the Plan year quarter coinciding with or next following date the eligibility requirements are met. Each Plan year begins on January 1. The employer, as defined by the Plan, is Geo-Hydro Engineers, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

Administration of the Plan is vested in the Company who may appoint a plan administrator. The investment advisor for the Plan is OneDigital Investment Advisors, LLC and the trustee is Geo-Hydro Engineers, Inc. A trust agreement provides for the investment of trust funds and prescribes the powers, duties, obligations, and functions of the Trustee. T. Rowe Price is the recordkeeper.

Contributions

The Plan is a contributory plan whereby an employee who elects to participate may contribute a maximum of 90 percent of their annual compensation as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan is a safe harbor plan. The Employer matches 100 percent of the first 3 percent of eligible wages and 50 percent of the next 2 percent of eligible wages not to exceed 5 percent of eligible wages. Participants direct the investment of their contributions and the employer's contribution into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated target fund until changed by the participant.

The Plan records employer and employee contributions receivable when compensation is paid. No allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contributions, if any, an allocation of fund earnings and charged with an allocation of administrative expenses. Fund earnings are allocated based on participant earnings or account balances as defined in the Plan. The benefit to which a participant is entitled is the total amount that can be provided from the participant's account.

Vesting

Plan participants are immediately vested in their contributions, Company safe harbor matching contributions and all earnings allocated to their accounts. Plan participants are on a 6 year vesting schedule for all other employer contributions being 20 percent vested after 2 years and gaining 20 percent more each year until fully vested after 6 years.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Benefit payments for death, disability, or retirement begin as soon as administratively possible. Payments for required minimum distributions may be deferred until the first day of April following the calendar year in which a participant reaches age 70 1/2 or retires except that distributions to a 5 percent owner of the employer must commence by the first day of April following the calendar year in which the participant reaches age 70 1/2. A participant who has reached age 59 1/2 may, upon their request, begin to receive their retirement benefits before their actual retirement. For termination of service for other reasons, a participant may receive the value of the vested interest of their account as a lump sum distribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the Trustee, Geo-Hydro Engineers, Inc. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to participant contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments and administrative expenses.

Under the terms of the Plan, administrative expenses may be paid by the Company. If not paid by the Company, the expenses shall become a liability of the Plan. The Company, however, may reimburse the Plan for any administrative expenses incurred, and such reimbursement shall not be considered as an employer contribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management performed an evaluation of subsequent events through October 2, 2025, the date these financial statements were available to be issued.

NOTE 3. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are shares of investment funds managed by T. Rowe Price. T. Rowe Price is the recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for record keeping services are included in net appreciation in fair value of investments and administrative expenses.

NOTE 4. PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 5. TAX STATUS OF THE PLAN

The Company has adopted a Volume Submitter 401(k) Profit Sharing Plan. The volume submitter plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the volume submitted plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC and, therefore, the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7.**FAIR VALUE MEASUREMENTS (CONTINUED)**

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
