**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of ELC of Duval 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Opinion**

**NOTE A – DESCRIPTION OF PLAN**

The following description of ELC of Duval 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s Provisions.

1. General

The Plan was formed January 1, 2024. The Plan is a 401 (k) profit-sharing plan, covering substantially all employees of Early Learning Coalition of Duval (the “Organization”). Employees are eligible to participate in the Plan and receive employer contributions on the date the employee attains the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

2. Contributions

Participants may elect to defer up to 90 percent pre-tax and 50 percent Roth contributions of total compensation each year up to the maximum allowed by law, which was \$23,000 in 2024. Participants who are age 50 or older may make catch-up contributions up to \$7,500 in 2024. Participants, with the consent of the Plan, may make rollover contributions from another qualified plan to the Plan.

The Plan elected to have automatic enrollment for eligible participants. All eligible employees are automatically enrolled in the Plan with pre-tax deferral rate of 2% of their total compensation. If a participant wishes to change deferral percentage or type, they can log into their account on the Human Interest website and make the changes, including electing to opt out of participation.

The Organization makes matching safe-harbor contributions on the participant’s behalf if the participant makes an elective employee contribution or catch-up contribution during the plan year. During 2024, the Organization’s matched participant contributions dollar for dollar up to 4%. Any participant who is employed by the Organization and attains the age of 18 during the plan year shall be eligible for the matching contributions.

The Organization may also make annual discretionary profit-sharing contributions on the participant's behalf as determined by the Board of Directors. To receive such employer profit sharing contributions, employees must be at least 18 years of age and be employed by the Organization. For 2024, the Organization’s Board of Directors elected not to make a discretionary profit-sharing contribution to the Plan.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Organization's contributions, (b) the Organization’s profit-sharing contributions, and (c) Plan earnings or losses. Allocations are based on participant contributions, earnings on participant account balances, as defined in the plan document. The benefit in which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

4. Vesting and Forfeitures

Participants are immediately vested in their own contributions and earnings and losses thereon. Participants vest 20% per year at the end of each year of service, starting after two years of service in the Organization's non-elective contributions, plus any related earnings or losses thereon. After six years of service, participants are fully vested in the Organization's non-elective contributions. Full vesting also occurs in the event of retirement, death or disability.

Forfeitures shall be used to pay any administrative expenses of the Plan and any remaining forfeitures will be used to reduce employer contributions. There were no forfeitures available at December 31, 2024.

5. Notes Receivable

Under the Plan provisions, a participant may borrow up to the lesser of 50% of his or her vested account balance or \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, subject to a minimum amount of \$1,000. Participant loans are required to be repaid within five years, and loan repayments shall be made each pay period in accordance with the repayment schedule. Interest is charged at a fixed rate based upon the prevailing prime rate at the time of loan plus one percentage point.

6. Distribution of Benefits

Payment of the participant's entire account balance under the Plan is available only upon retirement, termination of employment, hardship, the attainment of age 65, death or total disability. The only available form of distribution is a lump sum payment. Beneficiaries of participants who die while participating in the Plan, or before all benefits are paid, will be entitled to the entire balance and must be paid out within five years of their death. Furthermore, a partial or installment distribution may be permitted if needed to satisfy the required minimum distribution rules.

Upon attainment of age 59.5 employees may elect to withdraw all or a portion of their entire account balance without penalty while still employed by the Organization.

The Plan's provisions provide for hardship withdrawals for certain qualifying events as more specifically described in the Plan document.

7. Investments

The Plan is participant directed and participants may invest their contributions in any of the investment funds offered by the Plan. The Plan's service administrator during 2024 was Human Interest, Inc.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting.

2. Payment of Benefits

Benefits are recorded when paid.

3. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates and assumptions.

4. Investment Valuation and Income Recognition

The Plan follows the fair value measurement requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in an orderly transaction between market participants. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

6. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

7. Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025 the date the financial statements were available to be issued.

**NOTE C – FAIR VALUE MEASUREMENTS**

FASB ASC 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: The investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024, the Plan's participant-directed investments measured at fair value on a recurring basis by the fair value hierarchy levels described above are as follows:

**NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments at December 31, 2024 included shares of registered investment company funds managed by Matrix Trust Company. Matrix Trust Company is the custodian of the Plan, and Human Interest Inc. (the “TPA”) provides investment advisory and bookkeeping services to the Plan; transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan to the custodian and TPA for administration and investment advisory services were \$3,742 for the year ended December 31, 2024.

**NOTE F – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes of risk associated with certain investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE G – PLAN TERMINATION**

It is the intention of the Organization to continue the Plan; however, the Organization has the right to terminate the Plan at any time, subject to the provisions and penalties set forth by ERISA and the Internal Revenue Code. In the event of plan termination, participants would become 100% vested in the Organization’s contributions.

**NOTE H – TAX STATUS**

The Plan has adopted a standardized form of a volume submitter prototype plan sponsored by Matrix Trust Company. The volume submitter prototype plan has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service (IRS) as to the volume submitter prototype plan’s qualified status. The volume submitter prototype plan opinion letter has been relied upon by the Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that are more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
