Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Tempur Sealy 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Tempur Sealy 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General Information

The Plan is a defined contribution plan established to provide retirement benefits to eligible employees of the Company, as defined below. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Participating entities of the Plan are Tempur Sealy International, Inc., Tempur-Pedic Management, LLC, Tempur Production USA, LLC, Tempur Retail Stores, LLC, Tempur-Pedic North America, LLC, Tempur-Pedic Technologies, Inc., The Ohio Mattress Company Licensing and Components Group, Inc. (formerly known as Sealy, Incorporated), Sealy Mattress Manufacturing Company, Inc., Sealy Technology LLC, Sealy Mattress Company of Puerto Rico, Sealy, Inc., Burlington Mattress LLC, Comfort Revolution LLC, and K.B. & Associates, Inc. dba Mattress Warehouse (collectively referred to as the “Company” or “Employer”).

Plan Administrator and Sponsor

Tempur-Pedic Management, LLC, the plan administrator and sponsor, is a subsidiary of Tempur Sealy International, Inc.

Eligibility

The Plan covers all employees of the Company who have attained age 18, except union, leased, non-resident individuals, those employed by an affiliate that has not adopted the Plan, and independent contractors. Eligible employees may enter the Plan immediately following their date of hire. Participants are eligible for the Company safe-harbor matching contributions after completion of six months of service. Participants are eligible for the Company discretionary matching contribution if they contributed to the Plan and are employed on the last day of the year.

Contributions

Participants may elect to contribute from 1% to 85% of their compensation (as defined by the Plan) on a pre-tax and/or after-tax (“Roth”) basis, not to exceed the annual maximum limit established by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants are also allowed to contribute amounts representing distributions from other qualified plans (“rollovers”).

The Company makes safe-harbor matching contributions equal to 100% of the first 3% plus 50% of the next 2% of compensation each participant contributes to the Plan. The Company may also make an additional discretionary matching contribution to the Plan, as determined by the Company, not to exceed 3% of eligible compensation. The discretionary matching contribution is allocated to participant accounts based upon the percentage of each participant’s compensation relative to the total compensation of all eligible participants. However, no discretionary matching contribution was made for 2024.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time. Participants may also invest in a Self-Directed Brokerage Account (“SDBA”) through interfund transfers only; direct employee contributions are not permitted.

NOTE 1 – DESCRIPTION OF PLAN (CONCLUDED)

Participant Accounts

Each participant's account is credited with the participant's and the Company's contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based upon participant contributions, earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants hired on or after January 1, 2014, are generally immediately vested in all contributions plus earnings thereon. However, participants of the former Sealy Profit Sharing Plan that were terminated prior to January 1, 2014, are subject to vesting of that plan, which was 20% after two years of service and an additional 20% each year until completing six years of service. In addition, participants of the former K.B. & Associates, Inc. dba Mattress Warehouse 401(k) Profit Sharing Plan ("Mattress Warehouse Plan") are subject to vesting in the historical matching and profit sharing contributions of that plan, which was also 20% after two years of service and an additional 20% each year until completing six years of service.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, participants may elect to receive a lump-sum or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may only have one note outstanding at a time. Generally, the term of the note may not exceed five years. However, if the note is for the purchase of a participant's principal residence, the plan administrator may permit up to 10 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. This interest rate changed to prime plus 1% effective July 2024. Principal and interest are repaid ratably through payroll deductions.

Forfeitures

Forfeitures primarily relate to the former Sealy Profit Sharing Plan and the former Mattress Warehouse Plan. Forfeitures may be used to pay administrative expenses or offset Company matching contributions. Forfeitures of approximately \$614,000 were utilized during 2024 to offset Company matching contributions. Approximately \$123,000 and \$311,000 in forfeited non-vested accounts were available at December 31, 2024 and 2023.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as trustee and recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution and notes receivable fees are paid out of affected participants' accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 13, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

NOTE 3 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower") and Principal Trust Company ("Principal"), the respective trustees of the Plan.

NOTE 4 – RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with such investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 – INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated July 6, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants’ accounts will become fully vested and nonforfeitable.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Effective July 2024, the Plan changed its combined trustee and recordkeeper service provider from Principal to Empower. Fees paid by the Plan to Empower for trustee and recordkeeping services were approximately \$57,000 in 2024. Fees paid by the Plan to Principal for trustee and recordkeeping services were approximately \$112,000 in 2024.

Fees paid by the Plan for advisory services and other professional fees were approximately \$4,000 for 2024.

NOTE 8 – FAIR VALUE MEASUREMENTS

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, held in the fund, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

NOTE 8 – FAIR VALUE MEASUREMENTS (CONCLUDED)

Self-directed brokerage accounts: Comprised primarily of mutual funds, money market funds, and common stocks. Mutual funds and money market funds are valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market. Common stocks are valued at the closing price reported on the active market on which the securities are traded. These investments are classified as Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
