## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, I:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. My audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 - Description of the Plan

The following description of HubSpot Inc. 401(k) Profit Sharing Plan & Trust, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of HubSpot Inc. (the Company) that are eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pretax, Roth, and after-tax contributions from zero to ninety-six percent of their compensation as defined by the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatic enrollment participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Auto-enrollment starts 30 days after date of hire and increases 1% per year to a maximum of 10% unless employee affirmatively elects otherwise. The Plan includes in-plan Roth conversions of after-tax contributions for eligible participants that want to convert after-tax contributions into Roth contributions.

The Company made matching contributions of 50% of the total employee's contributions for the contribution period not to exceed \$5,000 and \$2,500 for the years ended December 31, 2024 and 2023 respectively. The Company may, at its discretion, make a profit sharing contribution. The profit sharing contribution, if made, is the ratio that each qualifying participant's compensation for the plan year bears to the total compensation of all qualifying participants for the plan year. Participants are eligible after completing one year of service at the Company. No profit sharing contributions were made in 2024 or 2023.

Participant Accounts

Participants' accounts are credited with their contributions, the Company's matching contribution and an allocation of Plan earnings, and if applicable are charged with loan set-up fees. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching contribution portion of the participants' accounts plus actual earnings thereon occurs as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly or semi-monthly payroll deductions.

#### Payment of Benefits

Participants may receive benefits the first day of the month on or after the date they reach age 65. Participants age 59 ½ or older may withdraw all or part of their account resulting from 401(k) elective deferral contributions and extra contributions. Distributions may be deferred until the participant reaches age 70 ½ if the value of the distribution is not less than \$5,000. However, if no distribution election is made before the age of 70 ½, the participant will begin to receive a mandatory minimum distribution as required by Federal Regulations. In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

#### Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. During the year ended December 31, 2024, forfeitures in the amount of \$210,297 were used to reduce Company contributions. The forfeiture balance at December 31, 2024 and 2023 totaled \$25,416 and \$16,941 respectively.

### Note 2 - Summary of Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires that Plan management make estimates that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### Note 2 - Summary of Accounting Policies (continued)

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan employs a fixed-basis point arrangement with revenue pass-back on the fund level. All recordkeeping revenue is passed back to the funds and participants that generate it. Then on a quarterly basis, the Plan assesses a 2 ½ basis point fee to all participants. Total fees generated by the Plan for year ended December 31, 2024 is \$460,503 while total revenue pass-back to the funds and participants is \$742,753. Both balances are listed on the Statement of Changes in Net Assets Available for Benefits for the year ending December 31, 2024.

### Note 3 - Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, net depreciation in fair value of mutual funds, and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

*Mutual funds:* Valued at the net assets value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Rollover Contributions

An aggregate of \$18,194,247 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the statement of changes in net assets available for benefits.

Note 6 - Related-Party Transactions

Fidelity Management Trust Company is the recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. In addition, certain officers and employees of the Company are administrators of the Plan and are participants in the Plan.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the company contribution of their account.

Note 8 - Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8 - Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Description of the Plan

The following description of HubSpot Inc. 401(k) Profit Sharing Plan & Trust, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of HubSpot Inc. (the Company) that are eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pretax, Roth, and after-tax contributions from zero to ninety-six percent of their compensation as defined by the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatic enrollment participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Auto-enrollment starts 30 days after date of hire and increases 1% per year to a maximum of 10% unless employee affirmatively elects otherwise. The Plan includes in-plan Roth conversions of after-tax contributions for eligible participants that want to convert after-tax contributions into Roth contributions.

The Company made matching contributions of 50% of the total employee's contributions for the contribution period not to exceed \$5,000 and \$2,500 for the years ended December 31, 2024 and 2023 respectively. The Company may, at its discretion, make a profit sharing contribution. The profit sharing contribution, if made, is the ratio that each qualifying participant's compensation for the plan year bears to the total compensation of all qualifying participants for the plan year. Participants are eligible after completing one year of service at the Company. No profit sharing contributions were made in 2024 or 2023.

Participant Accounts

Participants' accounts are credited with their contributions, the Company's matching contribution and an allocation of Plan earnings, and if applicable are charged with loan set-up fees. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching contribution portion of the participants' accounts plus actual earnings thereon occurs as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly or semi-monthly payroll deductions.

#### Payment of Benefits

Participants may receive benefits the first day of the month on or after the date they reach age 65. Participants age 59 ½ or older may withdraw all or part of their account resulting from 401(k) elective deferral contributions and extra contributions. Distributions may be deferred until the participant reaches age 70 ½ if the value of the distribution is not less than \$5,000. However, if no distribution election is made before the age of 70 ½, the participant will begin to receive a mandatory minimum distribution as required by Federal Regulations. In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

#### Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. During the year ended December 31, 2024, forfeitures in the amount of \$210,297 were used to reduce Company contributions. The forfeiture balance at December 31, 2024 and 2023 totaled \$25,416 and \$16,941 respectively.

### Note 2 - Summary of Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires that Plan management make estimates that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### Note 2 - Summary of Accounting Policies (continued)

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan employs a fixed-basis point arrangement with revenue pass-back on the fund level. All recordkeeping revenue is passed back to the funds and participants that generate it. Then on a quarterly basis, the Plan assesses a 2 ½ basis point fee to all participants. Total fees generated by the Plan for year ended December 31, 2024 is \$460,503 while total revenue pass-back to the funds and participants is \$742,753. Both balances are listed on the Statement of Changes in Net Assets Available for Benefits for the year ending December 31, 2024.

### Note 3 - Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, net depreciation in fair value of mutual funds, and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

*Mutual funds:* Valued at the net assets value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Rollover Contributions

An aggregate of \$18,194,247 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the statement of changes in net assets available for benefits.

Note 6 - Related-Party Transactions

Fidelity Management Trust Company is the recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. In addition, certain officers and employees of the Company are administrators of the Plan and are participants in the Plan.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the company contribution of their account.

Note 8 - Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8 - Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
