Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other matter - supplemental schedules required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE A - DESCRIPTION OF STATEMENTS OF NET ASSETS AVAILABLE FOR BENEFITS,  
STATEMENT OF CHANGES IN NET ASSETS AVAILABLE FOR BENEFITS**

The following brief description of The Pennsylvania Horticultural Society Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a 403(b) defined contribution retirement plan covering certain employees of The Pennsylvania Horticultural Society (the Society or Plan Sponsor). Plan participants must be 21 years of age or older and employed by the Society for at least one year in order to become eligible to receive the employer contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective May 4, 2019, the Plan was amended to accept the employees of Meadowbrook Farm into the Plan. The service requirement was waived for otherwise eligible employees.

Effective January 1, 2024, the Plan was amended to include optional items as permitted under the SECURE Act 2.0. The amendment allows for penalty-free withdrawals and enhanced loan options for individuals affected by federally declared disasters. For 403(b) hardship withdrawals participants may withdraw any part of their vested account and earnings from Elective Deferral, Qualified Matching and Qualified Nonelective Contributions. Additionally, participants may now take one annual emergency personal expense withdrawal up to \$1,000 and may access penalty-free distributions in cases of domestic abuse.

***Contributions***

Each year, participants may elect to defer a percentage of pretax annual compensation subject to certain Internal Revenue Code (IRC) limitations. All participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in addition to the statutory limit. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are eligible to make elective deferral contributions on the first day of the month following their date of hire.

The Society contributes 4% of each eligible participant's compensation for the Plan year, as defined. A discretionary contribution can also be made by the Society to the Plan. Participants have the ability to direct the Society's contributions to various investment options at any time. Contributions are subject to certain limitations. An employee is eligible to receive employer contributions after one year of employment. There were no discretionary contributions made during the year ended December 31, 2024.

The Plan offers a Roth elective deferral option to all participants who are eligible to make elective deferral contributions. Additionally, the Plan provides for automatic enrollments of participants. The automatic elective deferral contributions shall be a 6% pre-tax elective deferral contribution, unless otherwise elected. Participants with a deferral rate greater than zero will have that deferral increased annually on January 1, by 1% until a deferral rate of 10% is reached, unless otherwise elected.

***Participant Accounts***

Each participant's account is credited or charged as applicable, with the participant's contribution and allocations of (a) the Society's contribution and (b) the Plan's earnings and losses and charges for loan fees, where applicable. Allocations are made based on participant's earnings and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

All participants are immediately vested in their contributions and the employer non-elective contributions plus actual earnings thereon. Participants become vested in the Society's discretionary contributions and earnings thereon over the following vesting period:

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the value of the vested balance of the participant's account. Terms of the note may not extend beyond five years except notes for the purchase of a home. Participants may have a maximum of one loan outstanding at any time. Repayments of principal and interest are paid through equal payroll deductions over the life of the note. Interest rates are based on rates currently being charged by commercial lenders for loans of comparable risk on similar terms and durations. Interest rates ranged from 5.25% to 10.50% as of December 31, 2024 and were 5.25% to 10.25% as of December 31, 2023.

***Benefits Paid to Participants***

The Plan provides that under certain conditions, participants may withdraw their vested benefit. A participant is entitled to receive the vested portion of his or her account in a lump-sum distribution, annuity or in monthly installments, under the conditions described in the Plan document, in the event of retirement, termination, hardship, death or reaching age 59½ as an active employee. Upon the death of a participant, the remaining portion of the benefit will be distributed to the beneficiary using the same payment method elected by the participant. Participants are also permitted to make hardship withdrawals from their elective deferral source accounts in certain cases of immediate and heavy financial need. Per Internal Revenue Service (IRS) regulations, participants are required to take a Required Minimum Distribution (RMD) by April 1 of the year following the later of the year they reach age 73 or the year in which they have a severance from employment.

***Forfeitures***

Forfeitures resulting from the nonvested portion of employer contributions may be used to pay administrative expenses or to reduce the Society's contributions. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated to participants' accounts and deemed to be employer contributions. There were no forfeiture balances at December 31, 2024 and 2023. In 2024, there were no forfeited, nonvested accounts used to reduce the Society's contributions to the Plan.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Plan Sponsor. Loan processing and distribution fees are paid by the participants. Management fees and operating expenses charged to the Plan are deducted from investment income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Benefits Paid to Participants***

Benefit payments are recorded when paid.

**NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), the custodian of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to information certified by the custodian, except for comparing such information to the related information included in the above named financial statements and supplemental schedule.

**NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable and market-corroborated inputs which are derived principally from or corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

***Level 1 - Fair Value Measurements***

Mutual Funds:

The fair values of mutual funds are based on net asset values quoted on nationally recognized securities exchanges.

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the Plan's financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PARTIES-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by the custodian or its affiliates and, therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year). Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

Notes receivable from participants also qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).

**NOTE F - TAX STATUS**

The Plan adopted a prototype non-standardized 403(b) plan sponsored by Principal Trust Company. The prototype non-standardized 403(b) plan has received an opinion letter dated May 5, 2015, from the IRS as to the prototype non-standardized 403(b) plan's qualified status. The prototype non-standardized 403(b) plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provision of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no material uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - ADMINISTRATION OF THE PLAN**

Certain administrative functions of the Plan are performed by employees of the Society. No such employee receives compensation from the Plan.

Principal Trust Company serves as the custodian and recordkeeper of the Plan.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks such as interest rate, market, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued and determined that there were no circumstances that warranted recognition or disclosure of those events or transactions in the financial statements as of December 31, 2024.
