Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Yokohama Tire Corporation Salaried Employees' Retirement and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Yokohama Tire Corporation Salaried Employees' Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Yokohama Tire Corporation Salaried Employees' Retirement and Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 – Plan Description

The following description of Yokohama Tire Corporation Salaried Employees' Retirement and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all nonunion employees of Yokohama Tire Corporation (the "Company"), Yokohama Tire Manufacturing of Virginia, LLC; Yokohama Tire Manufacturing of Mississippi, LLC; and Yokohama Corporation of North America. Yokohama Tire Manufacturing of Mississippi became an adopting employer of the Plan on September 1, 2013, Yokohama Tire Manufacturing of Virginia, LLC became an adopting employer on January 1, 2014, and Yokohama Corporation of North America became an adopting employer on January 1, 2015. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute from 1% to 50% of annual compensation as pre-tax or Roth, as defined in the Plan. The Plan provides for automatic enrollment of all newly eligible employees at an initial pre-tax deferral contribution of 6%. In addition, the deferral rate will automatically increase on an annual basis, until the deferral rate reaches 10%. Participants may also contribute up to 6% of compensation after-tax; however, the pretax and after-tax combined amount cannot exceed 50% of compensation. The Company contributes 50% of the participant's elective pre-tax deferral up to an annual maximum of 6% of compensation. The Company must make a safe-harbor non-elective contribution of 3% and may make additional discretionary contributions. During the Plan years ended December 31, 2024 and 2023, the Company made discretionary contributions of 2%. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, and allocations of Plan earnings and administrative fees. Forfeited balances of terminated participants' non-vested accounts are used to reduce expenses and future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to the maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one year to five years. Loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Interest rates on loans at December 31, 2024 ranged between 4.25% to 9.50%. Principal and interest are repaid through payroll deductions.

Payment of Benefits

Upon retirement, death, disability, or termination, a participant will generally receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows partial distributions.

Administrative Costs

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$298,786 and \$119,862, respectively. A total of \$39,867 and \$23,326 were applied to expenses during the years ended December 31, 2024 and 2023, respectively. A total of \$98,300 and \$373,425 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Interest-Bearing Cash

The Plan's investment in the self-directed account includes interest-bearing cash. At December 31, 2024, interest-bearing cash also includes certificates of deposit. For the years ended December 31, 2024 and 2023, cash was \$302,680 and \$435,154, respectively. At times these amounts may exceed federally insured limits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Galliard Stable Return Fund C is a collective investment trust fund owned at December 31, 2024 and 2023. This investment is composed primarily of investment contracts and security-backed contracts and is valued at the net asset value of units of the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Note 4 – Investment Contracts

The Plan has investments in the Galliard Stable Return Fund C. The fund primarily invests in investment contracts and security-backed contracts issued by insurance companies and other financial institutions. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for these funds was approximately 4.88% and 4.92% for 2024 and 2023, respectively. The yield earned by the funds with an adjustment to reflect the actual interest rate credited to participants at December 31, 2024 and 2023 was 3.35% and 2.93%, respectively.

The objective of the fund is to provide investors with a moderate level of stable income without principal volatility. However, there is no assurance that this objective will be achieved.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held and managed by the Plan Trustee. Investments in funds issued and managed by the Trustee are considered related party transactions. Fees paid by the Plan to the Trustee for investment management and record-keeping services for 2024 and 2023 were \$130,462 and \$115,548, respectively. Administrative expenses are reported net of revenue sharing of \$80,109 and \$93,074 for 2024 and 2023, respectively.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Participants would receive a lump-sum distribution as soon as practical after the date of Plan termination.

Note 7 – Tax Status

The Company has adopted a non-standardized pre-approved profit-sharing plan sponsored by the Trustee. The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
