## Independent Auditor's Report

To the Fiduciaries and Plan Administrator  
La Clínica del Pueblo, Inc. 403(b) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of La Clínica del Pueblo, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the La Clínica del Pueblo, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan pursuant to the provisions of Section 403(b) of the Internal Revenue Code (the Code) established for the benefit of all employees in the Plan. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). A complete description of the Plan is contained in the Plan Document and Adoption Agreement, which governs the operation of the Plan.

*Eligibility*

An employee is eligible to participate in the Plan upon date of hire provided that they normally complete more than 20 hours of work per week and have attained a minimum age of 21.

*Contributions*

Each year participants may contribute pre-tax compensation subject to the limits established by the Code. As a result of the Economic Growth and Tax Relief Reconciliation Act of 2001 participants expected to reach age 50 or older during the calendar year may make an additional "catch up" contribution. Participants entering the Plan may roll over contributions from other plans. In addition, the Plan allows employees with at least 15 years of service to make additional elective deferrals in accordance with the plan documents.

La Clínica del Pueblo, Inc. (LCDP) may make discretionary employer matching contributions to all eligible compensation for all participants. For the year ended December 31, 2024, there were no discretionary employer matching contributions made.

LCDP may also make discretionary employer nonelective contributions to all eligible compensation for all participants. Effective January 1, 2020, the Plan was amended for discretionary employer contributions to be paid to employees working more than 20 but less than 30 hours per week at a rate of \$12.50 per pay period and employees working more than 30 hours per week at a rate of \$25.00 per pay period. For the year ended December 31, 2024, the discretionary employer nonelective contributions approved were 2% of eligible compensation.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and allocation of (i) LCDP's matching and discretionary contributions and (ii) Plan earnings and charged with an allocation of administrative expenses. The investment options available to participants include mutual funds, money market funds, or an insurance company general account.

*Vesting*

Participants are fully vested in their participant salary deferral accounts at all times. LCDP's matching and discretionary contributions are 100% vested after one year of service.

1. DESCRIPTION OF THE PLAN (CONTINUED)

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance. Participants may only have two loans outstanding at a time and all loans must be repaid within five years. The loans are secured by 50% of the participant's vested account balance and bear interest at the prime interest rate, as published in the *Wall Street Journal*, plus 2%.

*Benefit Payments*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum, partial lump-sum, installment distributions equal to the value of the participant's vested interest in the account, or distribution via a monthly annuity option. A participant whose vested balance is \$5,000 or less will receive a lump-sum distribution. A participant experiencing serious financial hardship may, with sufficient evidence, withdraw the portion of their vested account balance. The amount of the withdrawal may not be greater than the immediate financial need.

*Field Assistance Bulletin (FAB) 2009-02*

On July 20, 2009, the Employee Benefits Security Administration issued Field Assistance Bulletin (FAB) 2009-02, addressing the application of certain Form 5500 and Form 5500-SF annual reporting requirements to tax-sheltered annuity programs described in Section 403(b) of the Internal Revenue Code [403(b) plans]. FAB stated that, for purposes of the Plan's annual reporting and related audit requirements, an annuity contract or custodial account does not need to be treated as part of the Plan or as plan assets if it meets the certain conditions.

Accordingly, some 403(b) plans excluded certain accounts, including investment income and distributions. It was determined that La Clínica del Pueblo, Inc. 403(b) Plan does not exclude any annuity contracts nor custodial accounts and the related income and distributions in the accompanying financial statements.

*Forfeited Accounts*

As of December 31, 2024 and 2023, the forfeited non-vested account totaled \$60 and \$1, respectively. Forfeited accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, forfeitures totaling \$2,946 were used to reduce employer contributions.

*Administrative Expenses*

A portion of the administrative expenses and other fees are paid out of the Plan's assets. LCDP pays the remaining expenses of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and the disclosures. Accordingly, actual results may differ from those estimates.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset values of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

**3. INFORMATION CERTIFIED BY CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Act of 1974. The Plan's custodians, Lincoln National Life Insurance Company (Lincoln) and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), have certified that the following data included in the accompanying financial statements and supplementary schedule are complete and accurate:

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting literature are described as follows:

*Level 1* - inputs to the valuation methodology are unadjusted for quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan participates in a fully benefit-responsive investment contract with Principal Life Insurance Company via an investment in a Fixed Income Guaranteed Option. This is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value Fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Plan is prohibited from assigning or selling the contract to another party without consent of the issuer. The contract provides assurance the crediting rate will not be less than zero. If an event has occurred such that realization of full contract value will not be realized, the contract shall no longer be considered fully benefit-responsive. Participants transact at book value without limit. Equity wash provisions are allowed and do not disqualify a contract's fully benefit-responsiveness. Events that limit the ability of the fund to transact at contract value with the issuer (i.e., plan termination, merger, layoffs, etc.) and that also limit the ability to transact at contract value with participants are not probable of occurring. Participants have reasonable access to their funds.

The Plan entered into a variable annuity account (Variable Account) with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in the Variable Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Variable Account is subject to some restrictions and is considered fully benefit-responsive by management of the Plan. Therefore, the contract is reported at contract value which approximates fair value.

**6. RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by Lincoln and Principal. Lincoln and Principal are the custodians of the Plan and, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the year ended December 31, 2024, amounted to \$5,367. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, LCDP has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. TAX STATUS

The Plan meets the requirements of the Internal Revenue Code (IRC) and ERISA to qualify as exempt from federal income taxes. The Plan uses a Principal Financial Group Prototype Basic 403(b) plan approved by the IRS on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

The Plan's Form 5500, *Annual Return/Report of Employee Benefit Plan*, is open for inspection by the taxing authorities, generally for three years after filing.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
