Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Idealab 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Idealab 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan offered to employees of Idealab and its subsidiaries (the "Company"). The Plan covers all employees of the Company beginning on the date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code ("IRC").

B. Contributions

Participants may contribute from their annual compensation including any Company paid cash bonuses, as defined in the Plan, up to the statutory maximum determined by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company is also permitted to make discretionary matching and profit sharing contributions to the Plan. Since inception, however, the Company has not made any discretionary matching or profit sharing contributions to the Plan.

C. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings, and is charged with certain loan fees incurred by the participant, if any. The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year. Investment earnings and gains and losses are allocated in the relationship each participant's account bears to the balance of all participants' accounts at the beginning of each allocation period.

D. Vesting

Participants are immediately vested in the full value of their account balances, including Company contributions, if any.

E. Benefit Payments

On termination of service, death, disability or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account or may defer receiving his or her vested benefits if the account exceeds the minimum deferral under Section 411(a) of the IRC, as amended. Hardship withdrawals are permitted.

F. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of the vested account balance. Principal and interest are paid ratably through payroll deductions. The interest rate is the prime rate as published in the Wall Street Journal on the

day of the loan request plus 1%. The repayment period for such loans cannot exceed five years unless the proceeds are used to purchase the participant's principal residence, in which case longer terms are allowed.

The loans are primarily secured by 50% of the present value of a participant's vested interest in the Plan. In addition, the custodian of the Plan may accept other collateral that it deems to have value and liquidity. Interest rate of notes receivable range from 5.75% to 9.50% at December 31, 2024.

G. Forfeiture of Benefits

Any portion of a participant's account that is not vested shall be forfeited upon distribution of the vested portion. Forfeitures shall be used to pay administrative expenses and then to reduce Company matching contributions. As of December 31, 2024 and 2023, \$4,159 and \$4,101 were held in the Plan's forfeiture account, respectively.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP).

B. Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

In accordance with ASC 820, common/collective trusts are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares. The fair value amounts presented in the preceding tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Level 1 investments consist of mutual funds valued at their quoted market prices. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Administrative Fees

Substantially all expenses incurred in the administration of the Plan are paid by the Company, the Plan's sponsor. The Plan does not reimburse the Company for these expenses.

F. Risks and Uncertainties

Plan investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts to be reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 - INVESTMENT CONTRACTS

The guaranteed certificate funds (“contracts”) that participants may invest in are 7-year contracts with their own unique interest rates, which last one calendar quarter. The custodian maintains the contributions in the Company’s general funds. The contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value which approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their matured contract at contract value. Maturing contracts that are not redirected into another investment option will automatically roll into another certificate with the same maturity at the current rate of interest.

There are no reserves charged against the contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rates were approximately 1.41% and 1.23% for 2024 and 2023, respectively. Such rates are reviewed on a quarterly basis for resetting.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA.

NOTE 6 - INCOME TAX STATUS

The Plan has not received a determination letter from the Internal Revenue Service. However, the underlying volume submitter profit sharing plan document has received an opinion letter dated June 30, 2020 from the Internal Revenue Service on the form of the plan indicating that the volume submitter profit sharing plan, if properly adopted by the Company, could be exempt from federal income taxes under the IRC. Management believes that the Plan is operating in accordance with regulations for plans exempt from income taxes and that the Plan is exempt from taxes.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

The Company and the custodian may be deemed to be a party-in-interest under the guidelines of ERISA. The Company is the plan administrator and provides certain administrative services at no cost to the Plan. Certain Plan investments represent guaranteed investment contracts managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the Plan, and, therefore, these transactions qualify as party-in-interest transactions, for which a statutory exemption exists.
