### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Universal Leaf Tobacco Company, Inc. 401(k) Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements are comprised of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1—Description of the Plan**

The following description of the Universal Leaf Tobacco Company, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan, effective July 1, 1994, is a defined contribution plan covering substantially all salaried and hourly employees of Universal Leaf Tobacco Company, Inc. and certain designated affiliated companies (collectively, the “Company” or “Employer” or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), and Sections 401(a) and 501(a) of the Internal Revenue Code (“IRC”) of 1986, as amended.

*Administration* – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Participant Contributions* – Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, subject to maximum contribution limits established under the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions within IRC limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2018, the Plan includes an auto enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation.

*Employer Contributions* – The Company provides a safe harbor matching contribution of 100% of the first 5% of base compensation that a participant contributes to the Plan. Additional non-elective contributions may be made at the discretion of the Company. The Company made no non-elective contributions to the Plan for the years ended December 31, 2024 and 2023.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions and an allocation of Company contributions and Plan earnings or losses and charged with benefit payments and an allocation of any administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested accounts.

*Vesting* – Participants are fully vested in their employee contributions, Employer safe harbor matching contributions, and any rollover contributions. Participants become fully vested in the non-elective contributions after three or more years of vesting service (0% vested if less than three years). A participant will also become fully vested upon attainment of normal retirement age while an employee, death while an employee, or becoming disabled while an employee. A “Year of Vesting Service” is a period in which more than 1,000 hours of service are completed during the Plan year.

*Investments Options* – Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment elections at any time.

*Notes Receivable from Participants* – Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant’s account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Note 1—Description of the Plan (continued)**

*Payment of Benefits* – Upon termination of service, retirement, death, or disability, attainment of age 59½, or an approved financial hardship withdrawal, a participant may elect to receive a distribution of the vested portion of the participant’s account. The account will be distributed in a lump-sum payment, annuity payments, or installment payments in an amount equal to the vested value of their account as defined by the Plan. At December 31, 2024 and 2023, there were no benefit payments that had been requested but not yet paid.

*Forfeitures* – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15 and \$1, respectively. Per the Plan document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the years ended December 31, 2024 and 2023, \$22 and \$11,281, respectively, were used to pay Plan expenses and \$79,553 and \$40,407, respectively, were used to reduce employer contributions.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits* – Benefits paid to participants are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

*Risks and Uncertainties* – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**Note 4—Fair value measurements**

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction which requires an entity to maximize the use of observable inputs when measuring fair value. U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There were no transfers between levels during the years ended December 31, 2024 and 2023. The following is a description of the valuation methodology used to measure the Plan's investments at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Common/Collective Trust Funds* – Investments in the common/collective trust funds are stated at estimated fair values, which have been determined based on the unit values of the funds. Unit values are determined by the organization sponsoring such funds by dividing the funds' net assets at fair value by its units outstanding at each valuation date. In accordance with Subtopic 820-10, as there is no readily determinable fair value and the trust funds are valued using the net asset value ("NAV") per share (or its equivalent) as a practical expedient, they have not been classified in the fair value hierarchy.

Furthermore, although Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Tax status**

The Plan adopted a non-standardized, pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received an opinion letter specific to the Plan itself, and the pre-approved profit sharing plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan qualifies under IRC Section 401(a) and the related trust is tax-exempt as of December 31, 2024 and 2023. The Plan Sponsor believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6—Party-in-interest transactions**

Certain Plan investments are managed by the qualified institutions and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services totaled \$74,206 and \$37,678 for the years ended December 31, 2024 and 2023, respectively, and are included in the statements of changes in net assets available for benefits. Notes receivable from participants also qualify as a party-in-interest transaction.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

**Note 8—Subsequent events**

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through October 14, 2025, the date these financial statements were available to be issued.
