Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cathedral Corporation Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Cathedral Corporation Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a qualified defined contribution profit-sharing plan under Section 401(a) of the Internal Revenue Code and has a Section 401(k) salary deferral arrangement. The Plan covers employees of Cathedral Corporation and employees of Letter Concepts, Inc. (together the “Company”). Employees are eligible to participate in the Plan when they reach six months of service and are twenty years of age or older. Once eligible, employees can begin participating in the Plan on the first day of the calendar quarter coinciding with or following the date eligibility requirements are met. All assets acquired under the Plan are the result of employer or participant contributions thereto, and all income and other additions thereto are administered, distributed, forfeited or otherwise governed by the provisions of the Plan and the Employee Retirement Income Security Act of 1974 (ERISA).

Plan restatement, amendments, participating employers and plan merger - In June 2021, Cathedral Corporation acquired 100% of the outstanding stock of Letter Concepts, Inc. As a result of the corresponding asset transfer, there are \$9,787 and \$54,139 of remaining receivables from the former custodian of the Letter Concepts, Inc. Plan as of December 31, 2024 and 2023, respectively.

Plan provisions - The Plan has implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE Act”) and the SECURE 2.0 Act of 2022, laws which, among others, extend the age for required minimum distributions to seventy-three. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to make elective salary deferral contributions and Roth 401(k) contributions up to the maximum amount allowed by the Internal Revenue Code. Participants who meet certain age requirements are allowed to make catch-up elective deferrals. Rollover contributions to the Plan are also permitted. Eligible employees are automatically enrolled in the Plan to make elective contributions of 6% of their annual compensation unless they specifically elect not to defer under the Plan.

The Company makes Safe Harbor matching contributions of 100% of the first 1% of a participant’s elective deferral and 50% of the next 5% of a participant’s elective deferral with a maximum contribution of 3.5% of a participant’s eligible compensation. The Company’s Safe Harbor matching contributions were \$436,277 for the year ended December 31, 2024, of which the Company paid \$314,227 and used forfeited non-vested accounts of \$122,050 to reduce payments remitted to the Plan (see below). Safe Harbor matching contributions were \$412,572 for the year ended December 31, 2023, of which The Company paid \$347,966 and used forfeited

non-vested accounts of \$64,606 to reduce payments remitted to the Plan (see below). Additionally, the Company may make discretionary matching contributions based on participants' years of service and may also elect to make discretionary profit-sharing contributions, determined annually by the Company's Board of Directors. There were no discretionary matching or profit-sharing contributions for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant's account is credited with the participant's elective salary deferral contribution, an allocation of the Company's contributions, plan earnings and administrative expenses. Allocations of contributions are based on participants' compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's account balance. Participants can access their account information via Fidelity Management Trust Company's ("Fidelity") website where they have the ability to change their elective deferrals, apply for participant notes receivable and request distributions.

Investment options - Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered by the Plan. Participants may change their investment options daily through online access.

Vesting - Participants are immediately vested in their elective salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100% vested in Safe Harbor matching contributions after two years of credited service. Participants are 100% vested in any type of employer discretionary contributions after five years of credited service.

Forfeitures - Forfeited non-vested accounts may be used to pay future administrative expenses or reduce future employer contributions. The Company used \$122,050 and \$64,606 of available forfeited non-vested accounts to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. Unused forfeited non-vested accounts totaled \$28,729 and \$135,456 as of December 31, 2024 and 2023, respectively.

Notes receivable from participants - Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes bear interest at a rate based on prevailing interest rates charged by financial institutions under similar terms at the date of issuance; however, the rate can be changed at the discretion of the plan administrator. The interest rate on outstanding notes ranged from 4.25% to 10.50% as of December 31, 2024. Principal and interest is repaid ratably through payroll deductions. The term of the repayment period cannot exceed five years, except if the note is used to acquire a residence, then the repayment period may be extended beyond five years. The notes are secured by the vested balance in the participant's account. According to requirements of the participant note program, the plan administrator will treat a note in default as of the last day of the calendar quarter following the calendar quarter in which the loan is initially past due.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants who are active in the Plan or have terminated employment and have not continued to make payments on their outstanding notes, as required under the program. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Payment of benefits - Benefits are paid according to the vested interest to which participants are entitled upon retirement, termination, death or disability. Upon retirement, death, or disability, benefits are distributed to the participant or beneficiary in a lump sum payment at the request of the participant or beneficiary.

Hardship withdrawals - A participant may apply for a hardship withdrawal to assist in the payment of several types of personal hardships, as defined by the plan agreement. Any hardship distribution is limited to the amount necessary to meet the financial need.

Plan termination - Although it has not expressed any intent to do so, the Company has the right, under the plan agreement, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their account balances.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expense during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Investments are stated at fair value (see Note 5) with the exception of the common collective trust fund which is valued at net asset value (NAV) as a practical expedient as reported by the sponsor of the trust (see below). All investment values have been determined and certified by Fidelity Management Trust Company, the Trustee of the Plan, (see Note 4). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The Fidelity Managed Income Portfolio II is a common collective trust fund that is made up of various investment and security-backed contracts, which are mainly publicly traded securities. The common collective trust fund is valued at NAV, which serves as a practical expedient to estimate its fair value. The NAV of the common collective trust fund is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Investments valued at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviews all notes receivable balances that exceed forty-five days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balance that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance, if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable, and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Administrative expenses - Administrative costs, including maintaining participants' accounts, legal costs, and accounting costs, are the obligation of the Plan; however, the plan sponsor may pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments are paid directly out of the Plan's assets (see Note 6).

Payment of benefits - Benefits are recorded when paid.

Economic dependency and concentration of credit risk - Investments held by T. Rowe Price, MFS Investment Management and Vanguard represent approximately 74% of the Plan's investments as of December 31, 2024. Investments held by Fidelity, T. Rowe Price, MFS Investment Management and Vanguard represent approximately 80% of the Plan's investments as of December 31, 2023. Accordingly, the Plan is dependent upon the financial condition of these entities.

Subsequent events - Effective June 2025, the Company sold its business services division to a third-party buyer and approximately 108 employees were terminated and hired by the buyer. In total, the participants that were terminated amounted to more than 20% of plan participants. Accordingly, the Company determined that a partial plan termination had occurred, and all participants became fully vested in their account balances. Management has evaluated subsequent events through October 9, 2025, the date that the financial statements were available for issue.

Note 3 - Tax status of the Plan

The Plan has adopted the Fidelity Basic Plan Document No. 17. The Internal Revenue Service has ruled that this prototype plan is acceptable under Section 401(a) of the Internal Revenue Code. A separate determination letter has not been obtained for the Plan. The Plan has been amended since receiving the determination letter; however, the management of the Company and plan administrator are not aware of any matters that would disqualify the Plan. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the years ended December 31, 2024 or 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

Note 4 - Information certified by the Trustee of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in investments, interest and dividend income, and interest received on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Fair value measurements

The Financial Accounting Standards Board has published authoritative guidance on fair value measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that a plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (i.e., Mutual Funds) - Valued at the closing price reported on the active market on which the individual security is traded (Level 1).

Money Market Fund - Valued at the closing balance of interest-bearing cash accounts in which funds are held (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

Note 6 - Related-party transactions

Plan investments are funds managed by Fidelity Management Trust Company, the Trustee of the Plan. The investment fees paid for the Trustee's services qualify as party-in-interest transactions and are included in net appreciation in investments in the accompanying statements of changes in net assets available for benefits. Additionally, the Plan has contracted with Adirondack Financial Services to provide investment advisory services and Fidelity Investments Institutional to provide recordkeeping and third-party administrative services. These services qualify as party-in-interest transactions. The Plan paid \$124,184 and \$112,734 in investment advisory, recordkeeping and third-party administration fees for the years ended December 31, 2024 and 2023, respectively, which are included in administrative expenses in the accompanying statements of changes in net assets available for benefits.

The Plan contracts with Dannible & McKee, LLP to provide auditing services, which qualifies as party-in-interest transactions. Fees for those services were paid for by the Company for the years ended December 31, 2024 and 2023.

Note 7 - Reconciliation of the financial statements to Form 5500

As explained in Note 2, the Fidelity Managed Income Portfolio II is a common collective trust fund and is reported at NAV; however, Fidelity Management Trust Company has prepared Form 5500 using fair value for this investment. Accordingly, there is a reconciling item between the reporting in the financial statements and Form 5500 for this investment.
