**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Plymouth Place, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Plymouth Place, Inc. (the Company). The Plan was adopted by the employer as of January 1, 1988, and was restated in April 2019 and most recently amended effective June 1, 2024. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under Section 403(b)(7) of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Employees of the Company are immediately eligible to participate in the Plan for elective deferrals. Participants are eligible for the Company contributions upon completing one year with at least 1,000 hours of service. Effective June 1, 2023, employees are eligible for the Company match contributions immediately upon hire, unless they are in an excluded class of employees. Participants must also be active employees on the last day of the Plan year and have 1,000 hours of service during each Plan year to be eligible to receive the Company matching and additional contributions. Effective October 1, 2023, the Plan was amended to exclude certain employees from receiving the Company matching contribution.

**Contributions**

Each year participants may contribute a percentage or flat dollar amount of compensation, as defined in the Plan. Effective January 1, 2024, the Plan was amended to allow Roth contributions. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants over the age of 50 can elect to contribute catch-up deferrals up to the Internal Revenue Service (IRS) annual deferral limit for the Plan year.

The Company may, at its discretion, elect to make a qualified matching contribution to the Plan. For the year ended December 31, 2024, the matching contribution was determined based on the participant's years of service. Participants with five years of service or less received a match equal to 50% of employee deferrals up to 6% of eligible compensation deferred to the Plan. Those with six to nine years of service received a 70% match of employee deferrals up to 6% of eligible compensation, while participants with ten or more years of service received a 90% match of employee deferrals up to 6% of eligible compensation. In addition to the matching contribution, the Company may also elect to make an annual discretionary contribution to the Plan. For the year ended December 31, 2024, no additional contribution was made.

**Contributions (Continued)**

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching and additional contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's compensation or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Effective January 1, 2014, vesting in the Company matching and additional contribution portions of participant accounts plus actual earnings thereon is based on years of continuous service. A participant is vested 20% after two years of completed service and 20% each year thereafter, until fully vested after six years. Participants hired prior to January 1, 2014, were immediately vested in the Company contributions plus actual earnings thereon. Effective June 1, 2024, a participant is vested 20% every year of completed service, until fully vested after five years.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 1%. Interest rates range from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through payroll deductions. Loans must be repaid within five years or up to 15 years if used for the purchase of the participant's primary residence.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to 100% of the vested interest of the participant's account, or annual installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Company contributions; any remaining forfeitures are reallocated to eligible participants. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$9,935 and \$63,595, respectively. There were \$1,393 of forfeitures used to reduce administrative expenses during the year ended December 31, 2024. There were \$67,470 of forfeitures used during the year to reduce Company contributions for the year ended December 31, 2023. Subsequent to year-end, forfeitures of \$10,157 were used to reduce Company contributions for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable, if any, are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain participant transactions are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants as of December 31, 2024 and 2023, reflected on the accompanying statements of net assets available for benefits, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Prudential Retirement Insurance & Annuity Company (insurance company). The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the insurance company, represents contributions made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. A participant may ordinarily direct the withdrawal or transfer of all or a portion of his/her investment at contract value.

**NOTE 4 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

Generally, there are not any events that might limit the ability of the Plan to transact at contract value with the insurance company. In addition, there are not any events that allow the insurance company to terminate the contract with the Plan and settle at an amount different from contract value.

**NOTE 5 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at cost, which approximates fair value.

**NOTE 6 PLAN TAX STATUS**

The Plan Sponsor has adopted a pre-approved volume submitter 403(b) retirement plan document. The existing 403(b) prototype plan was amended and restated to comply with Revenue Procedure 2017-18. The restatement effective date is retroactive to January 1, 2010, except for certain provisions which have an effective date of June 1, 2016. The Plan is placing reliance on an opinion letter received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments were held by Charles Schwab Trust Bank, the qualified institution, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. In addition, the Plan paid fees to the qualified institution and other service providers totaling \$13,700 for the year ended December 31, 2024.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 11 INVESTMENTS EXCLUDED FROM PLAN**

The Plan has excluded from investments in the statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor (DOL)'s Field Assistance Bulletin No. 2009-02. If the identified contracts, as reported by The Lincoln National Life Insurance Company, were included, net assets available for benefits would increase by \$86,106 and \$86,291 as of December 31, 2024 and 2023, respectively. Further, investment income of \$2,936 and distributions of \$3,121 related to such accounts, as identified by The Lincoln National Life Insurance Company, have also been excluded from the statement of changes in net assets available for benefits for the year ended December 31, 2024.
