## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Venture Forthe, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. PLAN DESCRIPTION

The following is a brief description of the Venture Forthe, Inc. 401(k) Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a “safe harbor” defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee and employer contributions and covers all employees of Venture Forthe, Inc. (the “Company” or “Plan Sponsor”) who have completed at least 12 months and 1,000 hours of service, are at least 21 years of age, and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Participants may elect to contribute up to 100% of their compensation. Total contributions are subject to Internal Revenue Service (“IRS”) limitations. The safe harbor matching contribution is equal to 100% of employee contributions up to 3% of employee eligible compensation, plus 50% of salary deferrals between 3% and 5% of employee eligible compensation. This safe harbor matching contribution is fully vested and is referred to as a basic matching contribution. The Company may also make additional discretionary matching and profit sharing contributions. No discretionary matching or profit sharing contributions were made for the years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other defined contribution plans.

**Vesting** – Participants are immediately vested in both their voluntary contributions and safe harbor matching contributions and the earnings thereon. Vesting in the discretionary matching and profit sharing contributions, and earnings thereon, are based on a graded vesting schedule with participants 100% vested after six years. Regardless of years of service, participants are fully vested upon disability or death.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000, or up to 50% of their vested account balance. Loans are available on a reasonably equivalent basis and will only be made to participants who are creditworthy. Loans must be adequately secured and participants generally must use their vested interest in the Plan as security, provided the balance of all loans outstanding does not exceed 50% of their vested account balance. Generally, loan terms may not exceed five years. Borrowings bear interest based on a reasonable rate determined by the plan administrator (5.25% - 10.50% at December 31, 2024) and mature through November 2029. Principal and interest are paid through regular payroll deductions.

**Forfeitures** – Participants not fully vested in employer discretionary contributions upon separation from the Company, as defined in the Plan document, forfeit their non-vested balances, which are used to reduce administrative expenses of the Plan and then are allocated as employer discretionary profit sharing contributions. Any remaining forfeitures will be used to reduce basic matching contributions. There were no forfeitures available at December 31, 2024 and 2023. There were no forfeitures utilized during the years ended December 31, 2024 and 2023.

## 1. PLAN DESCRIPTION (continued)

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and an allocation of the employer contributions and Plan earnings. Allocations of earnings are based on participant account balances.

**Plan Termination** – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall become 100% vested and entitled to the amount of their account at the date of such termination.

**Payment of Benefits** – Benefits are determined by the final value of the participant’s account at the time of retirement, termination, disablement or death and are paid as lump-sum distributions. Employees are eligible for retirement at age 65. Distributions are also permitted in the event of financial hardship, as defined by the Plan. In addition, the Plan also allows for in-service distributions once a participant has attained the age of 59 1/2 years.

**Administrative Expenses** – Costs of administering the Plan were paid by both the Plan Sponsor and the participants for the years ended December 31, 2024 and 2023.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan follows the guidance of accounting standards that establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded, on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value as of December 31, 2024 and 2023:

**Mutual funds:** Valued based on the quoted market price available on an active market, which represents net asset values of the shares held by the Plan at year end.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

*Payment of Benefits* – Benefit payments to participants are recorded when paid.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

*Subsequent Events* – The Plan has evaluated the effects of all subsequent events through September 30, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

## 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures. For additional information on how the Plan measures fair value refer to Note 2 – Summary of Significant Accounting Policies. The following table summarizes the assets of the Plan for which fair values are determined on a recurring basis at December 31:

## 4. INCOME TAX STATUS

The Plan has adopted a Prototype Non-standardized Pre-Approved Profit Sharing Plan with CODA (the “Pre-approved Plan”). The Pre-approved Plan received an Opinion Letter from the IRS dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Code for use by employers for the benefit of their employees. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.
