As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the period May 13, 2024 through December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND FOR THE PERIOD MAY 13, 2024 THROUGH DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Nightwing 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan covering substantially all employees of Nightwing Group, LLC (the “Company”). The Company, formerly known as Columbus Buyer, LLC, was incorporated in Delaware on October 13, 2023, and formed to acquire the Cyber and Intelligence Services (“CIS”) Business from RTX Corporation (“RTX”). The acquisition was consummated in March 2024. Eligible employees of RTX participated in the RTX Corporation Savings Plan (the “RTX Plan”).

As a result of this transaction, the Plan was established on May 13, 2024. Substantially all former employees of RTX that transferred to the Company were given the option of rolling their existing account balances under the RTX Plan into the Plan.

The Plan is governed by the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). State Street Bank and Trust Company serves as the Plan’s trustee and custodian for the majority of Plan assets. Alight Solutions LLC functions as the Plan’s recordkeeper. Alight Financial Solutions is the custodian of the Plan’s self-directed brokerage accounts.

Participant Contributions—Participant contributions are withheld from employees’ compensation and are remitted to the Plan as soon as administratively feasible, in accordance with the Department of Labor’s regulations.

Participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan also includes an auto escalation feature wherein contributions will automatically increase by 1% of eligible compensation each year until they reach 10%.

Employer Contributions—Employer contributions consist of Company matching contributions and Company Retirement Contributions (CRCs). Generally, the Company matches 100% of the first 3%, and 33.3% thereafter, up to 6% of eligible compensation that a participant contributes each pay period. The CRC is an automatic non-elective Company contribution provided to certain eligible employees. The CRCs are a percentage of the participant’s eligible compensation based on the participants’ age and range from 3% to 7%.

Participant Accounts—Each participant’s account is credited with the participant’s contributions and Company matching contributions, CRCs (as applicable), and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting—Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching contribution and CRC portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is equal to 1% above the prime rate, as defined. Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits—On termination of service with the Company (including termination due to death, disability or retirement), a participant may elect a distribution of their vested balance as a lump sum distribution or through partial distributions. Otherwise, distributions generally begin on a participant’s mandatory commencement date.

Withdrawals—Participants may withdraw all or a portion of their vested account balance in accordance with the Plan document, which provides different rules for withdrawals based on whether or not the participant has reached age 59 ½.

Forfeited Accounts—In accordance with the provisions of the Plan, forfeitures arising from non-vested employer contributions may be used to reduce future employer contributions, pay plan administrative expenses, or be reallocated to eligible participants. Forfeitures are tracked and applied in accordance with the Plan document. As of December 31, 2024, forfeited nonvested accounts totaled \$27,210. During 2024, no employer contributions were reduced from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants’ account balances and the amounts reported in the financial statements.

Concentration of Investments—As of December 31, 2024, investments in the Fidelity 500 Index mutual fund and the Vanguard Target Retirement 2030 mutual fund accounted for approximately 28% and 12% of total investments, respectively.

Investment Valuation and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Nightwing’s 401(k) Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as those held during the year.

Contributions—Contributions from Plan participants and the matching contributions and CRCs from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits—Benefits are recorded when paid.

Administrative Expenses—Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant activity are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and for the period May 13, 2024 through December 31, 2024, included in the Plan’s financial statements and supplemental schedules that were prepared by or derived from information prepared by State Street Bank and Trust, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained a certification from the trustee that such information is complete and accurate.

The self-directed brokerage account is not certified. The amounts not certified include \$171,820 of investments at fair value as of December 31, 2024 and \$38,600 of net appreciation in fair value of investments for the period May 13, 2024 through December 31, 2024.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value (“NAV”) is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments associated with the collective trust funds.

Stable Value Fund—A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to confirm that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments associated with the stable value fund.

Money Market Account—Held in a short-term money market account which is valued at cost plus accrued interest.

Self-Directed Brokerage Account – Primarily includes a variety of common stocks and mutual funds. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

5. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain transactions within the Plan qualify as party-in-interest transactions under the ERISA. These include transactions with the Company, and services provided by parties whose roles are integral to the operation of the Plan.

Certain Plan investments are managed by State Street Bank and Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions. The Plan also issues loans to participants, which are secured by the vested balances in the participants’ accounts.

6. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Company withheld participant contributions during 2024 of \$2,262, which will be remitted to the Trustee later than required by Department of Labor (DOL) Regulation 2510.3-102. The Company will file Form 5330s with the IRS and pay the required excise tax on the transactions. In addition, participant accounts will be credited with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. TAX STATUS

Nightwing is in the process of submitting an application to the Internal Revenue Service (IRS) for a determination letter confirming that the Plan and its related trust are designed in compliance with the applicable provisions of the Internal Revenue Code. The application has not yet been approved, however, the Company and Plan management believe that the Plan is currently designed and operated

in compliance with the applicable requirements of the Internal Revenue Code, and the Plan and trust are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. SUBSEQUENT EVENTS

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued. Beginning January 2026, the Company will be offering an 8% company match for all regular employees. Nightwing will no longer offer age-based CRCs. Additionally, participants will be vested immediately in all past and future contributions.
