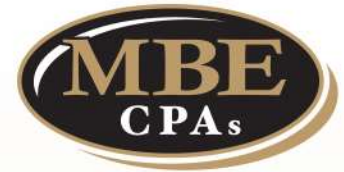

## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FSI, Inc. 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note A – Description of Plan**

The following description of the FSI, Inc. 401(k) and Profit Sharing Plan (The Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan, which was effective January 1, 2014 and amended thereafter, is a defined contribution plan covering all eligible full and part-time employees of FSI, Inc. and its affiliates (The Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers all employees who meet the eligibility requirements. To become eligible for employee deferrals, matching and profit sharing contributions, an employee must be 19 years old, and not be a union or a leased employee. Employees must also complete 500 hours of service in a consecutive 6 month period. If the service requirement is not met in the first 6 consecutive months of the period, employees can become eligible for the Plan if they complete a Year of Eligibility Service and are an employee of the Company at the end of that period. A Year of Eligibility Service is defined as completing at least 1,000 hours of service in a 12 consecutive month period beginning with your first day of employment. Entry into the Plan can commence after the eligibility requirements are met.

Contributions:

Each year, participants may contribute up to the maximum amount of pre-tax compensation as defined by the Internal Revenue Service, or the maximum post-tax compensation to the Roth option inside the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for safe harbor provisions whereby the Company will contribute 100 percent of the first 3 percent of employee compensation that a participant contributes to the Plan. The Company will also contribute 50 percent of the next 2 percent of employee compensation that a participant contributes to the Plan. The employer may, in its sole discretion, also contribute and allocate a profit sharing contribution to each participant's account. There were no profit sharing contributions made in the current year.

Participant Accounts:

Each participant's account is credited with the participant's contribution, Company's contribution, and an allocation of the Plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants:

Participants are allowed to borrow funds from their accounts. The minimum amount of any loan is \$1,000. The maximum amount of any loan made to a participant from the Plan cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may only have 1 loan outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at 1 percentage point over the prime interest rate. Principal and interest can be paid through payroll deductions or repaid in full by check. Loan refinancing is allowed. All outstanding balances become due and payable in their entirety upon severance of employment unless directly rolled over to another employer's plan. Interest rates on outstanding loans ranged from 4.25% to 9.50% during the year ended December 31, 2024. Principal and interest are paid in equal installments by payroll deductions.

**Note A – Description of Plan (Continued)**

Payment of Benefits:

On termination of service due to disability, death or retirement, a participant or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, receive partial payments, or rollover their account balance. For termination of service due to other reasons, a participant may receive a lump-sum distribution. In-service distributions are also allowed if the participant has attained normal retirement age. If a participant ceases to be an employee of the Company and his or her account balance is less than \$5,000, the entire vested account balance may be payable to the participant or his or her beneficiaries in a single lump-sum payment. Participant balances in excess of \$5,000 may remain in the Plan until such time the participant elects to receive a distribution. A participant may elect to receive a lump-sum amount or a rollover. In addition, hardship distributions are permitted if certain criteria are met. Hardship distributions are distributed in a lump sum amount.

Vesting:

Participants are 100% vested in their contributions and the company's matching contributions. The participants profit sharing contributions will vest based on years of vesting service in accordance with the following schedule:

If an employee is not already fully vested, they will automatically become fully vested if they attain Normal Retirement Age, if employment is terminated due to disability, if the employee dies, or if the Plan is terminated, or partially terminated.

Forfeitures:

Participants who terminate their employment and are less than 100% vested in their employer profit sharing account will forfeit the non-vested portion. There has been no profit sharing since inception of the Plan. In addition, employer deposits made that cannot be allocated to specific participant accounts are reported in the forfeiture account. Forfeitures are retained in the Plan and used to reduce Plan administration fees or employer matching contributions. The forfeitures account balance was \$90 and \$0 at December 31, 2024 and 2023, respectively.

**Note B – Summary of Significant Accounting Policies**

Basis of Accounting – GAAP:

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

**Note B – Summary of Significant Accounting Policies (Continued)**

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

Investments held by a defined contribution plan are required to be reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. See Note I for additional discussion of fair value measurements.

Fully benefit-responsive investment contracts are measured at contract value. See Note J for additional discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Change in Fair Value of Investments:

The Plan presents, in the statements of changes in net assets available for benefits, the net change in the fair value of its investments, which consist of the realized gains or losses and the net unrealized gains or losses on those investments.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits:

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who had elected to withdraw from the plan prior to the end of the calendar year, but had not been paid as of the years ended December 31, 2024 and 2023.

Administrative Expenses:

The Plan incurs expenses related to general administration and record keeping. The Plan pays for certain investment and distribution fees, but the Plan's sponsor pays the remaining expenses and certain accounting fees related to the Plan.

*Date of Management's Review:*

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.

**Note C – Plan Termination**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA.

**Note D – Tax Status**

The plan has on file an IRS determination letter dated June 30, 2020, as applied for by the plan provider. The Plan has been amended since receiving its last IRS determination letter. The Plan Administrator has not applied for a separate determination letter but in the opinion of the Plan Administrator and tax counsel, the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note E – Party-In Interest Transactions**

Certain Plan investments are annuity contracts owned by Empower Annuity Insurance Company. Empower Annuity Insurance Company is a custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Empower Annuity Insurance Company for recordkeeping fees of \$3,045 and \$3,250 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, the Plan also made direct payments to Empower Advisory Group, LLC for investment management services of \$9,269 and \$5,608, respectively. Direct payments made for management services to Premier Retirement Partners were \$2,329 and \$3,010 for the years ended December 31, 2024 and 2023 respectively. Additional indirect compensation was paid to Premier Retirement Partners and Ameriprise Financial Services, Inc., which is included in net appreciation in fair value of the investments. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**Note F – Accounting for Uncertainty in Income Taxes**

The plan has evaluated for uncertain tax positions. Management has determined there are no uncertain tax positions as of December 31, 2024 and 2023. Federal tax returns remain open to examination through their respective statutes of limitations.

**Note G – Concentration of Credit Risk**

All of the plan assets are maintained with a single custodian, which has concentrated the Plan's credit risk.

**Note H – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

**Note I – Fair Value Measurements**

The plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1: The fair values of mutual funds are based on the closing price reported in the active market where the individual securities are traded, when available.

Level 2: Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. There were no level 2 assets as of December 31, 2024 and 2023.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no level 3 assets as of December 31, 2024 and 2023.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**Note J – Group Annuity Contract**

The Plan has a fully benefit responsive group annuity contract with an insurance company, which is called the Key Guaranteed Portfolio Fund. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) division closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.
