### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

**NOTE 1 - PLAN DESCRIPTION**

The following description of the Urology Associates of Mobile, P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan, adopted January 1, 1977, is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Urology Associates of Mobile, P.A. (the Company) who are the age of twenty-one or older and have one year of credited service. Plan entry dates are January 1 and July 1 of each year. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions, which are made on an after-tax basis but may allow for tax-free distributions if certain requirements are met. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes safe harbor contributions equal to 100% of the participant's elective deferrals up to 3% of compensation, and 50% of elective deferrals exceeding 3% but not exceeding 5% of compensation. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. For the year ended December 31, 2024, the Company made profit sharing contributions to the Plan of \$914,235. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant accounts.* Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and Plan earnings. Participant accounts are charged with benefits paid and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their elective salary deferrals and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution is based on years of continuous service. Participants become 20% vested after two years of vesting service and vest ratably in 20% increments until they become 100% vested after six years of service. A participant will always be 100% vested if employed on or after attaining the normal retirement age of 60, becoming disabled, upon death, or upon termination of the Plan.

*Payment of benefits.* Upon termination of service due to permanent disability or retirement, a participant may elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution. Funds may also be accessed prior to the date they become distributable by way of in-service distributions and/or a financial hardship withdrawal. In-service distributions are available once the participant has reached the age of 59 1/2. Hardship withdrawals are allowable in accordance with current Internal Revenue Service (IRS) guidelines.

*Forfeited accounts.* Forfeitures are created when participants terminate employment prior to becoming fully vested in the Company contribution portion of their accounts. Forfeitures for terminated or withdrawing individuals are used to reduce employer contributions, if applicable. As of December 31, 2024 and 2023, unallocated forfeited accounts totaled \$7,188 and \$6,858, respectively. Amounts forfeited during 2024 totaled \$12,132. During the year ended December 31, 2024, employer contributions were reduced by \$12,027 from unallocated forfeited accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Receivables

Employer contributions receivable consists of profit sharing and true up contributions not yet remitted to the Plan at year end. Amounts due at year end were received by the Plan subsequent to year end.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Investment valuation and income recognition

The Plan's investments are reported at fair value as provided and certified by the Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Recordkeeping fees and investment advisory fees are charged directly to the participants' account and are included in administrative expenses. Certain other fees incurred by the Plan are included in net appreciation in fair value of investments.

Subsequent events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - PLAN ADMINISTRATION**

The general administration of the Plan and the responsibility for carrying out its provisions are placed with the Plan Administrator. For the period January 1, 2024 to November 13, 2024, Newport Trust Company, LLC (which became part of Ascensus in 2024 through a merger) served as Trustee for the Plan. For the period November 14, 2024 to December 31, 2024, Ascensus, LLC served as Trustee for the Plan. The Trustees hold, manage, invest, and reinvest the Plan's assets.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds are valued at cost, which approximates fair value.

**NOTE 5 - TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing plan, which received an opinion letter from the IRS dated November 30, 2020, which stated the Plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes have been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The investments information included in the accompanying financial statements and supplemental schedule, in total, including investments held at December 31, 2024, and net appreciation in fair value, dividends and interest for the year then ended was obtained from data prepared by the Trustees of the Plan and provided to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustees that such information is complete and accurate.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

During the year ended December 31, 2024, fees of \$68,033 were paid by the Plan to various service providers which qualify as party-in-interest transactions under ERISA.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
