Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of E&F Management, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. Plan Description

The following brief description of the E&F Management, LLC 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to employees of E & F Management, LLC (the "Company" or "E&F").

Employees are eligible to make salary deferral contributions immediately with no age or service requirement (see Note 9). Employees are eligible to receive discretionary matching contribution and discretionary non-elective profit sharing contributions after attaining age 18 and completing 6 months of service. Participants will only receive discretionary non-elective profit sharing contributions if they are employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year. Entry dates for discretionary matching contributions and discretionary non-elective profit sharing contributions are the first day of the month following the date on which eligibility requirements are fulfilled.

In January 2023, the Plan completed the merger of the Sullivan Auctioneers, LLC 401(k) Plan (Sullivan Plan). As a result, certain participants and plan assets of \$1,944,120 were transferred from the Sullivan Plan into the Plan during the year ended December 31, 2023.

Contributions

Participants may make voluntary pre-tax and after-tax Roth salary deferral contributions up to the maximum dollar limits allowable by law. Participants are automatically enrolled in the Plan with an initial salary deferral of 3% of eligible compensation, increasing by 1% on the first day of each plan year until it reaches a total of 10% of their eligible salary. At any time, a participant can elect not to contribute or may increase or decrease to deferral rates allowed under the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching contributions and discretionary non-elective profit sharing contributions.

Participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's discretionary matching contribution and discretionary non-elective profit sharing contributions, b) Plan earnings or losses and c) Plan expenses. Company discretionary matching contributions are allocated among participants based upon each eligible participant's elective salary deferral. Company discretionary non-elective profit sharing contributions are allocated based upon participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by John Hancock Life Insurance Company (John Hancock).

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions credited to the participants' accounts are based on years of continuous service. Participants are 25% vested after a year of credited service and vesting increases 25% per year until a participant is 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for hardship or financial purposes. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through payroll deduction payments for active participants and in at least quarterly installments for non-active participants.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum, partial or installment payments equal to the value of the vested funds allocated to the participant's account. Upon attainment of age 59 1/2, a participant may withdraw all or a portion of the contributions made to the Plan in which they are 100% vested. The Plan requires distribution payments between \$1 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. The Plan also allows for hardship distributions (as defined by the Plan document). Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce Company discretionary contributions. As of December 31, 2024 and 2023, there were \$117 and \$30,993, respectively, of forfeited non-vested accounts. During the years ended December 31, 2024 and 2023, the Company's discretionary contributions were reduced by \$83,515 and \$31,169, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Other

Investment management and record-keeping expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Audit fees are paid by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 13, 2025. See Note 9 for descriptions of subsequent events.

3. Information Certified by John Hancock

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of their underlying investments. The accounts include underlying investments in fixed securities, mutual funds, common stocks, or real estate which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these accounts meet those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract With John Hancock

The Plan has entered into an investment contract with John Hancock. John Hancock maintains the contributions in pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock.

The pooled separate accounts, as reported to the Plan by John Hancock, are included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

8. Related-Party Transactions

Certain Plan assets are cash and investments in pooled separate accounts managed by John Hancock. John Hancock is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

9. Subsequent Events

Change in Custodian and Asset Transfer

Effective August 15, 2025, T. Rowe Price Retirement Plan Services, Inc (T. Rowe Price) will be appointed as the new custodian of the Plan. The conversion will initiate a “Black Out” period beginning August 29, 2025, and continued through September 26, 2025. During the Black Out period, funds will not be applied to the employee selected funds or withdrawn from the Plan until T. Rowe Price has time to accurately complete the conversion. Employee contributions will continue to be made through payroll deductions, and contributions will be wired to T. Rowe Price and invested as requested.

Eligibility

Effective August 15, 2025, employees are eligible to make salary deferral contributions after 30 days of service.
