#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Woodstock Resort Corporation Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**1. Description of Plan**

The following description of The Woodstock Resort Corporation Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan covers all employees of The Woodstock Resort Corporation (the “Employer”) who have completed at least 1,000 hours of service within 12 consecutive months, except, nonresident aliens and individuals who became employees as a result of a transaction described in Internal Revenue Code (“IRC”) Section 410(b)(6)(C). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is a defined contribution plan formed on December 31, 1989 and amended and restated on May 1, 2021.

***Contributions***

Participants may contribute up to 100% of their pretax annual eligible compensation to the Plan. The Plan also allows for eligible participants to make post-tax contributions up to 100% of their annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Employer is required to make matching contributions of 100% of each participant’s elective deferrals up to 3% of the participant’s compensation.

The Employer may elect to contribute a discretionary profit sharing contribution. Employees must be employed on the last day of the Plan year and complete at least 1,000 hours of service to be eligible for profit sharing contributions. The Employer did not make a profit sharing contribution in 2024.

Contributions and eligible compensation are subject to certain limitations under the IRC.

***Participation and Vesting***

Each participant’s account is credited with the participant’s contribution, allocations of the Employer’s matching contributions, the Employer’s other discretionary contributions, and Plan income, expenses and losses. Allocations of the Employer’s other discretionary contributions are based on a uniform percentage of a participant’s eligible compensation, a uniform dollar amount, or as defined by the Plan. Allocations of Plan income, expenses and losses are based on a participant’s account balance to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of his or her account, as provided in the Plan.

***Participation and Vesting (continued)***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service.

Employees become vested in employer-matching contributions as follows:

Employees become vested in discretionary profit sharing contributions as follows:

Participants automatically become fully vested upon disability, death or normal retirement while under the employment of the Employer.

***Notes Receivable from Participants***

Participants may borrow from a minimum of \$1,000 up to 50% of their vested account balance, provided that the loan does not exceed \$50,000. Participants are permitted two outstanding loans. Loans are secured by the balance in the participant's account and bear interest at a reasonable rate, as defined by the Plan. All loans must be repaid within five years or within 30 years for the purchase of a primary residence. Principal and interest are paid ratably through biweekly payroll deductions.

The interest rate for all outstanding loans at December 31, 2024 and 2023 ranged from 7.25% to 9.50% and 4.25% to 9.50%, respectively.

**1. Description of Plan (continued)**

***Benefits***

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. In-service distributions are permitted for participants who have reached age 59 ½ or retirement age (65), as well as qualified for reservists. Rollover accounts may be withdrawn at any time. Distributions under the Plan may be made in lump sums or partial withdrawals.

***Forfeitures***

Forfeitures of terminated Participants' nonvested account balances can be used to pay administrative expenses, to reduce future Employer contributions, or can be reallocated to active participants. The Employer elected to use \$7,083 of forfeited amounts to pay certain Plan expenses as allowed by the Plan during the Plan year ended December 31, 2024. The forfeiture balance amounted to \$22,685 and \$23,597 at December 31, 2024 and 2023, respectively. During 2024 no forfeitures were used to fund Employer contributions.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and excluded from these financial statements. Fees related to the administration of notes receivable (i.e., participant loans from the Plan) from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Plan Termination***

Subject to limitations imposed by ERISA and rules and regulations promulgated thereunder, the Employer reserves the right to amend, modify, suspend, discontinue or terminate the Plan. In the event of termination or partial termination of the Plan, the interest of all affected participant accounts and benefits accrued to the date of such termination will become fully vested and nonforfeitable.

**2. Summary of Significant Accounting Policies**

The following are significant accounting policies consistently followed by the Plan in maintaining the underlying records of the Plan's net assets and the accounts of participants. The financial statements have been prepared in accordance with these policies.

**2. Summary of Significant Accounting Policies (continued)**

***Basis of Accounting and Use of Estimates***

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America (“US GAAP”), using the accrual basis of accounting which recognizes revenue when its earned and expenses as they are incurred. The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and disclosure of contingent net assets available for Plan benefits at the date of the financial statements and the reported amounts of additions and deductions to net assets available for Plan benefits during the period. Accordingly, actual results could differ from those estimates.

***Notes Receivable from Participants***

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are reclassified as a distribution based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Fair Value Measurements***

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to US GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds and common/collective trusts are stated at fair value. Investments in mutual funds are determined by quoted prices in active markets which represents the NAV of shares held by the Plan at year end. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**3. Tax Status**

The Plan has adopted a nonstandardized form of a pre-approved plan. The pre-approved plan provider, Ascensus, LLC, received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**4. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the Trustee of the Plan and a qualified institution.

**6. Common/Collective Trust**

The common collective trust consists of a stable value fund that primarily comprises fully benefit-responsive investment contracts and is valued at the NAV of units of the common collective trust. Participant transactions (purchases and sales) may occur daily. The common collective trust provides for daily redemptions by the Plan at the reported NAV per share, with no advance notification requirement. The common collective trust has no unfunded commitments.

**7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect account balances and the amounts reported in the statements of net assets available for benefits.

**8. Party-in-Interest Transactions**

Certain investments of the Plan are managed by the Trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for plan benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.
