1. Plan Description

The following description of The Arc - Warren County Chapter, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of The Arc - Warren County Chapter, Inc. (the "Organization"). Employees of the Organization are generally eligible to participate in the Plan on the first day of the month subsequent to attaining the age 18 and completing 1,000 hours of service within the first year. If employees work less than 1,000 hours per year, the employee becomes eligible to participate in the Plan on the earliest date after attaining age 21 and have worked more than 1,000 hours in a twelve month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Organization. The Organization shall be the Plan administrator and has the authority to appoint or remove the custodian. The Organization has engaged the services of a third-party administration firm to assist it with the performance of its duties. As of December 31, 2024 and 2023 Nationwide and Mutual of America, respectively serve as custodian and record keeper of the Plan (the "Custodian").

Contributions

Each year, participants may contribute a portion of their compensation, as defined in the Plan, subject to certain limitations established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employer discretionary amounts may be contributed at the option of the Organization's Board of Directors. Employer contributions were 4% and 2% of participant's eligible compensation in 2024 and 2023, respectively amounting to \$237,415 and \$234,535, respectively. Contributions are subject to certain limitations as established by the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contributions and Organization's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of service. A participant is 100% vested after 3 years of credited service.

The following is a schedule of the vesting percentages by years of service:

Notes Receivable From Participants

Participants may obtain loans from the Plan not to exceed the lesser of \$50,000 or 50% of their vested account balance. The interest rate is calculated at the Prime Rate plus .75% throughout the term of the loan. Loans are secured by the balance in the participant's account. If a participant is terminated, the participant will continue to make payments on the loan. If the loan is declared in default it will become due immediately. Loan balances were \$50,198 and \$71,979 as of December 31, 2024 and 2023, respectively. Principal and interest are paid ratably through monthly payroll deductions.

Benefits

No distributions from the Plan are made until participants reach the age of 59 ½, retire, become disabled, die (in which case, payments are made to their beneficiary or if none, their legal representative), can demonstrate a financial hardship, or otherwise terminate employment with the Organization. Participants are immediately vested in their account plus the actual earnings thereon upon retirement, as defined by the plan, disability or death.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10 year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

Forfeited non-vested accounts are available first to pay administrative expenses and any remaining to offset future employer contributions. For the years ended December 31, 2024 and 2023, forfeitures that were used to reduce employer contributions amounted to \$7,879 and \$3,701, respectively. There were no unapplied forfeitures at December 31, 2024 or 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the modified cash basis. Therefore, with the exception of appreciation or depreciation in the market value of investments, income and expense items are recognized only as cash is received or paid and receivables (other than notes receivable from participants), payables and accrued expenses are not reflected.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded as received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

All administrative expenses of maintaining the Plan are paid ratably from participants' accounts. Loan origination fees, withdrawal fees, and distribution processing fees will be paid by the individual participant's account.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, revenues and expenses and changes therein, and disclosures of contingent assets and contingent liabilities and accompanying notes. It is reasonably possible that the Plan's estimates may change in the near term.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the NAV of units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and accordingly have not been categorized in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market fund: Valued at the daily closing price as reported by the fund sponsor from an actively traded exchange.

4. Mutual of America Life Insurance Company's General Contract

The Plan offers an investment in the Interest Accumulation Account of Mutual of America Life Insurance Company's General Account (Interest Accumulated Account) totaling \$0 and \$268,895 at December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. During 2024 the contract was terminated.

Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. This account is credited with interest at a rate determined by Mutual of America, and it reserves the right to change interest rates applicable to the amounts held in the Interest Accumulation Account at its discretion. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Interest Accumulation Account credits interest at a rate that is declared from time to time, and which may increase or decrease at Mutual of America's discretion.

Mutual of America guarantees that they will credit interest for the life of the contract to amounts in the Interest Accumulation Account at a rate of at least equal to the greater of (1) any contractual minimum guarantee provided by the contract or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (NAIC) standard nonforfeiture law. The NAIC minimum rate is determined in accordance with a formula and cannot be less than 1.00% or more than 3.00% in any event. Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that

calendar year. The current minimum rate has been set at 1.00% in accordance with this formula for all contracts that do not have a contractual minimum guarantee of 3.00% or 1.50%.

If the contract has a contractual guaranteed minimum rate of 3.00% or 1.50%, the interest rate under the participant's contract will not go below that amount regardless of the minimum rate that is set for a calendar year. Mutual of America may credit a higher rate of interest to the participant's contract amounts in the Interest Accumulation Account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Interest compounds daily on the contract amounts in the Interest Accumulated Account to produce an effective annual yield that is equal to the stated interest rate. This guarantee is subject to Mutual of America's financial strength and claims-paying ability.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

5. Certified Investments (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company and Mutual of America at December 31, 2024 and 2023, respectively, the custodian.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. These accounts may be reduced by administrative termination expenses incurred and paid by the Company for which the Company seeks reimbursement by the Plan.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain plan investments are mutual funds and pooled separate accounts managed by Mutual of America and Nationwide trust company during the years ended December 31, 2024 and 2023. Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor, and therefore, these transactions qualify as party-in interest. For the years ended December 31, 2024 and 2023, party-in-interest expenses amounted to \$3,606 and \$1,709, respectively.

9. Risk and Uncertainties

The Plan invests in various investment funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

10. Subsequent Events

Management has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditor's report and the date the financial statements were available to be issued, October 8, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with the modified cash basis of accounting. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

Effective December 17, 2024, the Plan changed its trustee and custodian from Mutual of America to Nationwide Trust Company. As part of this transition, all plan investments were liquidated and

transferred to Nationwide Trust Company. At December 31, 2024, the transferred assets were temporarily held in a mutual fund with Nationwide Trust Company pending allocation to individual participant accounts. The total amount held in this unallocated investment account was \$4,747,864 and is included in Investments, at fair value on the accompanying Statement of Net Assets Available for Benefits. Subsequent to year-end, these funds were allocated to participants' accounts based on each participant's balance at the date of transfer. The Plan Administrator has confirmed that all assets were properly allocated by January 2025.
