INDEPENDENT AUDITOR'S REPORT

To the Trustees of
the Ouachita County Medical Center Employee Retirement Plan

Opinion

We have audited the accompanying financial statements of Ouachita County Medical Center Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Ouachita County Medical Center Employee Retirement Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ouachita County Medical Center Employee Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Ouachita County Medical Center Employee Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Ouachita County Medical Center (the “Company”) who have one year of service, at least 1,000 service hours, and are age twenty-one or older. The following types of employees are excluded from the Plan: employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Company may make contributions equal to a discretionary amount determined by the Company’s management. In 2024, the Company made no contributions to the Plan.

Forfeitures

Forfeitures will first be used to restore previous forfeitures of rehired participants. Any remaining forfeitures may be used to pay administrative expenses of the Plan. If forfeitures still remain, they shall be part of the Company’s contribution for the Plan year in which such forfeiture occurred. There was no forfeiture balance as of December 31, 2024 and 2023. For the year ended December 31, 2024 forfeitures in the amount of \$78 were used to reduce employer contributions in accordance with Plan provisions.

Participant Accounts

Each participant's account is credited, as applicable, with an allocation of the Company’s contribution, Plan earnings, and any remaining forfeitures of terminated participants’ non-vested accounts not used for to pay plan expenses. Allocations are based on participant compensation, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are non-participant directed.

Vesting

Participants vest in the Company contributions portion of their accounts based on years of service as follows:

<u>Years of Service</u>	<u>Percentage</u>
0-2	0%
3	100%

A participant is credited with one year of service each Plan year if the participant works at least 1,000 hours.

Payment of Benefits

On termination of service or retirement, death, or permanent disability, the participant will choose between one lump-sum cash payment, direct transfer, periodic payments, joint and survivor annuity, life annuity, or term certain and life annuity equal to the vested interest in his or her account. Normal retirement age is the later of age 65 or the fifth anniversary of the participant's commencement of participation to the plan. Withdrawals by a participant while employed are limited to any participant that has accrued any amount prior to January 1, 2004, attained the age of 55, and must be fully vested.

Administrative Expenses

The Plan permits the payment of plan expenses to be made from the Plan's assets. Record keeping and other administration fees are allocated among the participants' accounts, to which the fees or expenses pertain, on a dollar-weighted per account basis. Additional fees are charged for management of certain investments.

NOTE 2 – DATE OF MANAGEMENT'S REVIEW

The plan sponsor evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 7, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events.

NOTE 3 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair market value, as defined by the generally accepted accounting principles. See Note 4 for disclosure related to fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains (losses), and the unrealized appreciation (depreciation) on those investments.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Benefits are recorded when paid.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023, respectively.

NOTE 5 - PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and Plan assets will be used solely to provide benefits for participants.

NOTE 6 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

NOTE 7 - RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 8 - RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Plan expenses that are paid directly by the plan sponsor qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions provision of ERISA and the Internal Revenue Code.
