INDEPENDENT AUDITORS' REPORT

TO THE PLAN ADMINISTRATOR AND PARTICIPANTS OF CALIFORNIA SKIN INSTITUTE 401(k) PROFIT SHARING PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of CALIFORNIA SKIN INSTITUTE 401(k) PROFIT SHARING PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the California Skin Institute 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established on November 1, 1985, to provide retirement benefits for employees of California Skin Institute Management, LLC (the “Company”). Effective March 2025, California Skin Institute Management, LLC was acquired by Schweiger Dermatology Group, which became the new plan sponsor. The Plan is a profit sharing plan and trust covering all eligible employees who have attained 21 years of age, have completed one year of eligibility service, and are not covered by a collective bargaining agreement, nonresident aliens, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records of the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and government regulations, and providing participants with any reports and documents required by law.

Participant Contributions – Participants in the Plan may elect to contribute, on a pretax basis or post-tax basis (“ROTH”), either a percentage or set dollar amount of their annual eligible compensation, as defined by the Plan agreement. Participant contributions are subject to annual limits specified by the IRC. For the year ended December 31, 2024, the annual limitation was \$23,000. Participants who reached at least 50 years of age by the end of the Plan year are permitted to make additional catch-up contributions limited to \$7,500 for the year ended December 31, 2024. Participants are also allowed to roll over contributions from other qualified retirement plans, subject to approval by the plan administrator.

Employer Contributions – The Company provided for “Safe-Harbor” contributions to all eligible employees, excluding highly compensated employees, in accordance with the provisions of the IRC. Under the Safe-Harbor contribution rules, the Company makes mandatory contributions in the amount of 3% of eligible compensation for non-highly compensated participants. The Company may also make an annual discretionary profit sharing contribution to the Plan. This profit sharing contribution is expressed as a percentage of participants’ compensation and is allocated to participants’ accounts. The Company made a profit sharing contribution at 1.44% of non-highly compensated participants’ eligible compensation and 4.44% of highly compensated participants’ eligible compensation for 2024.

The Company’s Safe-Harbor contributions and discretionary profit sharing contributions amounted to \$474,481 and \$1,220,958, respectively, for the year ended December 31, 2024. In addition, the Company may make discretionary matching contributions; however, none were made for the year ended December 31, 2024. The Company’s contributions are subject to certain limitations imposed by applicable provisions of the IRC.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Participant Accounts – Each participant’s account is credited with the participant’s voluntary and rollover contributions, as well as allocations of the Company’s Safe-Harbor contributions and discretionary contributions and Plan investment earnings or losses and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary and rollover contributions and the Company’s Safe-Harbor contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit sharing and matching contributions and related earnings thereon is based on years of continuous service. To earn a year of service for vesting purposes, a participant must be credited at least 1,000 hours of service during the Plan year. A participant is 100 percent vested after six years of credited service, as follows:

Investment Options – The Plan currently offers pooled separate accounts and a guaranteed interest fund as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant’s vested account balance or \$50,000 minus the highest outstanding balance of loans in the past 12 months. The loans are secured by the vested balance in the participant’s account. The term of the loan is not to exceed five years, except for loans used to finance the purchase of a primary residence. Interest is charged at a fixed rate determined by the plan administrator at the date of the loan under the loan policy. Principal and interest are paid ratably through semi-monthly payroll deductions and loans are due immediately upon termination of employment.

Payment of Benefits – On termination of service due to normal retirement, disability, death, or termination of employment, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, partial withdrawals or in installments. Normal retirement age is 65 years. Hardship distributions and in-service distributions upon attainment of age 59½, as defined in the Plan, are also permitted. A terminated participant that has a vested account balance between \$1,000 and \$7,000, and has not provided distribution instructions to the Plan, will have his or her account rolled over to an individual retirement account as designated by the plan administrator. In 2023, the upper limit was \$5,000. Vested account balances of less than \$1,000 are automatically cashed out as a single lump-sum distribution. Required minimum distributions are required to begin no later than April 1st following the later of the end of the year a participant retires or reaches the age of 73.

Forfeited Accounts – Any portion of a terminated employee’s account that is not vested is forfeited, subject to the possibility of reinstatement. Forfeitures may be applied to reduce future employer contributions and plan administrative expenses at the discretion of the Company. Forfeited non-vested accounts amounted to \$269,305 and \$82,131 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures of \$21,926 were used to pay administrative expenses. Forfeitures of \$67,000 were used in 2025 to fund 2024 employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan’s financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the Plan’s investment advisor and John Hancock Life Insurance Company (“John Hancock”). See Note 3 for discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions – Contributions from Plan participants and contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (“NAV”) of accumulation units held at year-end. The NAV, as provided by John Hancock, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account, dividends and contract account charges. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. The pooled separate accounts do not have unfunded commitments and are currently not subject to withdrawal limitations.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As described above, the fair value of pooled separate accounts is measured using the NAV practical expedient. In accordance with the fair value measurement guidance, investments that are measured at fair value using the NAV practical expedient are not required to be classified in the fair value hierarchy.

The following table sets forth additional disclosure of the Plan’s investments whose fair value is estimated using NAV per share (or its equivalent) as of December 31, 2024 and 2023:

As of December 31, 2024 and 2023, one investment fund accounted for approximately 26% and 25%, respectively, of the Plan’s investment assets. Additionally, the target date family of funds utilized by the Plan, in the aggregate, accounted for approximately 45% and 44% of total investments as of December 31, 2024 and 2023, respectively.

NOTE 4 – INFORMATION CERTIFIED BY THE INSURANCE COMPANY

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock has certified the completeness and accuracy of all investments and notes receivable from participants presented in Notes 3 and 5 and the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related net appreciation/depreciation in fair value of investments and interest income on the notes receivable from participants presented in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – INVESTMENT, AT CONTRACT VALUE

Effective November 2, 2020, the Plan entered into a funding agreement with John Hancock which includes the terms and conditions related to John Hancock's fully benefit-responsive Guaranteed Income Fund investment option. John Hancock maintains the contributions in a general account. John Hancock guarantees a minimum rate of interest to the Guaranteed Income Fund and may credit a current interest rate, expressed as an annual effective yield, exceeding the minimum guaranteed rate. John Hancock determines the current credited interest rate based on a number of factors, including mortality and expense risks, interest rate guarantees, investment income earned on invested assets, and capital gains and/or losses on the sale of invested assets.

John Hancock is contractually obligated to repay the principal and the specified interest yield that is guaranteed to the Plan. The Plan's guaranteed minimum effective crediting interest rate was 1.00% for the year ended December 31, 2024.

John Hancock's Guaranteed Income Fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value in the statements of net assets available for benefits. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by John Hancock represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value. No surrender charge is assessed against contract withdrawals taken for reasons of participant retirement, severance from employment, death, disability, hardship, loan or in-service withdrawals after age 59½. However, there are certain contractual restrictions on transfers to and from the Guaranteed Income Fund and a positive or negative market value adjustment may apply upon contract surrender. The Plan administrator does not believe that the occurrence of any such market value adjustment event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

The Plan may transact according to the terms defined in the contract at contract value or terminate the contract with the issuer at any time. Upon termination or surrender, contract value adjustments and fees may apply. The issuer reserves the right to treat accumulated withdrawals that exceed 5% of the current value of all plan accounts at the beginning of the contract year as a surrender.

NOTE 6 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments include units of participation in pooled separate accounts of John Hancock and the John Hancock Guaranteed Income Fund. John Hancock holds the Plan's assets, and therefore, these transactions qualify as party-in-interest transactions.

Fees paid directly by the Plan to John Hancock for recordkeeping and administrative services amounted to \$218,379 for the year ended December 31, 2024, and are included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

John Hancock provides certain administrative services to the Plan pursuant to a Recordkeeping Agreement between the Company and John Hancock. John Hancock receives revenue from certain of the investment management service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the Plan. John Hancock also provides a credit to the Plan to offset some of the administrative expenses paid by the Plan.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 – SUBSEQUENT EVENTS

In March 2025, California Skin Institute Management, LLC was acquired by Schweiger Dermatology Group. As a result of the acquisition, Schweiger Dermatology Group became the new sponsor of the Plan.

The Plan administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
