Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Brodart Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1 - Description of plan

The following description of the Brodart Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a qualified defined-contribution plan under Section 401(a) of the Internal Revenue Code, with a Section 401(k) salary deferral provision covering all employees of Brodart Co. (the “Company”) who are eighteen years of age, who have been employed by the Company for an aggregate of two months and who are not covered by a collective bargaining agreement. Once an employee is eligible for the Plan, they are automatically enrolled to begin making elective contributions of 3% of their annual compensation to the 401(k) Plan. This deferral percentage is increased automatically by 1% each year, up to a maximum of 15%, unless the participant elects a different percentage or expressly elects not to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan provisions - The Plan implemented the required provisions of the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (the SECURE 2.0 Act) and the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2019 (the SECURE Act). Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to contribute up to 100% of pre-tax and after-tax annual compensation as defined in the Plan, subject to limitations set by the Internal Revenue Code. Participants that have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans. Participants are eligible to make Roth 401(k) deferrals and are subject to the same restrictions as the regular deferral account, although they may not borrow, take a hardship withdrawal or an in-service withdrawal from their Roth elective deferral account. In-plan Roth 401(k) conversions are permitted.

The Company may, at the discretion of the Company’s management, make discretionary nonelective contributions and/or discretionary matching contributions to the Plan. Participants are eligible to receive discretionary profit-sharing contributions after reaching twelve months of service. Participants are eligible to receive employer discretionary matching contributions after reaching two months of service. The Company did not make discretionary nonelective or discretionary matching contributions for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contribution, if any, as well as a share of plan earnings and administrative expenses. Company discretionary contributions are allocated based on the ratio that each individual’s compensation bears to the total compensation of all participants for the calendar year. Allocations of earnings are based on participant account

balances, as defined by the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account; see below. Participants can access their account information via Fidelity's website where they have the ability to change their elective deferrals and investment options, as well as apply for participant notes receivable and request distributions.

Vesting - Participants are immediately vested in their salary deferral contributions and employer discretionary profit-sharing contributions. Participants become 100% in employer discretionary matching contributions after two years of service.

Forfeitures - Forfeited accounts may be used to reduce administrative expenses or to reduce future employer contributions. Unused forfeitures related to the recapture of long outstanding checks in accordance with plan operating procedures were approximately \$27,500 and \$24,000 as of December 31, 2024 and 2023, respectively. The Plan did not use forfeited accounts for the years ended December 31, 2024 or 2023.

Investment options - Upon enrollment in the Plan, a participant may direct contributions to any of the Plan's selected investment options. Participants may change their investment options daily online through Fidelity's website.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, subject to a further limitation of 100% of their elective deferral, after tax and rollover account balance or 50% of their vested account balance, whichever is less. The repayment period cannot exceed five years unless the note is for the purchase/construction of the participant's residence, in which case the note repayment period can be extended to twenty years. The notes are secured by the balance in the participant's account and bear interest at interest rates ranging from 4.25% to 9.50%. Interest rates are determined at the date of inception, commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through weekly or bi-weekly payroll deductions.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on participant notes receivable who are active in the Plan or have terminated employment and have not continued to make payments on the outstanding note receivable as required under the participant loan program. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Payment of benefits - On termination of service due to death, disability, retirement or other reasons, a participant is eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments for a specified form or dollar amount. Participants may also elect to roll over funds into another qualified plan or individual retirement account. Additionally, participants are permitted to make in-service withdrawals of account balances from the Plan. To qualify for this type of withdrawal, the participant must have attained the age of 59½ or must meet certain criteria for a hardship withdrawal, as outlined in the plan document; see below.

Hardship withdrawals - A participant may apply for a hardship withdrawal to assist in the payment of several types of personal hardships, as defined by the plan agreement. Any hardship distribution is limited to the amount necessary to meet the financial need.

Plan termination - Although the Company has not expressed any intent to do so, the Company has the right under the plan document to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Investments held by the Plan are stated at fair value (see Note 4) with the exception of the Putnam Stable Value Fund investment, which is a common collective trust that is valued at net asset value (NAV) as a practical expedient as reported by the sponsor of the fund; see below. All fair values have been maintained and certified by Fidelity Management Trust Company, the Trustee of the Plan, (see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The Putnam Stable Value Fund is a common collective trust fund that is made up of various investment and security-backed contracts, which are mainly publicly traded securities. Common collective trusts are valued at NAV per share, which serves as a practical expedient to estimate its fair value. The NAV of common collective trusts is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases

and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Investments measured at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy.

The Plan holds a life insurance policy issued by Genworth Life and Annuity Insurance Company. This policy is for the benefit of the participant insured and may be distributed or surrendered at the participant's direction. Premiums shall be paid first from policy dividends and other amounts from the accumulated cash value. If these sources are insufficient, premiums shall be paid from salary reduction contributions, subject to limits as established by the provisions of the plan document. This policy is fully allocated to the insured participant's account, with the change in cash surrender value recorded as part of net appreciation in investments in the statements of changes in net assets available for benefits.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviews all notes receivable balances that exceed ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balance that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance, if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Payment of benefits - Benefits are recorded as paid.

Administrative costs - Administrative costs, including maintaining participant accounts, legal costs, and accounting costs, are the obligation of the Plan; however, the plan sponsor may pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments are paid directly out of the Plan's assets (see Note 5).

Economic dependency and concentration of credit risk - Approximately 90% and 87% of the Plan's investments are invested with American Funds as of December 31, 2024 and 2023, respectively. Accordingly, the Plan is dependent upon the financial condition of this company.

Subsequent events - Management has evaluated subsequent events through October 13, 2025, the date that the financial statements were available for issue.

Note 3 - Information certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in investments, dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4 - Fair value measurements

The Financial Accounting Standards Board has published authoritative guidance on fair value measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies (i.e., Mutual Funds) - Valued at net asset value of shares, which are valued at the closing price reported on the active market on which the individual securities are traded (Level 1).

Self-Directed Brokerage Accounts - Contains common stocks, which are valued at the closing price reported on the active market on which the individual securities are traded (Level 1).

Money Market Funds - Managed portfolios, which consist of U.S. Government obligations valued at the closing price reported on the active market on which the individual security is traded (Level 2).

Other - Consists of a life insurance policy, which is valued at the cash surrender value of the policy (Level 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 5 - Related party transactions

The Plan's investments are managed by Fidelity Management Trust Company, the Trustee of the Plan. Fees paid for these services qualify as party-in-interest transactions and are included in the net appreciation in investments in the accompanying statements of changes in net assets available for benefits. Furthermore, the Plan contracts with Fidelity Investments Institutional to provide recordkeeping and third-party administrative services, which qualify as party-in-interest transactions. Fees paid for these services amounted to \$52,331 and \$52,419 for the years ended December 31, 2024 and 2023, respectively, which are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. The Plan contracts with Clearview Wealth Advisors, LLC to provide investment advisory services, which qualify as party-in-interest transactions. Fees paid for these services amounted to \$42,951 and \$42,277 for the years ended December 31, 2024 and 2023, respectively, which are included in administrative expenses in the statements of changes in net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 6 - Tax status

The Plan has adopted the Fidelity Basic Plan Document No. 17. The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the years ended December 31, 2024 or 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2021.

Note 7 - Reconciliation of the financial statements to Form 5500

Form 5500 may have certain investment balances, income and expense items that differ from amounts shown on the accompanying financial statements. These differences relate to classification and rounding only and have no effect on the net assets available for benefits nor changes in net assets available for benefits as of December 31, 2024 and 2023, and for the years then ended.
