### Note 1: Description of Plan

The following description of the Highland Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was formed on January 1, 2024. The Plan is a defined contribution plan covering substantially all employees of Highland Bank and Wall Companies (collectively the Company) who are age 18 and have completed 1 month of service. Participants may enter the Plan on the first day of the month after meeting eligibility requirements. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Retirement Plan Committee. The Committee has the power to carry out provisions of the Plan, including the administering of Plan, and to determine the appropriateness of the Plan's investment offerings, and monitoring performance.

Effective January 1, 2024, assets from the Boundary Waters Bank 401k Savings Plan and the Wall Companies Plan were merged into the Plan.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### Contributions

Participants may defer a portion of their eligible compensation, as defined in the Plan, in whole percentages up to 100%, subject to the maximum amounts allowed by the Internal Revenue Code (IRC). These contributions may be made on either a pretax basis or after tax basis (through Roth contributions). Participants who attain age 50 or older are also eligible to make catch-up contributions, subject to the maximum amounts allowed by the IRC. Under provisions of the IRC, the Plan also allows participants to roll over funds from other qualified plans.

The Plan allows for safe harbor matching contributions. The Company provides safe harbor matching contributions to eligible employees equal to 100% of the first 4% of eligible compensation. The safe harbor matching contribution for 2024 totaled \$422,412.

Discretionary nonelective contributions may be made by the Company to participants of the Plan. Discretionary nonelective contributions can be made to eligible participants employed at the end of the Plan year who have completed 1,000 hours of service during the plan year. There were no discretionary nonelective contributions for the year ended December 31, 2024.

#### Contributions (Continued)

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated age-weighted fund until charged by the participant.

#### Investment options

Upon enrollment to the Plan, a participant may direct deferrals and Company contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution and an allocation of (a) the Company discretionary nonelective contributions and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are 100% vested in their rollover contributions, deferral contributions, safe harbor matching contributions and any earnings thereon. Balances attributable to Company nonelective contributions shall vest based on the participant's years of service according to the table below. Vesting under the Plan is based on elapsed time method. Hours of service are not counted and instead periods of service are computed.

#### Forfeitures

At December 31, 2024, forfeited nonvested accounts totaled \$4,422. These accounts will be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. Also, during the year ended December 31, 2024, forfeited nonvested accounts of \$85 were used to pay administrative expenses.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or employment a participant may elect to receive a lump-sum, install payment or partial withdrawals amount equal to the value of the participant's vested interest in his or her account. Upon termination, participants with an account balance of \$7,000 or less will have their account automatically rolled over to an individual retirement account with Fidelity. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans have terms ranging from one to five years, or may not extend beyond 30 years from the date of loan for the purchase of a primary residence, and are secured by the balance in the participant's account. The participant may only have 2 loans outstanding at any given time. At December 31, 2024, interest rates on loans ranged from 3.25% to 9.50% maturing at various dates between 2025 and 2029. Principal and interest are paid ratably through biweekly payroll deductions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Investment Valuation and Revenue Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for additional information on the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Contributions**

Participant contributions and related Company safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

#### **Administrative Expenses**

Administrative expenses are paid by the Plan unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **Note 3: Information Certified or Provided by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and, notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value in accordance with Accounting Standards Codification (ASC) Topic 820. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants shall become 100% vested and shall be distributed to the participants or their beneficiaries.

### Note 6: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7: Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for services rendered were \$22,005 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Plan is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Plan's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Plan. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2024, totaling \$10,235, were remitted outside the 15-day requirement. These transactions constitutes a prohibited transaction as defined by ERISA. In July 2025, the Company received notification through VFCP that the late contributions had been fully corrected.

### **Note 10: Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Highland Bank 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Highland Bank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### Note 1: Description of Plan

The following description of the Highland Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was formed on January 1, 2024. The Plan is a defined contribution plan covering substantially all employees of Highland Bank and Wall Companies (collectively the Company) who are age 18 and have completed 1 month of service. Participants may enter the Plan on the first day of the month after meeting eligibility requirements. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Retirement Plan Committee. The Committee has the power to carry out provisions of the Plan, including the administering of Plan, and to determine the appropriateness of the Plan's investment offerings, and monitoring performance.

Effective January 1, 2024, assets from the Boundary Waters Bank 401k Savings Plan and the Wall Companies Plan were merged into the Plan.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### Contributions

Participants may defer a portion of their eligible compensation, as defined in the Plan, in whole percentages up to 100%, subject to the maximum amounts allowed by the Internal Revenue Code (IRC). These contributions may be made on either a pretax basis or after tax basis (through Roth contributions). Participants who attain age 50 or older are also eligible to make catch-up contributions, subject to the maximum amounts allowed by the IRC. Under provisions of the IRC, the Plan also allows participants to roll over funds from other qualified plans.

The Plan allows for safe harbor matching contributions. The Company provides safe harbor matching contributions to eligible employees equal to 100% of the first 4% of eligible compensation. The safe harbor matching contribution for 2024 totaled \$422,412.

Discretionary nonelective contributions may be made by the Company to participants of the Plan. Discretionary nonelective contributions can be made to eligible participants employed at the end of the Plan year who have completed 1,000 hours of service during the plan year. There were no discretionary nonelective contributions for the year ended December 31, 2024.

#### Contributions (Continued)

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated age-weighted fund until charged by the participant.

#### Investment options

Upon enrollment to the Plan, a participant may direct deferrals and Company contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution and an allocation of (a) the Company discretionary nonelective contributions and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are 100% vested in their rollover contributions, deferral contributions, safe harbor matching contributions and any earnings thereon. Balances attributable to Company nonelective contributions shall vest based on the participant's years of service according to the table below. Vesting under the Plan is based on elapsed time method. Hours of service are not counted and instead periods of service are computed.

#### Forfeitures

At December 31, 2024, forfeited nonvested accounts totaled \$4,422. These accounts will be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. Also, during the year ended December 31, 2024, forfeited nonvested accounts of \$85 were used to pay administrative expenses.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or employment a participant may elect to receive a lump-sum, install payment or partial withdrawals amount equal to the value of the participant's vested interest in his or her account. Upon termination, participants with an account balance of \$7,000 or less will have their account automatically rolled over to an individual retirement account with Fidelity. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans have terms ranging from one to five years, or may not extend beyond 30 years from the date of loan for the purchase of a primary residence, and are secured by the balance in the participant's account. The participant may only have 2 loans outstanding at any given time. At December 31, 2024, interest rates on loans ranged from 3.25% to 9.50% maturing at various dates between 2025 and 2029. Principal and interest are paid ratably through biweekly payroll deductions.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Investment Valuation and Revenue Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for additional information on the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Note 2: Summary of Significant Accounting Policies** (Continued)

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Contributions**

Participant contributions and related Company safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

#### **Administrative Expenses**

Administrative expenses are paid by the Plan unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **Note 3: Information Certified or Provided by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and, notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value in accordance with Accounting Standards Codification (ASC) Topic 820. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants shall become 100% vested and shall be distributed to the participants or their beneficiaries.

### Note 6: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7: Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for services rendered were \$22,005 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Plan is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Plan's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Plan. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2024, totaling \$10,235, were remitted outside the 15-day requirement. These transactions constitutes a prohibited transaction as defined by ERISA. In July 2025, the Company received notification through VFCP that the late contributions had been fully corrected.

### **Note 10: Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.
