The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for plan benefits for the period from July 1, 2024 (inception) to December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the period from July 1, 2024 (inception) to December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**(1) Description of the Plan**

The following description of the M.S. Ambrogio North America LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a qualified defined contribution profit sharing plan with a cash deferral arrangement covering all eligible employees of M.S. Ambrogio North America LLC (the "Company" or the "Employer"). Members of a collective bargaining unit and nonresident aliens are ineligible to participate. The Plan was established on July 1, 2024 when the assets were transferred from an existing Pooled Employer Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**(b) Eligibility**

Employees of the Company, as defined in the Plan, are eligible to participate in the Plan upon attaining age 18 and completing five consecutive months of eligibility service. Participants are eligible for employer safe harbor matching, non-elective safe harbor, and profit sharing contributions upon becoming eligible to participate in the Plan. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of the month coinciding with or next following their eligibility date.

**(c) Employee Contributions**

Participants may elect to defer pre-tax or after-tax Roth contributions up to 92% of their annual compensation in increments of 1%, as defined in the Plan, subject to maximum limits set by the Internal Revenue Code ("IRC"). Participants who have reached the age of 50 before the end of the year may contribute additional catch-up contributions not to exceed IRC limits. Participants may also contribute amounts representing rollovers from other qualified plans.

**(d) Employer Contributions**

The Company makes a safe harbor matching contribution of 75% of participant contributions that are not in excess of 6% of participant compensation.

The Company makes a non-elective safe harbor contribution equal to 3% of an employee's eligible compensation. In order to share in the nonelective contribution, employees must have completed at least 1,000 hours of service.

The Company may make a profit sharing contribution as permitted by the Plan. In order to share in the profit sharing contribution, employees must have completed at least 1,000 hours of service and be employed by the Company on the last day of the Plan year. The Company did not make a profit sharing contribution for the period ended December 31, 2024.

***(e) Participant Accounts***

Each participant's account is credited with (a) the participant's elective deferrals and rollover contributions, (b) the Company's safe harbor matching, non-elective safe harbor, and profit sharing contributions, and (c) net investment earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

***(f) Vesting***

All participant accounts are 100% vested immediately.

***(g) Notes Receivable from Participants***

Participants may borrow from a minimum of \$1,000, up to 47.5% of their vested account balance, provided the loan does not exceed \$50,000, subject to certain Internal Revenue Service ("IRS") limitations. Participants are permitted two outstanding loans. Notes are to be repaid within 4½ years, unless the note is for a primary residence, which is to be repaid within 10 years. Notes are secured by the remaining vested balance in the participant's account. Interest is charged at a reasonable rate, as defined by the Plan. Loans are collateralized by the participant's account.

***(h) Payment of Benefits***

Upon termination of service due to death, disability, retirement, or termination of employment, a participant receives an amount equal to the value of the participant's vested interest in their account in either lump sum, partial payments, installment payments, or annuity contracts.

For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If a terminated participant's vested balance is less than \$7,000, it is mandatory that the benefits be distributed from the Plan. Involuntary lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. A participant may withdraw rollover contributions at any time.

In-service distributions are allowable within the Plan, once a participant reaches age 59½ or the Plan's normal retirement age. The Plan also allows hardship distributions under Federal rules.

Under SECURE Act and SECURE 2.0 Act, the Plan allows for an exception to the early withdrawal penalty for distributions up to \$1,000 annually used for emergency expenses. It also allows the Plan to permit participants that self-certify that they experienced domestic abuse to withdraw up to the lesser of \$10,000 (or 50% of the vested balance) within one year of the incident without penalty.

**(2) Summary of Significant Accounting Policies**

***(a) Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***(b) Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

***(c) Risks and Uncertainties***

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

***(d) Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

***(e) Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***(f) Payment of Benefits***

Benefit payments are recorded when paid.

***(g) Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

***(h) Subsequent Events***

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available for issuance.

**(3) Information Certified by the Plan's Trustee and Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company, the trustee of the Plan, and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the custodian of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for plan benefits as of December 31, 2024, the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected on the statement of changes in net assets available for plan benefits for the period from July 1, 2024 (inception) to December 31, 2024.

**(4) Fair Value Measurements**

Generally accepted accounting principles in the United States of America establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). All mutual funds and money market funds are classified as Level 1. These totaled \$7,685,313 as of December 31, 2024.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Investment Contract**

The Plan entered into fully benefit-responsive investment contracts. Because the investment contracts are fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption from ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) violation of a material obligation under the contract, or (d) a material misrepresentation.

The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants were probable of occurring.

The investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

**(7) Income Tax Status**

The Plan is based on a prototype plan that has received a favorable determination letter from the Internal Revenue Service dated August 31, 2020 as a prototype non-standardized plan, which is acceptable under Section 401 of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**(8) Withdrawing Participants**

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

**(9) Related Party Transactions**

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

**(10) Reconciliation of Financial Statements to Form 5500**
