## **1. Description of Plan**

The following description of the Budweiser of Columbia 401(k) Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan which provides retirement benefits to certain employees of KW Associates, LLC (the "Company"). Employees who have attained the age of twenty-one and completed three months of service with the Company are eligible to participate in the Plan. In addition, employees who have attained the age of twenty-one and completed one-year of service or one thousand work hours are eligible to receive profit-sharing contributions and matching employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Contributions**

Participants may contribute up to 90% of their pre-tax compensation (subject to allowable legal limits) as defined by the Plan. Participants who have attained age fifty before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. Participants may elect to allocate current contributions among a variety of investment options. The allocations remain in effect until a new election is made. The Company may make discretionary profit-sharing and matching contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of employer contributions, if any, Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. Earnings and losses are allocated by investment based on the ratio of a participant's account invested in a particular investment to all participants' investment balances.

### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 for all open loan balances or 50% of their vested account balance.

## **1. Description of Plan (continued)**

### **Participant Notes Receivable (continued)**

The maximum note receivable term is five years, except for a note receivable to purchase a principal residence, for which the term is twenty years. The notes receivable are collateralized by the balance in the participant's account and, at December 31, 2024, bear interest at rates ranging from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

### **Vesting**

Participants vest in employer matching and profit-sharing contributions at a rate of 20% per year beginning with the first year of service through the fifth year of service, at which time they are fully vested. Participants are 100% vested in their participant contributions at all times.

### **Forfeitures**

In accordance with the Plan document, available forfeitures may be used first to offset Plan administrative expenses, and any remaining forfeitures may be used to offset employer contributions. At December 31, 2024 and 2023, unallocated forfeited non-vested accounts total approximately \$3,000 and \$4,000, respectively. The Plan used approximately \$25,000 and \$23,000 to offset employer contributions during the years ended December 31, 2024 and 2023, respectively.

### **Payment of Benefits**

Upon retirement, disability, death, termination of employment, or attainment of age 59½, participants or their beneficiaries may elect to receive their vested portion of Plan assets in a single distribution or by other distribution methods as allowed under the Plan. Upon termination of employment for reasons other than retirement, disability, or death, the participant's vested interest in the Plan will be paid to the participant as soon as administratively feasible upon participant request of a distribution. A lump sum payment will be automatically distributed for balances not exceeding \$1,000.

### **Plan Termination**

Subsequent to year-end, the Company was purchased by a third party. Plan management intends to terminate the Plan and distribute the Plan's assets by December 31, 2025. As of December 31, 2024 and through the date the financial statements were available to be issued, no formal election to terminate the Plan has been made. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States (“US GAAP”).

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Participant Notes Receivable**

Participant notes receivable are measured at their unpaid principal balance, plus any accrued, but unpaid interest. If a participant does not make repayments and the Plan Administrator considers the participant note receivable to be in default, the note receivable balance will become immediately due and payable, and the delinquent participant note receivable is recorded as a deemed distribution based on the terms of the Plan document.

### **Administrative Expenses**

The Plan allocates a portion of participants’ accounts to pay administrative fees. All other professional fees are paid by the Company.

### **Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as investments held during the year.

### **Risks and Uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

### **3. Trustee Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, participant notes receivable, net appreciation in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company (the "Trustee").

### **4. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits.

The methods used to measure fair values of the Plan's investments may produce amounts that may not be indicative of net realizable value or may not be reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's mutual fund investments, and interest-bearing cash were valued using Level 1 inputs, based on quoted market prices.

**4. Fair Value Measurements (continued)**

The Plan's investments include the Fidelity Advisor Stable Value Portfolio ("FASV"), which is a collective trust whereby the underlying investments primarily consist of fully benefit-responsive investment contracts, fixed income securities, and money market funds. FASV is valued at fair value using Level 2 inputs as calculated by the qualified institution by aggregating the fair value of the underlying investments (valued using Level 1 inputs). The qualified institution allocates fair value to the Plan using the percentage of the Plan's investment in FASV at contract value. This Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the account provider reserves the right to temporarily delay withdrawal from the collective trust in order to ensure that security liquidations will be carried out in an orderly business manner.

**5. Party-in-Interest Transactions**

The Plan holds investments that are managed by the Trustee. All transactions with the Trustee qualify as party-in-interest transactions. Administrative fees refunded by the Trustee to the Plan for custodial, recordkeeping, and investment advisory services amounted to approximately \$10,000 and \$7,000 for the years ended December 31, 2024 and 2023. The refunds are due to carryovers from prior years in a revenue crediting account provided to the Plan by the Trustee.

Participant notes receivable amount to approximately \$807,000 and \$847,000 as of December 31, 2024 and 2023 and qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules as defined by ERISA.

**6. Income Tax Status**

The Plan operates under a volume submitter plan document. The Internal Revenue Service ("IRS") issued an opinion letter for the volume submitter on June 30, 2020, stating that the form of the volume submitter plan was acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the Plan has been amended since the date of the letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
