Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in notes to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements, referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers' ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DESCRIPTION OF PLAN:

The following description of Retirement Income Plan of Detroit Typographical Union No. 18 With Detroit Newspaper Publishers provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General-The Plan is a multi-employer plan administered by a board of administration consisting of two representatives from Detroit Typographical Union #18 and one representative appointed by each employer. This plan is a parallel plan with other Detroit Newspaper Publishers Plans. All funds are held by JPMorgan Chase Bank, N.A. Plan year end is a normal calendar year. Normal age of retirement is sixty-five years. Cost of benefits is paid by employer in accordance with collective bargaining agreements. Employee becomes participant when employed by participating employer and represented by collective bargaining agreement between employer and union.

Vesting-Vesting occurs at either ten years of vesting service or two years of credited service. Some employees are eligible for joint survivor benefits.

Funding Policy-No contributions by either employers or employees are allowed or required.

Payment of Benefits-Upon termination of service, benefits will be paid as monthly annuity payments or by lump sum distribution. Further restrictions apply to payment methods; these restrictions are listed in the Plan agreement.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Estimates-The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments-The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits-Benefits are recorded when paid.

OTHER COMMITMENTS:

To the best of our knowledge, there are no material lease commitments, contingent liabilities or transactions with persons known to be parties in interest as of December 31, 2024.

TAX STATUS:

The Internal Revenue Service has determined and informed the Plan by a letter dated March 8, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

The Plan files Form 5500 annually with the Internal Revenue Service. The tax years that remain open for examination under the IRS are 2021, 2022, and 2023.

TERMINATION OF PLAN:

On June 18, 1990, the Plan was amended to start termination proceedings. The employers and the Union have decided to cease further accrual of benefits effective July 15, 1990 in relation to the termination. The employers and the union, acting pursuant to Section 4041A(a)(1) of ERISA and Section 9.3 of Article IX of the Plan document, have terminated the plan effective December 31, 1991. In this termination process, there is, however, a contingency. The Plan has applied to the Pension Benefit Guarantee Corporation (PBGC) for a private letter ruling in regards to the single versus multi-employer plan question. The PBGC issued a ruling that the Plan is a multi-employer plan, therefore, the Plan terminated December 31, 1991.

In February 2002, the Plan was restated in its entirety and amended to consolidate amendments made since its last restatement and to further comply with the requirements of the Internal Revenue Code of 1986 as amended through GUST so as to maintain its qualified status. The PBGC has given cursory approval to these actions.

CRITICAL STATUS:

The Plan was first certified by the plan actuary to be in endangered status for the January 1, 2008 plan year and has adopted a Rehabilitation Plan. From the January 1, 2009 plan year until June 30, 2013, the plan was classified as critical. All plan participants and beneficiaries have been notified of these matters.

Under federal pension law, a plan generally will be considered to be in “endangered” status if, at the beginning of the plan year, the funded percentage of the plan is less than 80 percent or in “critical” status if the percentage is less than 65 percent. If a pension plan enters endangered status, the trustees of the plan are required to adopt a funding improvement plan. Similarly, if a pension plan enters critical status, the trustees of the plan are required to adopt a rehabilitation plan. Rehabilitation and funding improvement plans establish steps and benchmarks for pension plans to improve their funding status over a specified period of time.

REHABILITATION PLAN:

Federal law requires pension plans in critical status to adopt a rehabilitation plan aimed at restoring the financial health of the plan. The law permits pension plans to reduce, or even eliminate, benefits called “adjustable benefits” as part of a rehabilitation plan. On December 7, 2009, the Board of Administration of the Plan finalized and implemented a rehabilitation plan eliminating or reducing adjustable benefits.

PLAN INSOLVENCY:

On April 30, 2013, participants were notified that the Plan was insolvent and had requested financial assistance from the Pension Benefit Guaranty Corporation (PBGC). The Plan became insolvent in June of 2013.

On June 18, 2013, the Plan took a promissory note for a loan from the PBGC in the amount of \$152,000.00. The Plan also received an additional loan of \$143,000.00 in 2013. In 2014, the Plan received additional loans of \$143,000.00 and \$251,000.00. In 2015, the Plan received additional loans of \$181,000.00 and \$189,000.00. In 2016, the Plan received additional loans of \$180,500.00 and \$115,200.00. In 2017, the Plan received additional loans of \$184,100.00 and \$153,900.00. In 2018, the Plan received additional loans of \$163,700.00 and \$109,500.00. In 2019, the Plan received additional loans of \$107,200.00 and \$122,500.00. In 2020, the Plan received additional loans of \$172,000.00 and \$113,700.00. In 2021, the Plan received additional loans of \$115,200.00 and \$110,700.00. In 2022, the Plan received additional loans of \$95,200.00 and \$149,500.00. In 2023, the Plan received additional loans of \$122,800.00 and \$111,300.00. In 2024, the Plan received additional loans of \$179,000.00 and \$95,100.00. The Plan is recording the loan amounts as income due to the financial condition of the Plan and the inability of the Plan to repay the loans. The loans are considered uncollectible by the PBGC. The PBGC will continue to fund the Plan to pay benefits.
