Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Udelhoven 401(k) Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

1. Description of Plan

The Udelhoven 401(k) Plan & Trust (the Plan) covers eligible employees of Harding Holdings, Inc. and its wholly-owned subsidiaries, Udelhoven Oilfield System Services, Inc.; Udelhoven, Inc.; and Udelhoven International, Inc. (collectively referred to as the Company). The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. *General* – The Plan is a defined contribution plan commonly referred to as a 401(k) plan. The Plan covers all employees of the Company who are 18 years of age or older, who are not non-resident aliens, and who are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Board of Directors of the Company. John Hancock Life Insurance Company (USA), hereinafter John Hancock, is the custodian of the Plan.

- b. *Contributions* – Each year, participants may contribute up to the maximum amount allowed by Internal Revenue Service Guidelines. Participants who have attained age 50 before the end of the Plan year may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers participants the opportunity to contribute to investment options under a group annuity contract with John Hancock, the U.S. division of Manulife Financial Corporation based in Toronto, Ontario.

Employer-matching contributions are not allowed by the Plan.

- c. *Participant Accounts* – Each participant's account is credited with the participant's contributions and the participant's share of the Plan's investment income (loss). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. *Vesting* – Participants are immediately 100 percent vested in their contributions plus actual earnings thereon.

1. Description of Plan, Continued

- e. *Note Receivable from Participants* – The Plan does not allow loans to participants.
- f. *Payment of Benefits* – On termination of service due to reasons other than death, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or as partial distributions if so elected by the participant. Additionally, the individual may remain a participant in the Plan until he or she elects to take the lump-sum or partial distributions.

For termination of service due to death, payments to a participant's beneficiary will be made in accordance with the Plan and with applicable IRS code sections.

Participants may also request an in-service distribution of their account balance for purposes of satisfying a financial hardship, under certain circumstances specified in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See note 4 for discussion of fair value measurements.

2. Summary of Significant Accounting Policies, Continued

Investment Valuation and Income Recognition, Continued

Pooled separate accounts invested directly in mutual funds are valued at the net asset value of shares held by the Plan at year end. General accounts invested in John Hancock Stable Value Guaranteed Income Fund are not fully benefit responsive and, as such, are valued at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Other investment income is recorded on the accrual basis. Since the investments are pooled separate accounts, investment income is included in net appreciation (depreciation) in fair value of investments.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions and earnings.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements.

Subsequent Events

No events requiring adjustment to or disclosure in the financial statements have occurred subsequent to December 31, 2024. The Plan evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. Information Certified by John Hancock

Plan management has elected a 103(a)(3)(C) audit as permitted by ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, and the ERISA-required supplemental schedule as of December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the plan. This information includes:

- Investments at fair value
- Net appreciation (depreciation) in fair value of investments
- Fair value information included in note 4
- Schedule of assets (held at end of year)

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- The fair value of the underlying pooled separate accounts, invested directly in mutual funds, equals the number of shares of the respective underlying fund held by the Plan at year end, multiplied by the closing net asset value per share quoted by that fund.
- The fair value of the general account invested in the John Hancock Stable Value Guaranteed Income Fund, equals the number of shares of that fund held by the Plan at year end, multiplied by the closing net asset value per share quoted by that fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

John Hancock is a party in interest since it is the trustee and recordkeeper for the Plan. John Hancock selects funds, manages funds, and negotiates with various fund managers for management under pooled separate accounts.

As mentioned in note 2, administrative expenses are allocated to participant accounts for expenses to be paid by the Plan. The Plan has a revenue sharing agreement with John Hancock whereby excess revenues are accounted for in a Plan Expense Recovery Account (PERA). The Plan allows the PERA balances to be used to pay Plan administrative expenses or to be allocated to the accounts of the participants. A summary of the PERA transactions are as follows for the years ended December 31:

6. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Company has adopted a prototype plan document and is relying on the Prototype Sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the prototype plan may have been amended since receiving the opinion letter, the Prototype Sponsor and the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. No uncertain tax positions that qualify for either recognition or disclosure in the financial statements exist at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Excess Contributions Payable

The Plan failed to pass the Average Deferral Percentage (ADP) Test for 2023. Accordingly, payments to participants totaling \$31,785 were made in 2024 to return excess contributions and related earnings, in order to comply with the nondiscriminatory provisions of the Plan.

The Plan passed the Average Deferral Percentage (ADP) Test for 2024 and, as such, there were no excess contributions payable at December 31, 2024.
