## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Henderson, Hutcherson & McCullough, PLLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

## Notes to Financial Statements

---

### 1. Description of Plan

The following description of The Henderson, Hutcherson & McCullough, PLLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan available to substantially all employees of Henderson, Hutcherson & McCullough, PLLC and HHM Bookkeeping Solutions, LLC, a company related through common ownership (collectively, the “Company”), who have attained the age of 21. Eligible employees may begin participation as of January 1, April 1, July 1, or October 1 of the year in which they meet the eligibility requirements. Participants are eligible to receive Company matching and profit sharing contributions upon the completion of one year of eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees may elect to contribute a percentage or dollar amount of their pre-tax and/or after-tax (“Roth”) annual compensation, as defined in the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company may make discretionary matching contributions at a rate to be determined annually. For 2024 and 2023, the Company matched 100% up to the first \$3,500 of base compensation that each participant contributed to the Plan. Participants must complete 1,000 hours of service and be employed on the last day of the plan year in order to receive the Company’s contribution.

Upon enrollment in the Plan, a participant may direct participant and Company contributions in any of the investment options offered through the Plan. Participants may change their investment options at any time. Participants may change their deferral percentages quarterly on January 1, April 1, July 1, and October 1.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions, plus any income or loss thereon. Vesting in the Company’s contributions, plus any income or loss thereon, is based on years of continuous service according to the following schedule:

#### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or separation, participants may elect to receive a lump-sum payment equal to the value of the participant’s vested account balance. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan.

### 1. Description of Plan (Concluded)

#### ***Forfeitures***

Forfeitures from non-vested participant accounts may be used to offset plan administrative expenses or future Company contributions. During 2024 and 2023, forfeitures of approximately \$5,000 and \$36,000 were utilized to offset the Company's discretionary matching contributions. Forfeited non-vested accounts of approximately \$3,500 and \$0 were available as of December 31, 2024 and 2023.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested account balance in the participant's account and bear interest at a commercially reasonable rate. Terms are generally up to five years and only one note can be outstanding at a time. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, such as those for custodial and third-party administrative services, may be paid by the Plan. Distribution and note receivable fees are paid from affected participant accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the American United Life Insurance Company ("AUL") Stable Value Account.

### 2. Summary of Significant Accounting Policies (Concluded)

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through September 30, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL, the Plan's custodian.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a non-standardized plan document utilized by ERISA Services, Inc. The IRS has determined and informed ERISA Services, Inc. by a letter dated June 1, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan investments are invested in funds managed by AUL. Administrative fees paid by the Plan to AUL for administrative services were approximately \$1,3000 and \$1,700 during 2024 and 2023. AUL is the custodian of the Plan and, as such, these transactions qualify as party-in-interest.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurements***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered separate accounts:* These investments are based on the market value of the underlying investments, which represents the net asset value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

*Self-directed brokerage accounts:* These are comprised primarily of mutual funds, money market funds and common stocks. Mutual funds and money market funds are valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market. Common stocks are valued at the closing price reported on the active market on which the securities are traded. These investments are classified as Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Investments at Contract Value

The AUL Stable Value Account is a group fixed annuity issued by AUL. Principal and accumulated interest are backed by AUL's general account assets. An interest rate is declared prior to the beginning of each calendar year and is guaranteed for that year until the next year's rate is set. As of December 31, 2024 and 2023, the interest rate was 1.75% and 1.25%, respectively. Participants may generally transfer their account balance from the AUL Stable Value Account to any other investment option offered under the Plan at any time without restrictions or penalties.

### 10. Subsequent Event

Effective July 2025, the Plan changed its respective custodian and recordkeeping service providers from AUL and OneAmerica Financial Partners, Inc. to Empower Trust Company and Empower Retirement Services.
