## **INDEPENDENT AUDITORS' REPORT**

Board of Trustees of

### **Opinion**

We have audited the financial statements of Motion Picture Laboratory Technicians Local 702 Pension Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Motion Picture Laboratory Technicians Local 702 Pension Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Motion Picture Laboratory Technicians Local 702 Pension Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Motion Picture Laboratory Technicians Local 702 Pension Fund (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and its Summary Plan Description for a more complete description of the Plan's provisions.

**General:** The Plan was a collectively bargained multi-employer defined benefit pension plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (ERISA). The benefits earned depended on the duration of participation in the Plan and the level of member’s employment. The Plan was established December 1955 between the Motion Picture Laboratory Technicians Union Local 702 (The Union), and all employers signing a Collective Bargaining Agreement with the Union, providing for the contributions to the Pension Fund.

**Plan Administration:** The administration of the Plan is the responsibility of a Board of Trustees composed of Union and Employer Trustees. The Union Trustees and Employer Trustees have equal voting rights.

**Pension Benefits:** The Plan was established to provide pension benefits to the Plan’s eligible participants. Benefits provided included normal, early retirement, disability, survivors, five-year certain pension, and death benefits. A full description of Plan benefit provisions is available in the Rules and Regulations of the Plan as amended and restated.

**Funding:** The Plan does not receive any employer contributions; it is funded by the Pension Benefit Guaranty Corporation (PBGC).

**Termination:** The Plan's Board of Trustees, as sponsor, has the right under the Plan to modify benefits provided to participants. The Plan may be terminated by the vote of the Board, subject to the provisions set forth in the Agreement and Declaration of Trust and ERISA.

As described in Note 7, the Plan depends on funding from the Pension Benefit Guaranty Corporation to pay benefits.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Payment of Benefits:** Benefit payments to participants are recorded upon distribution.

**NOTE 3 – TAX STATUS**

The Plan is qualified under Section 401(a) of the Internal Revenue Code, and its related trust is exempt from income tax under Section 501(a) of the Internal Revenue Code. The Plan has obtained an exemption letter from the IRS stating the Plan and related Trust are designed in accordance with applicable sections of the IRS. Plan management believes that the Plan as designed is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the related trust is tax exempt. Consequently, no provision for income taxes has been included in the Plan’s financial statements.

**NOTE 4 – PLAN TERMINATION PRIORITIES**

As the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Vested benefits insured by the PBGC up to the applicable limitations.
2. All nonvested benefits.

Benefits under the Plan are insured by the PBGC. As the Plan terminates its net assets generally will not be available on a pro rata basis to provide participants' benefits. Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty, whereas other benefits may not be provided for at all.

A full description of the Plan's termination priorities is available in the Plan's rules and regulations, as amended and restated.

**NOTE 5 – CONCENTRATION OF CREDIT RISK**

Financial instruments that subject the Plan to concentration of credit risk include cash and short-term investments. While the Plan attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits. Short-term investments are not covered by the Federal Deposit Insurance Corporation.

**NOTE 6 – EVALUATION OF SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through June 12, 2025, the date the financial statements were available to be issued.

**NOTE 7 – PENSION BENEFIT GUARANTY CORPORATION FUNDING**

Employer contributions to the Plan ceased as of December 31, 1985. As a consequence, the Plan requires PBGC funding to meet its obligation for benefit payments.

At least ten (10) days before the end of each calendar year, the Plan provides the PBGC a schedule showing the value of its assets, including outstanding claims for withdrawal liability that are reasonably expected to be collected, valued in accordance with 29 C.F.R. Part 4281 (which requires that the present value of future reasonable administrative expenses and the present value of repayments of financial assistance to the PBGC be deducted from the value of the Plan's assets).

**NOTE 8 – ACTUARIAL VALUATION**

Since the Plan is being funded by the PBGC, an actuarial valuation is not required unless specifically requested. At the request of the PBGC, the Plan's actuary last performed a valuation as of December 31, 2023, the results of which are summarized hereunder.
