Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Texas Champion Bank 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan

The following description of the Texas Champion Bank 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Texas Champion Bank and Agrow Credit Corporation, a wholly-owned subsidiary of Texas Champion Bank (collectively, the "Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2022, the Plan was amended and restated to adopt a volume submitter ("VS") profit sharing plan, the FIS Business Systems LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA.

The amended and restated Plan reflects the most recent statutory and regulatory changes applicable to plans maintained under Code Section 401(a) and 401(k) of the Internal Revenue Code ("IRC").

Administration of the Plan

The Company serves as the Plan administrator and, accordingly, certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. Empower Annuity Insurance Company of America serves as administrative agent on behalf of Talcott Resolution Life Insurance Company (the "Custodian"), the Plan's custodian.

Eligibility

Employees who have reached 18 years of age and completed six months of service are immediately eligible to participate in the Plan except employees covered by a collective bargaining agreement and nonresident aliens.

Contributions

Participants may make contributions to the Plan on a pre-tax basis through payroll withholding of any whole percentage up to 100% of their eligible compensation. Contributions may not exceed the limitation (\$23,000 in 2024 and \$22,500 in 2023) set forth in Section 402(g) of the IRC. Participants may make catch-up contributions (pre-tax contributions that exceed the annual elective deferral limit) during any calendar year ending on or after the participant's 50th birthday. A participant's total catch-up contribution is limited to a maximum of \$7,500 per year in both 2024 and 2023. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans. The Plan is participant directed, and participants may change their contribution rates or investment options at any time.

For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions equal to 100% of the participant's pre-tax contribution, not to exceed 3% of the participant's compensation, and 50% of the participant's pre-tax contribution, not to exceed an additional 2% of the participant's compensation. For the years ended December 31, 2024 and 2023, the Company made safe harbor contributions totaling \$128,007 and \$129,877, respectively. The Company's safe harbor matching contributions are invested directly in the various investment options, as directed by the participant.

The Company may also make discretionary additional matching contributions or profit-sharing contributions on behalf of each participant. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary matching or profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' accounts in that fund. Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan, continued

Notes Receivable from Participants

Plan participants may borrow from the vested portions of their account balances a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 less the highest outstanding loan balance in the last twelve months or (b) 50% of their vested account balances. Participants may have only one loan outstanding at any time. Loans are repaid through payroll deductions for periods not to exceed five years for general loans, or up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Participant loans bore interest rates from 5.25% to 10.50% for the year ended December 31, 2024 and 5.25% to 10.25% for the year ended December 31, 2023.

Vesting

Participants are immediately vested in any Company safe harbor matching contributions, their elective contributions, rollover contributions, and any income or loss thereon. Vesting in Company discretionary matching contributions and profit-sharing contributions is based on years of continuous service as follows:

A participant shall become immediately vested in all accounts upon retirement, death, or total and permanent disability.

Forfeitures

Forfeitures of non-vested Company contributions are used to pay administrative expenses and any remaining forfeitures are used to reduce the Company's matching contributions. During both the years ended December 31, 2024 and 2023, no forfeited non-vested amounts were used to pay administrative expenses or reduce Company contributions. As of December 31, 2024 and 2023, forfeitures available to pay future Plan expenses or reduce future Company contributions totaled \$7,447 and \$7,204, respectively.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or their designated beneficiary in the event of death) may receive a single lump-sum amount equal to the value of the participant's vested interest in their account. The Plan allows for hardship and in-service withdrawals from a participant's vested account balance subject to certain limitations as defined in the Plan document.

Administrative Expenses

Fees and expenses incurred in the administration of the Plan, to the extent not paid by the Company, are charged to and paid from the Plan's assets. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of investments.

Expense Offset Arrangements

Fees incurred by the Plan for the investment management and recordkeeping services are included in the net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Therefore, actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for various investment securities. These investment securities are exposed to market risks, which generally mean the risk of loss in the value of certain investment securities due to changes in interest rates, security and commodity prices and general market conditions. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The Plan's investments in pooled separate accounts are valued at the net asset value ("NAV") of units held by the Plan at year-end as a practical expedient. The NAV of these accounts is based on the market value of its underlying investments divided by the number of units outstanding, as determined by the Custodian.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan generally uses the market approach. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodology used by the Plan for investments measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based on the NAV of the underlying assets and the number of units owned by the Plan at the reporting date. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date

In accordance with ASC 820-10, investments measured at fair value using NAV per share (or its equivalent) as a practical expedient are not classified in the fair value hierarchy. At both December 31, 2024 and 2023, all of the Plan’s investments that are measured at fair value are in pooled separate accounts and measured at fair value using NAV as a practical expedient. Accordingly, no fair value hierarchy is presented.

^(a) The strategy of these funds is to seek growth of capital primarily through investments in common stocks that appear to offer superior opportunities for growth of capital. These funds may invest a portion of their assets in securities of issuers domiciled outside the United States.

^(b) The strategy of these funds is to seek conservation of capital, current income and long-term growth of capital and income. These funds use a balanced approach to invest in a broad range of securities, including common stocks, investment-grade bonds, and securities issued and guaranteed by the U.S. government and by U.S. federal agencies.

^(d) The strategy of these funds is to seek an acceptable level of current income and a growing stream of income over future years. Growth of capital is the secondary objective.

4. Guaranteed Investment Contract

The Plan offers as an investment option a benefit-responsive guaranteed investment contract. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. Guaranteed Investment Contract, continued

The guaranteed investment contract has a guaranteed annual interest rate of no less than 3.00%. The guaranteed interest rate is redetermined at the discretion of the issuer. However, under no circumstances will the redetermined rate be less than 3.00%. The guaranteed interest rate for both the years ended December 31, 2024 and 2023 was 3.00%.

5. Information Certified by the Custodian (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest from notes receivable from participants for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the administrative agent on behalf of the Custodian of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. Party-In-Interest Transactions

The Plan's investments are in pooled separate accounts and in a guaranteed investment contract managed by the Custodian of the Plan. The Plan also issues notes receivable from participants. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their accounts.

8. Income Tax Status

Effective January 1, 2022, the Plan adopted by the Company is a VS plan that is designed to comply with provisions of the IRC's Economic Growth and Tax Reconciliation Act of 2001 ("EGTRRA"). Such VS plans are pre-approved by the Internal Revenue Service ("IRS") by reference to the Cumulative List of Changes in Plan Qualification Requirements (the "Cumulative List") provided under EGTRRA. Accordingly, the Plan was eligible for a six-year remedial amendment cycle. Because the Plan is a VS plan, the Company is not authorized to amend the Plan except to comply with changes in the Cumulative List. The Plan received a favorable advisory letter from the IRS dated June 30, 2020. Management of the Company and the Plan administrator believe the Plan complies with and is being operated in accordance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, currently no audits for any tax periods are in progress.

9. Delinquent Participant Contribution Transactions

During the years ended December 31, 2023 and 2022, the Company determined that certain employee deferrals aggregating \$20,611 and \$52,073, respectively, had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures were taken. The lost earnings for both the 2023 and 2022 contributions, estimated at less than \$100, were processed and deposited to participant accounts during 2024.

10. Subsequent Events

Plan management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued and has concluded that there are no significant events to be reported.
