## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### **NOTE A - DESCRIPTION OF PLAN**

The following description of HCR 401(k) Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established by Homefix Custom Remodeling Corporation and Homefix Custom Remodeling Installation Services Corporation (the “Company”) effective June 1, 2001. The Plan covers substantially all employees of the Company over the age of 21. All employees except for installation technicians and marketing employees are immediately eligible to make elective deferral contributions to their accounts. Installation technicians and marketing employees are eligible to make elective deferral contributions to their accounts after 60 days of service. All employees must obtain one year of service to be eligible for safe harbor and matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was most recently amended and restated effective January 1, 2022, to comply with applicable tax law changes and to include Pure Financial Group (“Pure”) employees. The Plan is a qualified plan under the Internal Revenue Code (“IRC”) §401(a) and 401(k) and is, therefore, exempt from federal income taxes under the provisions of IRC §501(a).

#### **Contributions**

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, subject to limitations under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, the Plan allows elective contributions to be made as Roth contributions. In addition, the Plan allows for catch-up contributions for participants age 50 or older as permitted by the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Trustees have elected safe harbor provisions, which equal 100 percent of the matched employee contributions up to the first 3 percent of gross compensation and 50 percent of the next 2 percent of gross compensation. Safe harbor contributions were \$223,454 for the year ended December 31, 2024.

The Company may make a discretionary matching contribution. The discretionary percentage is determined by the Company each year. There were no discretionary matching contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant’s account is participant directed and is credited with the participant’s contributions, the employer matching contribution, if applicable, and allocations of Plan earnings and expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are vested immediately in their employee deferral and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company’s non-elective and matching contribution portion of their accounts is based on the following vesting schedule. If, however, a participant dies, or is permanently disabled, he or she will immediately become 100 percent vested in all employer contributions.

### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Loan repayments are made through regular payroll deductions. The notes receivable balance was \$39,924 and \$66,916 at December 31, 2024 and 2023, respectively.

#### **Payment of Benefits**

Upon disability, retirement, death, or termination of employment, participants are entitled to the benefits in their separate accounts. In addition, in-service withdrawals are permitted when a participant attains age 59½. Benefits are paid as lump sum distributions. Hardship distributions are permitted if certain conditions are met.

#### **Forfeited Accounts**

Forfeitures accumulate due to account distributions or as a result of a reversal of employer contributions based upon year-end true-up calculations. Forfeitures may be utilized to pay administrative expenses of the Plan or to reduce employer contributions. Forfeiture balances as of December 31, 2024 and 2023, are \$9,299 and \$8,392 respectively. Forfeitures utilized to reduce administrative expenses were \$783 for the year ended December 31, 2024.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Date of Management's Review**

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

#### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

#### **Investment Valuation and Income Recognition**

Investments held by the Plan, except fully benefit-responsive investments, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of net assets available for benefits attributable to a fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note C for discussion of fair value measurements.

Purchases and sales are recorded on a settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the settlement date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

#### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments, and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### **Benefits**

Benefits are recorded when paid.

#### **Expenses**

Operating expenses of the Plan are paid partially by the Company with the remainder paid by the Plan. Expenses covered by the Company are excluded from these financial statements.

### **NOTE C - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

#### **Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### **NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has an investment in the Key Guaranteed Portfolio Fund, which is a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

### **NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

Because the guaranteed investment contract meets the criteria to be considered fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contribution value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$37,160 and \$32,712 at December 31, 2024 and 2023, respectively. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed semiannually for resetting. The contract cannot be terminated by the issuer before the scheduled maturity date.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

### **NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

As discussed in Note B, the Plan paid certain fees related to Plan operations to various service providers. Participant loans are also party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

### **NOTE G - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan's tax years of December 31, 2021 through December 31, 2024, remain subject to examination. There are currently no examinations for any tax periods in progress.

### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
