## Independent Auditors' Report

To the Trustee of the  
Beyond Health Management Solutions 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Beyond Health Management Solutions 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 11 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 – Description of the Plan**

The following description of the Beyond Health Management Solutions 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Beyond Health Management Solutions, LLC (Plan “Sponsor”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan, established on November 17, 2011, effective January 1, 2011, covering substantially all employees of the Plan Sponsor. Employees are eligible to participate on the first day of the Plan month coinciding with or following the completion of 30 days of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) as well as all applicable provisions of the federal income tax laws.

The Trustee and Plan Administrator are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

*Contributions* - Each year, participants may make tax-deferred contributions to the Plan not to exceed the amount deductible for federal income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor has the option to make discretionary matching and profit-sharing contributions of an amount determined by management. During the year ended December 31, 2024, the Plan Sponsor made discretionary matching contributions up to 2% of the participant’s compensation totaling \$49,207. Contributions are subject to Internal Revenue Service (IRS) limitations.

*Participant Accounts* - Each participant’s account is credited with the participant’s tax-deferred contributions and employer contributions (if any), as well as allocations of the Plan Sponsor’s profit-sharing contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their deferred salary contributions, rollover contributions from other plans, and actual earnings thereon. Vesting in the Plan Sponsor’s matching contributions and profit-sharing contributions (if any) of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested upon retirement, permanent disability, death or reaching age 65 while employed by the Plan Sponsor.

If a participant separates from the employment of the Plan Sponsor for any other reason, a participant shall be vested based upon the following schedule:

**Note 1 – Description of the Plan (continued)**

Notes Receivable from Participants - Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Only one loan may be outstanding at any one time. The loans, in the form of promissory notes (Note 2), are secured by the balances in the participants' accounts, and bear interest at the prime rate of interest plus 2%. Principal and interest on notes receivable from participants are repaid through payroll deductions.

Payment of Benefits - Distributions from the Plan will be made in one lump-sum payment in cash equal to the value of the participant's vested interest in his or her account balance, in partial distributions, or in installments. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If the participant's vested interest does not exceed \$5,000, then the participant's benefit will be distributed in a lump-sum as soon as practicable following the event that led to the participant being entitled to a distribution. With respect to mandatory distributions of \$1,000 or less, if a participant makes no election, then the amount will be automatically rolled over to an individual retirement account provided the amount is at least \$1.

Forfeited Accounts - At December 31, 2024 and 2023, unallocated forfeitures available contributions totaled \$94,502 and \$75,781, respectively. Forfeitures are used to reduce the employer's matching contribution to the Plan or to pay administrative fees. During the years ended December 31, 2024, and 2023, no forfeitures were used.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting - The Plan's financial statements are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, except for the Plan's only fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on the Plan's investments bought and sold as well as those held during the year.

**Note 2 – Summary of Significant Accounting Policies (continued)**

Notes Receivable from Participants - Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. The Plan recognizes interest income from the notes receivable as earned.

Payment of Benefits - Benefits are recorded when paid.

Expenses - It is the philosophy of the Plan Sponsor to absorb and pay most Plan administration expenses such as audit fees and other administrative functions so as not to decrease Plan assets. Any fee or expense paid, directly or indirectly, by the Plan Sponsor is not considered a contribution to the Plan, provided the fee or the expense relates to the ordinary and necessary administration of the Plan. During the year ended December 31, 2024 the Plan incurred administrative fees of \$6,719. These charges are reflected in the accompanying statement of changes in net assets available for benefits.

Recent Accounting Pronouncements - During the year ended December 31, 2024 and through October 8, 2025, there were no new accounting pronouncements issued by the Financial Accounting Standards Board (FASB) that will need to be adopted by the Plan.

Subsequent Events - In preparing the financial statements, the Plan has reviewed, as determined necessary by the Plan's management, no events that have occurred after December 31, 2024, up until the issuance of the financial statements, which occurred on October 8, 2025.

**Note 3 – Fair Value Measurements**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

**Level 1** - Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Level 2** - Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and

**Level 3** - Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts (PSA)*: consist of mutual funds which are valued daily at their net asset values (NAV) provided by the administrator of the fund. The Plan and participants hold "units of participation" in the separate account. The NAV is used as a practical expedient to estimate fair value of the PSA. The NAV is based on the value of the underlying assets owned by the fund, which include a mix of U.S. and international equities, fixed income investments, and cash. There are no restrictions on redemptions and no unfunded commitments.

**Note 4 – Fully Benefit-Responsive Investment Contract**

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America totaling \$118,774 and \$90,836 at December 31, 2024 and 2023, respectively.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**Note 4 – Fully Benefit-Responsive Investment Contract (continued)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options

Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of a material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

**Note 5 – Related-Party Transactions and Party-In-Interest Transactions**

Nova 401(k) Associates was the Plan's third-party administrator and recordkeeper during the year ended December 31, 2024, and therefore any transactions with the Plan qualify as party-in-interest transactions.

Empower Retirement LLC (Empower), the Plan's custodian, provides certain administrative services to the Plan pursuant to a contract between the Plan Sponsor and Empower. Empower receives revenue from mutual fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their account balances.

**Note 7 – Federal Income Tax Status**

The Plan as originally drafted is a Non-Standardized Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement. The IRS has determined and informed the sponsor of the prototype plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). However, a separate determination letter from the IRS has not yet been requested by the Plan Sponsor to determine if the Plan was designed in accordance with applicable sections of the IRC. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 9 – Prohibited Transactions**

During the year ended December 31, 2022, employee withholdings in the amount of \$62,430 were late in being transferred to the Plan. The delays were unintentional. As of report date, the Plan Sponsor has remitted the lost earnings calculated using the Department of Labor guidelines for late deposits to the Plan.
