Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements referred to above of Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements referred to above may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of Visiting Nurse Association of Greater Philadelphia Employee Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time and part-time employees of the Visiting Nurse Association of Greater Philadelphia (VNA). Employees excluded from Plan participation are the following: nonresident aliens with no United States source income, leased employees, and independent contractors. Employees of VNA are eligible to participate in the salary reduction arrangement in the Plan immediately upon commencement of employment. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Effective May 1, 2022, Public Health Management Corporation (PHMC) acquired VNA.

Contributions

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 403(b) or Roth contributions to the Plan.

Participants are entitled to a catch-up contribution after completion of 15 years of service. This dollar limit on elective deferrals may be increased by the smallest of the following amounts: (a) \$3,000; (b) \$15,000, reduced by catch-up amounts previously contributed; or (c) \$5,000 multiplied by the participant's years of service, reduced by the total elective deferrals while they have been employed by the VNA. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

VNA makes a discretionary contribution equal to 3.5% of eligible compensation to the Plan for eligible participants. Employees are eligible for VNA's contributions first day of the month following completion of one year of service and upon reaching the age of 21. The discretionary contribution was \$207,857, net of forfeitures, for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, VNA contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contribution sources plus actual earnings. Vesting in the VNA's contribution is based on years of continuous service. Participants are 100% vested after three years of credited service.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, installment payments, or an annuity. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. Account balances less than \$1,000 will be distributed as a lump sum distribution. Rollover distributions are permitted, as defined in the Plan document. In addition, the Plan allows for hardship distributions if certain criteria are met. The Plan will make a mandatory distribution following severances from employment if the account balance is less than \$5,000.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future VNA contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$755 and \$1,223 for the years ended December 31, 2024 and 2023, respectively. There was \$18,733 of forfeitures used to reduce VNA contributions for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or VNA, as provided by the Plan document. Expenses paid directly by VNA are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

VOYA Retirement Insurance and Annuity Company and Ascensus LLC (as an authorized representative of Ascensus Trust Company and Newport Trust Company), the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money Market Fund – Valued and transacted at a stable \$1.00 net asset value (NAV) which approximates fair value of the underlying assets within the fund.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts – Valued using the NAV of unites, as determined by the qualified institution. NAV is a readily determinable fair value and is the basis for current transactions.

Fixed Account: Investments in the qualified institutions fixed income accounts are considered to be nonbenefit responsive and are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by VOYA.

NOTE 5 HISTORICAL PLAN INFORMATION

Prior to 2009, the Plan's third-party administrators tracked contributions, investment earnings, distributions and other activity on a "contract" basis. Each participant was setup as having a separate 'contract' and Plan level activity was not captured. This method of administration was utilized prior to January 1, 2009 as the regulations governing 403(b) plans did not require Plan level reporting. The Plan administrator believes a good faith effort was made to obtain all relevant information prior to January 1, 2009. However, as a result of the method of administration and lack of historical Plan level financial reporting, the Plan administrator is unable to obtain Plan level information prior to January 1, 2009.

NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

In 2011, the Plan entered into a group annuity contract with ING Life Insurance and Annuity Company (changed name to Voya Retirement Insurance and Annuity Company in 2014). As part of the contract, Voya maintains a portion of the contributions in a "guaranteed account." The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Voya. The guaranteed account is included in the financial statements at fair value, because it is not fully benefit responsive.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, VNA has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their VNA contributions. See Note 12 for discussion of partial plan termination.

NOTE 9 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by VOYA Retirement Insurance and Annuity Company, Ascensus Trust Company, the qualified institutions of the Plan and the Vanguard Group, Inc. the third-party administrator of the Plan. Therefore, the investment transactions with these parties qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments as they are paid through contract charges rather than a direct payment.

NOTE 11 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain Plan assets were invested in the VOYA Retirement Insurance and Annuity Company pooled separate accounts. The accounts held by the Plan comprise of pooled separate account and invest in shares of underlying mutual funds. VOYA has chosen not to complete and submit an Annual Report (Form 5500) reporting the pooled separate accounts as a "direct filing entity" with the Department of Labor. Therefore, the Plan's interest in these accounts will not be reported as an interest in a pooled separate account in the Plan's Annual Return/Reports (Form 5500) prepared and submitted for the subject audit year and instead shown as mutual funds on the tax return Form 5500. The financial statements for the Plan reflect its representative value in the pooled separate accounts.

NOTE 12 PARTIAL PLAN TERMINATION

On October 28, 2024, the Employer terminated over 50% of total of the employees, in aggregate the termination represented a partial termination of the Plan. As a result of this partial termination, all accumulated benefits of affected employees were fully vested as of October 28, 2024.
