## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the  
Vistra Thrift Plan

### ***Opinion***

We have audited the financial statements of Vistra Thrift Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## VISTRA THRIFT PLAN

### NOTES TO FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF THE PLAN

The following description is provided for general information purposes only. Reference should be made to the Vistra Thrift Plan (Plan) document for more complete information.

**General** — The Plan is a participant-directed defined contribution plan for employees of Vistra Corp, (Vistra) and its participating subsidiaries (collectively the Employers).

The Vistra Thrift Plan Committee manages the operation and administration of the Plan. Fidelity Investments is the trustee, custodian of the assets and record-keeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is intended to be a participant-directed “individual account plan” under ERISA Section 404(c). As such, the fiduciaries of the Plan are not liable for any losses that are the direct result of participant investment decisions. Although the Plan has an automatic enrollment feature for new employees, continued participation in the Plan by employees of the Employers is entirely voluntary.

The Plan had the following investment options at December 31, 2024 and 2023:

- AllianceBernstein Small Cap Growth Portfolio - Class I (domestic equity mutual fund);
- Harbor Small Cap Value - Institutional Class (domestic equity mutual fund);
- DFA US Target Value Fund I (domestic equity mutual fund)
- WB Small-Mid Cap Growth A (collective investment trust growth equities);
- T. Rowe Price Institutional Large Cap Growth Fund (collective investment trust growth equities);
- Boston Partners Large Cap Value Equity Fund Class D (collective investment trust value equities);
- T. Rowe Price Stable Value B (collective investment trust value equities)
- Fidelity 500 Index fund (domestic equity mutual fund);
- Vanguard Inflation-Protected Securities Fund - Institutional Class (fixed income mutual fund);

  - Spartan 500 Index Commingled Pool;
  - Spartan Global ex US Index Commingled Pool; and
  - Spartan Extended Market Index Commingled Pool;
- Fidelity Global ex U.S. Index Fund (formerly Spartan Global ex U.S. Index Fund) - (international equity fund), and
  - Fidelity BrokerageLink (a brokerage account with the Plan that offers the opportunity to choose investments from a range of Fidelity Investment and non-Fidelity Investment mutual funds).

A Roth 401(k) contribution feature provides for participants to make after-tax contributions to the Plan and to ultimately receive a distribution of the earnings attributable to these contributions that are tax free if certain conditions are met.

***Eligibility, Participation and Employee Savings*** — All employees of a participating Employer are eligible to participate in the Plan upon employment except: (1) nonresident alien employees who receive no earned United States of America (US) sourced income, (2) leased employees, or (3) any individuals who are treated by or characterized in the internal records of an Employer as independent contractors, loaned employees, staff augmentation personnel, scope of work contractors, or seconded employees, regardless of any determination by the US Internal Revenue Service (IRS), other governmental agency, or a court or other tribunal, that any such individual is, or was, a common law employee of an Employer for any period of time, or (4) individuals who are treated or characterized by an Employer as temporary employees or who perform services for an Employer under a special contractual arrangement pursuant to which such individual will not attain a year of service. Door-to-door sales representatives of TXU Energy Retail Company LLC and its subsidiaries are eligible to participate in the Plan after 90 days of employment.

The Plan has an automatic enrollment feature whereby new employees are automatically enrolled in the Plan with a pretax contribution rate of 3% of eligible compensation unless the new employee affirmatively makes an election not to participate or to participate at a different contribution rate. If no change is made by the participant, the contribution rate will automatically increase by 1% each year up to a maximum of 10% at the end of seven years. Such contributions initiated through this automatic enrollment feature are automatically invested in the age appropriate Fidelity Freedom Index Commingled Pool for the participant unless they choose a different investment.

Under the Plan, except as limited by law, a participating employee may invest a specified percentage of eligible compensation each payroll period, either through pretax salary deferral or after-tax payroll deduction. The total of a participant's pretax and after-tax salary deferral/payroll deductions is known as Employee Savings. The maximum amount of Employee Savings for participants earning less than the IRS threshold for determining “highly compensated employees” is 75% of eligible compensation, and for participants earning more than the IRS threshold for determining “highly compensated employees” is 20% of eligible compensation.

Federal law limits the amount a participant may invest on a pretax basis \$23,000 in 2024. However, a participant who is eligible to make pretax salary deferrals and attained age 50 before the close of the Plan year, may make an additional pretax catch-up contribution each year. This catch-up limit was \$7,500 in 2024 for participants who reached age 50 during the respective Plan year. The Plan year begins January 1 and ends December 31.

Subject to certain conditions, a participant may transfer or rollover to the Plan cash amounts distributed or distributable from an individual retirement account (IRA) or a qualified retirement plan. Only taxable contributions held in an IRA may be

transferred or rolled over from an IRA, while taxable and nontaxable contributions may be transferred or rolled over from a qualified retirement plan.

**Employer Matching Contributions** - All eligible Plan participants are eligible to receive Employer matching contributions of 100% up to the first 6% of eligible compensation, except for Luminant bargaining unit employees of Vistra and its subsidiaries participating in the Traditional Retirement Plan Formula in Vistra Retirement Plan, who receive a 75% Employer matching contribution on the first 6% of eligible compensation contributed.

**Investment of Funds** — All Employer matching contributions are made in cash and invested according to the participant's investment election. Each participant may invest his/her Employee Savings, in 1% increments, among the various available investment options.

All assets of the Plan are held by the trustee for the exclusive benefit of participants and their beneficiaries. Separate account records for each participant are maintained by the record-keeper. The record-keeper provides a summary of financial performance by investment fund directly to Plan participants.

A participant may diversify investments of Employee Savings among the available investment funds under the Plan at any time by liquidating the investments attributable to such Employee Savings and reinvesting such amounts in other investment options as may be available under the Plan.

Participants may also effectively diversify their Employer matching contributions amount at any time by making a total withdrawal of such accounts subject to certain regulatory and vesting conditions. See below for information regarding withdrawal from the Plan. Additionally, a participant may diversify investments of Employer matching contributions at any time by liquidating the investments attributable to such matching contributions and reinvesting such amounts in other investment options available under the Plan.

**Unit Values** — Participants do not have beneficial ownership in specific securities or other assets in the Interest Income funds, but have an interest therein represented by units valued as of the close of each business day. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit value, and the appropriate account is charged or credited with the number of units properly attributable to the participant.

**Withdrawals from the Plan** — Withdrawals from the Plan are governed by applicable IRS regulations and provisions of ERISA. Penalties may apply in certain instances.

Participants are fully vested in all amounts in their accounts (i.e., pretax contributions, after-tax contributions, Employer matching contributions, rollover contributions, Roth contributions and all earnings and dividends thereon).

A participant who terminates employment may retain the funds in the Plan or withdraw them at any time; however, the participant must begin withdrawals no later than April 1st following the later of: (1) the calendar year in which the participant attains age 72 or (2) the calendar year in which the participant retires. To avoid immediate taxation, a withdrawal made upon termination may be rolled into an IRA or a qualified retirement plan sponsored by another employer, provided that the other qualified retirement plan accepts rollovers. Terminated participants who leave their account in the Plan are charged a monthly administrative maintenance fee.

Participants may make partial or total withdrawals from their rollover and after-tax Employee Savings accounts at any time and for any reason. Participants may make withdrawals from their Employer Match Contributions once the matching contributions have been made. Participants may make withdrawals from pretax Employee Savings accounts upon termination of employment or attainment of age 59 ½. Additionally, participants who meet certain qualifications defined by the IRS may make hardship withdrawals from their pretax Employee Savings account. As of January 2019, new regulations state that Participants who receive hardship withdrawals no longer have a waiting period before they may contribute to the Plan.

Participants making withdrawals can choose from the following optional forms of payment: (a) publicly traded fund units (to the extent permitted by the fund) credited to a participant's account; (b) single lump sum cash payment; or (c) a combination of (a) and (b).

**Notes Receivable from Participants** — The Plan includes a loan feature allowing participants to borrow up to 50% of their pretax Employee Savings, after-tax Employee Savings, Employer matching contributions and rollover contributions and repay the loan with after-tax payroll deductions. A participant may not have more than two outstanding loans at one time. The minimum amount of a Plan loan is \$1,000 and the maximum is \$50,000 less the highest outstanding loan balance in the preceding 12 months. Participants may repay the loan into their account(s) over a period of one to five years for a general purpose loan, and the shorter of 15 years or their remaining mortgage term for a primary home loan. The rate of interest charged for a loan initiated in any given month is the prime lending rate published in the Wall Street Journal on the last business day of the prior month, plus 2.0%. During 2024 the interest rate charged on new loans was 10.50% for January through September, 10.00% for October through November, and 9.75% for December.

**Federal Income Taxes** — The IRS has determined that the Plan meets the requirements of Section 401(a) of the Internal Revenue Code of 1986, as amended (the Code) as to form; that the Trust is exempt from federal income taxes under Section 501(a) of the Code; and that Employer contributions paid to the Trust under the Plan are allowable federal income tax deductions to the Employers subject to the conditions and limitations of Section 404 of the Code. The Plan received its last favorable determination letter from the IRS on September 30, 2016. Certain non-material amendments have been made to the Plan that are not covered by the new determination letter. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

The Plan is subject to examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress. The Plan has recorded no uncertain tax positions.

**Amendment, Modification, Suspension and Termination** — It is the intention of the Plan Sponsor to continue the Plan indefinitely; however, the Plan Sponsor, by action of its Board of Directors, may amend, modify or suspend the Plan at any time, or from time to time, and may terminate the Plan at any time; and any Employer may withdraw from participation in the Plan at any time upon prior notice.

In the event of termination of the Plan, in whole or in part, or termination of participation of any Employer, each participant in the Plan affected by such termination shall receive a distribution of the entire balance in the participant's account, whether derived from Employee Savings, rollovers or Employer matching contributions.

**Party-in-Interest** — Certain plan investments are managed by Fidelity Institutional Asset Management, Fidelity Management Research Company and Fidelity Brokerage Services LLC, all of which are subsidiaries of the plan trustee. These transactions qualify as party-in-interest transactions allowable under ERISA regulations.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States (GAAP). Benefit payments are recorded when paid. Subsequent events have been evaluated through October 13, 2025 the date these financial statements were available to be issued. On January 1, 2025, the Energy Harbor 401(K) and Retirement Contribution Plan was merged into the Vistra Thrift Plan. Employees covered under the collective bargaining agreement between Energy Harbor and various unions will remain at the 50% up to 6% match until negotiated otherwise. The members of these unions will also receive an annual non-elective contribution at the rate under their applicable collective bargaining agreements.

**Use of Estimates** — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and Uncertainties** — The Plan utilizes various investment instruments. Investment instruments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term, and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Valuation of Investment Securities** — The Plan's investments (other than benefit-responsive investment contracts) are stated at fair value. See Note 3 for additional disclosures on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date.

Benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan corresponding to fully benefit-responsive investment contracts because it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statements of Net Assets Available for Benefits present the Interest Income Fund at contract value of the investment contracts.

**Notes Receivable from Participants** — Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Expenses** — Plan administration fees (e.g., recordkeeping, accounting, legal and trustee services) are paid by the Employers and recorded as incurred. Investment fees are charged individually by each fund manager for asset management and administration of that fund. Investment fees are typically charged indirectly against individuals' accounts by being deducted from the investment return on each individual investment option. Individual service fees (e.g., short-term redemption fees, loan initiation fees, in-service withdrawal fees) are charged separately to the accounts of individuals who choose to utilize a particular plan feature, generally on a pro-rata basis against all investments and sources. Additionally, terminated participants pay a monthly account maintenance fee, which is recorded as a reduction of administrative fees reported in the statement of changes in net assets available for benefits, if they leave their account in the Plan.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability, in an orderly transaction between willing market participants at the measurement date. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The income approach uses valuation techniques to convert future amounts to a single present value amount. The cost approach is based on the amount that currently would be required to replace the service capacity of an asset. The Plan primarily uses the market approach of using prices and other market information for identical and/or comparable assets for those investments that are measured on a recurring basis and uses valuation techniques to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan categorizes its investments recorded at fair value based upon the following fair value hierarchy:

- Level 1 valuations use quoted prices in active markets for identical assets that are accessible at the measurement date. An active market is a market in which transactions for the asset occur with sufficient frequency and volume to provide pricing information on an ongoing basis. For example, the Plan's Level 1 investments include equity and fixed income mutual funds that are valued using published market prices, such as those from the New York Stock Exchange.
- Level 2 valuations use inputs other than actively quoted market prices included in Level 1, which are observable for the asset, either directly or indirectly. Level 2 inputs include: (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in markets that are not active, (c) inputs other than quoted prices that are observable for the asset such as interest rates and yield curves observable at commonly quoted intervals and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other mathematical means. None of the Plan's assets are classified as Level 2 assets.
- Level 3 valuations use unobservable inputs for the asset. Unobservable inputs are used to the extent observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset at the measurement date. None of the Plan's assets are classified as Level 3 assets.

With respect to amounts presented in the following fair value hierarchy table, the fair value measurement of an asset (e.g. an investment) is required to fall in its entirety in one level, based on the lowest level input that is significant to the fair value measurement. Assessing the significance of a particular input to the fair value measurement in its entirety requires judgment, considering factors specific to the asset being measured.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the Plan, such assets include investments in common collective trust funds.

The interest income fund generally consists of investment contracts as described below:

**Guaranteed Investment Contracts** — Insurance company separate account GICs are investments in a segregated account of assets maintained by an insurance company for the benefit of the investors. The total return of the segregated account assets supports the insurance company separate account GICs return. The credited rate on this product will reset periodically and it will have an interest rate of not less than 0%.

**Synthetic Guaranteed Investment Contracts** — General fixed maturity synthetic GICs consist of an asset or collection of assets that are owned by the fund (or plan) and a benefit-responsive (as discussed in Note 2) book value wrap contract. The wrap contract assures that book value, benefit-responsive payments will be made for participant-directed withdrawals. The interest rate of the contract is set at the start of the contract and typically resets every quarter. Generally, fixed maturity synthetic GICs are held to maturity. The initial interest rate is established based on the market interest rates at the time the initial asset is purchased, and it will have an interest rate not less than 0%.

Constant duration synthetic GICs consist of a portfolio of securities owned by the fund (or plan) and a benefit-responsive, book value wrap contract purchased for the portfolio. The wrap contract amortizes gains and losses of the underlying securities over the portfolio duration, and assures that book value, benefit-responsive payments will be made for participant-directed withdrawals. The crediting rate on a constant duration synthetic GIC resets every quarter based on the book value of the contract and the market yield, the market value and the average duration of the underlying assets. The crediting rate aims at converging the book value of the contract and the market value of the underlying portfolio over the duration of the contract and therefore will be affected by movements in interest rates and/or changes in the market value of the underlying portfolio. The initial crediting rate is based on the market interest rates at the time the underlying portfolio is initially established, and it will have an interest crediting rate of not less than 0%.

It is probable that withdrawals and transfers resulting from the events listed below, although no such events are considered probable, will limit the ability of the fund to transact at book or contract value. Instead, market value would likely be used in determining the payouts to the participants.

- Employer-initiated events — events within the control of the Plan or the plan sponsor that would have a material and adverse impact on the fund;
- Employer communications designed to induce participants to transfer from the fund;
- Competing fund transfer or violation of equity wash or equivalent rules in place;
- Changes of qualification status of Employer or plan.

In general, issuers may terminate the contract and settle at other than contract value if the qualification status of the Employer or plan changes, if there is a breach of material obligations under the contract and misrepresentation by the contract holder, or failure of the underlying portfolio to conform to the pre-established investment guidelines.
