### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Mitek Employees' Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

**Note 1 DESCRIPTION OF PLAN**

The following description of the Mitek Employees' Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees who have completed one month of service and are age twenty-one or older. The Plan also covers part-time, temporary, student, intern, and seasonal employees who have completed one year of service and are age twenty-one or older. Plan sponsors include Mitek Corporation; Atlas Sound, L.P.; Magnum Marketing Corporation; Thunder Valley Ranches, LLC; Innovative Electronic Designs, LLC; IED Support Services, LLC; Thunder Valley Corporation; and Advanced Audio Acoustics, Inc. (the "Company" or "Plan Sponsors"), all of which are under common control. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Administration**

The Plan is administered by the Mitek Employees' Retirement Savings Plan Advisory Committee. The record keeping of the plan is performed by One America Retirement Services. Matrix Trust Company ("Matrix" or the "Trustee") is responsible for the custody and management of the Plan's assets.

**Contributions**

*Participant Contributions*

Eligible employees may contribute up to 70% of pre-tax annual compensation, as defined in the Plan. Contributions must be made through payroll deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make tax-deferred catch-up contributions.

*Matching Contributions*

Matching contributions, if any, are allocated in proportion to the amount of pay each participant defers, up to one-half of the first 6% of base compensation. Discretionary contributions are allocated among participants in the ratio that compensation of each participant bears to the total compensation of all participants into the same investments and at the current investment percentages as selected by each participant. The Plan Sponsors have no obligation to make matching or company discretionary contributions in any year. For the years ended 2024 and 2023, the Plan Sponsors made a matching contribution to the Plan.

*Automatic Enrollment*

Employees are automatically enrolled in the Plan at a 3% tax-deferred contribution rate when they become eligible for participation. These contributions are invested in the Plan's default investment option if no other election is made. The contribution rate is set to automatically increase 1% each plan year until the deferral rate has reached 6%. Employees may opt out of the automatic enrollment, stop contributions, and modify their contribution rate or investment selections at any time.

**Note 1 DESCRIPTION OF PLAN (continued)**

**Participant Accounts**

Each participant's account is funded with the participant's contributions and allocations of the Company's contributions, if any, and Plan earnings or losses. Allocations are based on participant account balances, as defined by the Plan. Participants are entitled to the vested portion of their account.

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Participants are vested in the Plan Sponsors' matching and optional contributions, plus actual earnings thereon, based on years of service. Participants are vested in Plan Sponsor contributions over a five-year vesting schedule which vests at a rate of 20% per year.

**Participant Loans**

Effective July 1, 2022, participants may borrow from their accounts a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of their vested account balance. These loans may be used for a maximum of five years. Loans made for a purchase of a primary residence have a term consistent with commercial loan practices. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime rate plus 1%, fixed at the time of the loan, as defined, as established by the plan administrator. Principal and interest are repaid through payroll deductions.

**Investment Options**

Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct contributions in any of the then available investment fund options. Participants may change or transfer their investment options at any time via telephone or a secure internet website.

**Payment of Benefits**

Vested account balances are payable upon retirement, death or disability, or termination of employment. In-service distributions are also permitted after meeting certain requirements in accordance with Plan provisions. Distributions may be made in a lump sum payment, a series of installment payments, or partial payments. The Plan makes a single lump-sum payment if a vested account balance does not exceed \$5,000.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Plan Sponsor contributions. Forfeited amounts at December 31, 2024 and 2023 totaled \$34,684 and \$19,412, respectively. For the years ended December 31, 2024 and 2023, Plan expenses were reduced by \$33,661 and \$15,809 from forfeited non-vested accounts, respectively.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The Plan's financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Certain prior year amounts in the financial statements and notes thereto have been reclassified to conform to the current year's presentation.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Management Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (see Note 3). Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold, and held at year-end.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Benefit Payments and Distributions**

Benefits and distributions are recorded when paid. For 2023, in order to remain in compliance with Internal Revenue Code ("IRC"), the Plan was required to refund approximately \$23,000 for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS"). The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no such excess amounts for 2024.

**Operating Expenses**

Expenses of maintaining the Plan generally are paid by the Plan Sponsors. Expenses relating to the purchase or sale of investments are included in the cost or deducted from the proceeds. Certain participant services and recordkeeping fees are charged to the participant's account.

**Note 3 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Section 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;

**Note 3 FAIR VALUE MEASUREMENT (continued)**

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques must maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Principal Collective Trust Fund:* A stable principal fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable asset collective trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 4 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As described in Note 2, administrative expenses of running the Plan generally are paid by the Plan Sponsors. Certain administrative functions are performed by officers or employees of the Plan Sponsors. No such officer or employee receives compensation from the Plan. Fees paid for loan administration totaled \$6,470 and \$1,800 for the years ended December 31, 2024 and 2023, respectively. Fees are paid by the participant who obtains the loan. Participant loans also qualify as party-in-interest transactions.

**Note 5 PLAN TERMINATION**

Although they have not expressed any intention to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contribution accounts.

**Note 6 TAX STATUS**

The Internal Revenue Service has determined and informed Mitek Corporation by a letter dated June 17, 2009, that the Plan and related trust, as then designed, were in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions for open periods, generally three years from the filing date; however, there are currently no audits for any tax periods in progress. If penalties or interest would be incurred, it would be reported as income tax expense.

**Note 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
