Note 1 - Plan Description

The following description of the Compass Health Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Compass Health and Child Advocacy Center of Snohomish County at Dawson Place (collectively referred to as the Sponsor) to provide retirement benefits to employees. The Plan is intended to be a plan that meets requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, excluding nonresident aliens, may elect to make salary deferrals upon hire. Reclassified employees are excluded from receiving employer contributions. Employees are eligible for employer contributions after completing one year of service and begin receiving contributions on the first day of the pay period that begins after the eligibility criteria are fulfilled. The Plan defines a year of service as a twelve month eligibility service period in which participants worked at least 975 hours.

Contributions - Employees may contribute up to 100% of their eligible compensation as pre-tax or Roth contributions. The Plan allows participants to make catch-up contributions if they have attained age 50 before the end of the plan year. Participants may also rollover amounts representing distributions from other eligible retirement plans. The Plan has an automatic enrollment feature under which new employees working more than 20 hours a week are enrolled at a 2% deferral rate unless they elect a different participation level.

The Sponsor makes matching contribution equal to 100% of each participant's elective deferrals up to 2% of eligible compensation. The Sponsor also makes a nonelective contribution equal to 3% of each eligible participant's eligible compensation. Contributions are subject to certain regulatory limitations under the IRC.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loans are secured by the balance in participant's account. The interest rate is set at 1% above the prime rate, as defined. Loan terms range from one to five years, unless used for the purchase of a primary residence. Each loan is repaid through payroll deductions and the balance of the loan can be paid in full at any time.

Vesting - Participants are fully vested at all times in all contributions plus earnings thereon.

Benefit Payments - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive the value of their vested account as a lump-sum payment. Participants who have attained age 59 ½ may also elect to receive a distribution of their account prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Payments - Benefits are recorded when paid.

Investment Fees and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through July 10, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quotes prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard) through the Standard Stable Asset Fund. Standard maintains the contributions in their general account. Assets in the general account are supported by the financial stability of Standard. While Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, any guarantees are dependent on Standard’s ability to meet its financial obligations. The crediting rate is based on a formula established by Standard but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

Note 4 - Continued

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value, including termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of the Plan's withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Those events include the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain the minimum asset levels, plan disqualification, and failure to adopt the Plan in a reasonable time.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held at December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan invests in shares of mutual funds managed by Fidelity or its affiliates. Transactions with such investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions. The Plan entered into a group annuity contract with Standard through the Standard Stable Asset Fund. Transactions with this investment and fees paid from the Plan to Standard qualify as party-in-interest transactions.

Note 7 - Plan Termination

It is the intention of the Sponsor to continue the Plan indefinitely, but the Sponsor may, at its discretion, modify, amend, or terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status

Management adopted a Fidelity 403(b) volume submitter plan document. Fidelity received an approval letter from the IRS dated August 7, 2017, which states that the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan allows participants to invest in various investment fund options which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Compass Health Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Responsibilities of Management for the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Plan Description

The following description of the Compass Health Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Compass Health and Child Advocacy Center of Snohomish County at Dawson Place (collectively referred to as the Sponsor) to provide retirement benefits to employees. The Plan is intended to be a plan that meets requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, excluding nonresident aliens, may elect to make salary deferrals upon hire. Reclassified employees are excluded from receiving employer contributions. Employees are eligible for employer contributions after completing one year of service and begin receiving contributions on the first day of the pay period that begins after the eligibility criteria are fulfilled. The Plan defines a year of service as a twelve month eligibility service period in which participants worked at least 975 hours.

Contributions - Employees may contribute up to 100% of their eligible compensation as pre-tax or Roth contributions. The Plan allows participants to make catch-up contributions if they have attained age 50 before the end of the plan year. Participants may also rollover amounts representing distributions from other eligible retirement plans. The Plan has an automatic enrollment feature under which new employees working more than 20 hours a week are enrolled at a 2% deferral rate unless they elect a different participation level.

The Sponsor makes matching contribution equal to 100% of each participant's elective deferrals up to 2% of eligible compensation. The Sponsor also makes a nonelective contribution equal to 3% of each eligible participant's eligible compensation. Contributions are subject to certain regulatory limitations under the IRC.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loans are secured by the balance in participant's account. The interest rate is set at 1% above the prime rate, as defined. Loan terms range from one to five years, unless used for the purchase of a primary residence. Each loan is repaid through payroll deductions and the balance of the loan can be paid in full at any time.

Vesting - Participants are fully vested at all times in all contributions plus earnings thereon.

Benefit Payments - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive the value of their vested account as a lump-sum payment. Participants who have attained age 59 ½ may also elect to receive a distribution of their account prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Payments - Benefits are recorded when paid.

Investment Fees and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through July 10, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quotes prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard) through the Standard Stable Asset Fund. Standard maintains the contributions in their general account. Assets in the general account are supported by the financial stability of Standard. While Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, any guarantees are dependent on Standard’s ability to meet its financial obligations. The crediting rate is based on a formula established by Standard but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

Note 4 - Continued

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value, including termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of the Plan's withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Those events include the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain the minimum asset levels, plan disqualification, and failure to adopt the Plan in a reasonable time.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held at December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan invests in shares of mutual funds managed by Fidelity or its affiliates. Transactions with such investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions. The Plan entered into a group annuity contract with Standard through the Standard Stable Asset Fund. Transactions with this investment and fees paid from the Plan to Standard qualify as party-in-interest transactions.

Note 7 - Plan Termination

It is the intention of the Sponsor to continue the Plan indefinitely, but the Sponsor may, at its discretion, modify, amend, or terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status

Management adopted a Fidelity 403(b) volume submitter plan document. Fidelity received an approval letter from the IRS dated August 7, 2017, which states that the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan allows participants to invest in various investment fund options which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 1 - Plan Description

The following description of the Compass Health Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Compass Health and Child Advocacy Center of Snohomish County at Dawson Place (collectively referred to as the Sponsor) to provide retirement benefits to employees. The Plan is intended to be a plan that meets requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, excluding nonresident aliens, may elect to make salary deferrals upon hire. Reclassified employees are excluded from receiving employer contributions. Employees are eligible for employer contributions after completing one year of service and begin receiving contributions on the first day of the pay period that begins after the eligibility criteria are fulfilled. The Plan defines a year of service as a twelve month eligibility service period in which participants worked at least 975 hours.

Contributions - Employees may contribute up to 100% of their eligible compensation as pre-tax or Roth contributions. The Plan allows participants to make catch-up contributions if they have attained age 50 before the end of the plan year. Participants may also rollover amounts representing distributions from other eligible retirement plans. The Plan has an automatic enrollment feature under which new employees working more than 20 hours a week are enrolled at a 2% deferral rate unless they elect a different participation level.

The Sponsor makes matching contribution equal to 100% of each participant's elective deferrals up to 2% of eligible compensation. The Sponsor also makes a nonelective contribution equal to 3% of each eligible participant's eligible compensation. Contributions are subject to certain regulatory limitations under the IRC.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loans are secured by the balance in participant's account. The interest rate is set at 1% above the prime rate, as defined. Loan terms range from one to five years, unless used for the purchase of a primary residence. Each loan is repaid through payroll deductions and the balance of the loan can be paid in full at any time.

Vesting - Participants are fully vested at all times in all contributions plus earnings thereon.

Benefit Payments - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive the value of their vested account as a lump-sum payment. Participants who have attained age 59 ½ may also elect to receive a distribution of their account prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Payments - Benefits are recorded when paid.

Investment Fees and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through July 10, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quotes prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard) through the Standard Stable Asset Fund. Standard maintains the contributions in their general account. Assets in the general account are supported by the financial stability of Standard. While Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan, any guarantees are dependent on Standard’s ability to meet its financial obligations. The crediting rate is based on a formula established by Standard but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

Note 4 - Continued

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value, including termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of the Plan's withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or withdrawal restrictions may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Standard and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Those events include the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain the minimum asset levels, plan disqualification, and failure to adopt the Plan in a reasonable time.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held at December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan invests in shares of mutual funds managed by Fidelity or its affiliates. Transactions with such investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions. The Plan entered into a group annuity contract with Standard through the Standard Stable Asset Fund. Transactions with this investment and fees paid from the Plan to Standard qualify as party-in-interest transactions.

Note 7 - Plan Termination

It is the intention of the Sponsor to continue the Plan indefinitely, but the Sponsor may, at its discretion, modify, amend, or terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status

Management adopted a Fidelity 403(b) volume submitter plan document. Fidelity received an approval letter from the IRS dated August 7, 2017, which states that the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan allows participants to invest in various investment fund options which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
